Review of Foreign Trade May, 2016

EXPORTS

The total Exports of Pakistan during May, 2016 amounted to Rs. 191,221.32 million as against Rs. 179,622.05 million in April, 2016 and Rs. 198,389.79 million during May, 2015 showing an increase of 6.46% over April, 2016 but decreased by 3.61% over May, 2015.

Exports during July–May, 2016 totalled Rs. 1,994,670.08 million as against Rs. 2,213,443.79 million during the corresponding period of last year showing a decrease of 9.88%.

In terms of U.S dollars, the exports during May, 2016 amounted to \$1,826.75 million as against \$1,716.02 million in April, 2016 and \$1,948.34 million during May, 2015 showing an increase of 6.45% over April, 2016 but decreased by 6.24% over May, 2015.

In terms of U.S. dollars, the exports during July–May, 2016 totalled \$19,140.25 million as against \$21,858.66 million during the corresponding period of last year showing a decrease of 12.44%.

IMPORTS

The total Imports of Pakistan during May, 2016 amounted to Rs. 416,800.74 million as against Rs. 399,929.33 million in April, 2016 and Rs. 379,073.75 million during May, 2015 showing an increase of 4.22% over April, 2016 and by 9.95% over May, 2015.

Imports during July–May, 2016 amounted to Rs. 4,194,622.09 million as against Rs. 4,199,592.05 million during the corresponding period of last year showing a decrease of 0.12%.

In terms of US dollars, the imports during May, 2016 amounted to \$3,981.72 million as against \$3,820.72 million in April, 2016 and \$3,723.55 million during May, 2015 showing an increase of 4.21% over April, 2016 and by 6.93% over May, 2015.

In term of U.S. dollars, the imports during July–May, 2016 amounted \$40,247.11 million as against \$41,475.96 million during the corresponding period of last year showing a decrease of 2.92%.

Based on the above figures of exports & imports the balance of trade in May, 2016 was unfavorable for Pakistan to the tune of 225,579.42 million in rupees equal to US \$2,154.97 million. The balance of trade during July–May, 2016 was also unfavorable to the tune of 2,199,952.01 million rupees equal to U.S. \$21,106.86 million.

I - Exports by Group/Commodities

Exports from Pakistan during May, 2016 amounted to Rs. 191,221.32 million as against the exports of Rs. 179,622.05 million in previous month and Rs. 198,389.79 million during the corresponding month of last year showing an increase of 6.46% over previous month but decreased by 3.61% over the corresponding month of last year.

Exports during July–May, 2016 totaled Rs. 1,994,670.08 million as against Rs. 2,213,443.79 million during the corresponding period of last year showing a decrease of 9.88%.

Comparative figure of exports by group/commodities during May, 2016 compared to April, 2016 and May, 2015 are given in table-1 and cumulative exports for the period July–May, 2016 of current financial year compared to the corresponding period of last year are given in table-2.

Primary Commodities

During May, 2016 the 6 selected primary commodities contributed 13.62% of total exports in which the share of rice, fruits, vegetables & preparations thereof, fish & fish preparations, tobacco un-manufactured and raw cotton were 9.13%, 2.52%, 1.90%, 0.03% and 0.02% respectively.

During July–May, 2016 these 6 commodities contributed 14.28% of the total exports showing an increase of 2.25% as against their combined share of 13.97% during the corresponding period of last year.

Textile Manufactures

During May, 2016 the 9 selected commodities of Textile Manufactures contributed 56.37% of total exports in which the share of knitwear, articles of

apparel & clothing (excl. knitwear), cotton fabrics, bed-wear and cotton yarn were 11.91%, 10.64%, 10.20%, 10.07% and 5.21%, respectively.

During July–May, 2016 these 9 commodities contributed 57.03% of the total exports showing an increase of 5.80% as against their combined share of 53.91% during the corresponding period of last year.


Other Manufactures

During May, 2016 the 7 selected commodities of Other Manufactures contributed 8.97% of total exports in which the share of leather clothes & accessories, leather, surgical instruments, sport goods (excl. toys), footwear, carpets, carpeting, rugs and mats and petroleum products were 2.34%, 1.93%, 1.67%, 1.63%, 0.56%, 0.47%, and 0.37%, respectively.

During July-May, 2016 these 7 commodities contributed 8.79% of the total exports showing a decrease of 11.00% as against their combined share of 9.87% during the corresponding period of last year.

II – Analysis of Selected Commodities of Export

Cotton Fabrics

Cotton fabrics came down to third position on the exports list in its group for May, 2016 from first in the previous month. During this month its exports amounted to Rs. 19,507.50 millions as against Rs. 20,324.99 million in April, 2016 and Rs. 19,388.79 million during May, 2015 showing a decrease of 4.02% over April, 2016 but increased by 0.61% over May, 2015.

During July–May, 2016 of current financial year 2,020,705 thousand sq. meters of cotton fabrics valued at Rs. 215,271.70 million were exported as against 1,919,974 thousand sq. meters valued at Rs. 230,519.81 million during the same period of last year showing an increase of 5.25% in terms of quantity and in terms of value decreased by 6.61%. The average unit price of cotton fabrics decreased to Rs. 106.53 per sq. meter from Rs. 120.06 per sq. meter during the corresponding period of last year showing a decrease of 11.27%. Main buyers of cotton fabrics during July–May, 2016 of current financial year were Bangladesh (Rs. 48,398.89 million), China (Rs. 16,682.31 million), Italy (Rs. 14,511.90 million), Turkey (Rs. 9,810.62 million), Germany (Rs. 9,754.24 million), U. S. A. (Rs. 7,959.51 million), Sri Lanka (Rs. 7,596.25 million), Spain (Rs. 7,368.07 million), Portugal (Rs. 6,859.84 million) and Egypt (Rs. 6,308.49 million). Their total take-off accounted for 62.83% of total exports of cotton cloth as compared to their combined share of 60.03% during the same period of last year.

Variety-wise exports of cotton fabrics during July-May, 2016 of current financial year and the corresponding period of last year are given below.

Cotton Yarn

Cotton yarn maintained its fifth position on the exports list in its group for May, 2016 as in the previous month. Its exports in this month amounted to Rs. 9,956.31 million as against Rs. 9,718.50 million in April, 2016 and Rs. 14,014.22 million in May, 2015 showing an increase of 2.45% over April, 2016 but decreased by 28.96% over May, 2015.

During July–May, 2016 exports of cotton yarn amounted to Rs. 122,504.48 million as against Rs. 175,069.59 million in the corresponding period of last year depicting a fall of 30.03%. In terms of quantity 392,302 thousand kg of cotton yarn was exported during the July–May, 2016 of current financial year as against 602,352 thousand kg exported during the corresponding period of last year showing a decrease of 34.87%. The average unit price of cotton yarn for period July–May, 2016 of current financial year was Rs. 312.27 per kg as against Rs. 290.64 per kg in the same period of last year showing an increase of 7.44%.

China (Rs. 80,963.42 million), Bangladesh (Rs. 9,839.82 million), Hong Kong (Rs. 5,257.69 million), Turkey (Rs. 3,998.60 million), Portugal (Rs. 3,470.46 million), Korea Republic of (Rs. 3,030.53 million), Japan (Rs. 2,716.70 million), Italy (Rs.1,587.00 million), U. S. A. (Rs. 1,586.14 million) and Viet Nam (Rs. 1,113.59 million) were major buyers of cotton yarn during this period. Their combined share accounted for 92.70% of total exports of cotton yarn as compared to their combined share of 92.24% during the same period of last year.

Variety-wise exports of cotton yarn in terms of quantity and value during July-May, 2016 of the current financial year and corresponding period of last year are given below:-

Rice

Rice maintained its first position on the exports list in its group during May, 2016. In this month it fetched Rs. 17,456.59 million as against Rs. 18,154.00 million in April, 2016 and Rs. 15,516.68 million in May, 2015 showing a decrease of 3.79% over April, 2016 but increased by 12.56% over May, 2015.

During July–May, 2016 its exports amounted to Rs. 179,178.31 million as against the exports of Rs. 192,722.08 million during the corresponding period of last year showing a decrease of 7.03%. China was the leading buyer of rice during July–May, 2016 with its share of 15.56% in the total exports of this item. Other major buyers were Kenya (10.26%), Afghanistan (6.39%), United Arab Emirates (6.24%), Saudi Arabia (4.45), Mozambique (4.25%) and Tanzania (3.59%).These seven countries accounted for 50.73% of total exports of rice during this period.

Unit price of rice basmati for May, 2016 was Rs. 94,487.08 per tonne as against Rs. 120,700.13 per tonne in May, 2015 showing a fall of 21.72%. Average unit price of this variety for July–May, 2016 of current financial year was Rs. 96,580.00 per tonne as against Rs. 117,269.39 per tonne for the same period of last year showing a fall of 17.64%.

Unit price of rice "Other Verities" decreased to Rs. 37,142.73 per tonne in May, 2016 from Rs. 43,076.34 in May, 2015 showing a fall of 13.77%. The average unit price of rice "Other Varities" for July–May, 2016 at Rs. 39,232.34 per tonne was lower by 10.35% compared to average unit price of Rs. 43,761.30 per tonne for the same period of last year.

Leather

Leather came up to second position on the exports list in its group for May, 2016 from fourth in the previous month. Its exports in this month amounted to Rs. 3,685.52 million as against Rs. 3,273.44 million in April, 2016 and Rs. 4,474.75 million in May, 2015 showing an increase of 12.59% over April, 2016 but decreased by 17.64% over May, 2015.

Exports of this item during July–May, 2016 totalled Rs. 34,822.12 million as against Rs. 45,802.51 million during the corresponding period of last year showing a fall of 23.97%. In terms of quantity 15,801,034 sq. meter of leather exported during July–May, 2016 as against 20,453,483 sq. meters exported during the corresponding period of last year showing a decrease of 22.75%.

The main buyers of leather during July–May, 2016 were Hong Kong (Rs. 6,240.19 million), Italy (Rs. 5,148.91 million), China (Rs. 3,818.61 million), India (Rs. 3,056.60 million), Korea Rep. of (Rs. 2,335.83 million), Viet Nam (Rs. 2,293.98 million), Spain (Rs. 1,322.09 million), Germany (Rs. 1,309.11 million), Bangladesh (Rs. 1,300.51 million), South Africa (Rs. 1,114.80 million) and Indonesia (Rs. 895.02 million) whose combined share in total exports of leather was 82.81% as against their compared share of 83.37% during the same period of last year.

Carpets, Carpeting Rugs & Mats

Carpets, carpeting rugs and mats maintained its sixth position on exports list in its group for May, 2016 as in the previous month. Its exports in May, 2016 amounted to Rs. 895.40 million as against Rs. 892.92 million in April, 2016 and Rs. 952.06 million in May, 2015 showing an increase of 0.28% over April, 2016 but decreased by 5.95% over May, 2015.

Exports of this item for the July–May, 2016 of current financial year amounted to Rs. 9,498.53 million as against Rs. 11,335.61 million during the corresponding period of last year showing a decrease of 16.21%.

In terms of quantity 1,656,985 sq. meters of carpets, carpeting rugs and mats were exported during July–May, 2016 of current financial year as against 2,286,385 sq. meters exported during the corresponding period of last year showing a decrease of 27.53%.

The average unit price of carpets of woolen hand knotted was Rs. 6,467.55 per sq. meter during July–May, 2016 as against Rs. 5,599.01 per sq. meter in the corresponding period of last year showing a rise of 15.51%. U.S.A. (Rs. 4,918.48 million), Germany (Rs. 767.89 million), France (423.75 million), Italy (Rs. 365.35 million), United Kingdom (Rs. 344.82 million), Japan (Rs. 342.75 million), Turkey (Rs. 304.13 million), Sweden (229.53 million) and Spain (Rs. 224.48 million), were the main buyers of carpets, carpeting rugs and mats during July–May, 2016. They together accounted for 83.39% during July–May, 2016 as compared to their share of 78.22% during the same period of last year.

Quantity and value of exports of carpets, carpeting rugs and mats during July–May, 2016 and corresponding period of last year are given below.

Petroleum products maintained its seventh position on the exports list in its group during May, 2016 as in the previous month. In this month its exports amounted to Rs. 700.29 million as against Rs. 239.28 million in April, 2016 and Rs. 53.08 million in May, 2015 showing an increase of 192.67% over April, 2016 and by 1219.31% over May, 2015.

Exports of this item for July–May, 2016 of current financial year stood at Rs. 5,098.35 million as against exports of Rs. 30,467.12 million during the corresponding period of last year showing a decrease of 83.27%.

In terms of quantity 89,741tons of petroleum products were exported during July–May, 2016 of current financial year as against 332,224 tones exported during the corresponding period of last year showing a decrease of 72.99%.

The main buyers of petroleum products during July–May, 2016 were Afghanistan (Rs. 4,936.07 million), United Arab Emirates (Rs. 83.36 million), India (Rs. 56.42 million), Malawi (Rs. 9.77 million) and Bangladesh (Rs. 6.18 million). These five countries accounted for 99.87% of total exports of petroleum products during July–May, 2016 as against 65.27 exports during the same period of last year.

Raw Cotton

Raw Cotton maintained its fifth position on the exports list in its group for May, 2016 as in the previous month. Its exports in this month amounted to Rs. 34.69 million as against Rs. 35.63 million in April, 2016 and Rs. 159.37 million in May, 2015 showing a decrease of 2.64% over April, 2016 and by 78.23% over May, 2015.

Exports of this item during July–May, 2016 amounted to Rs. 7,881.73 million as against Rs. 14,851.21 million showing a decrease of 46.93% compared to the same period of last year. In terms of quantity 48,961 tonnes of raw cotton was exported during July–May, 2016 as against 93,384 tonnes exported in the same period of last year showing a decrease of 47.57%.

The main buyers of raw cotton during July–May, 2016 were India (Rs. 2,112.80 million), Viet Nam (Rs. 1,968.39 million), Bangladesh (Rs. 1,559.87 million), Indonesia (Rs. 1,527.54 million), Thailand (Rs. 579.96 million) and Philippines (28.54 million). They together account for 98.67% of total exports of raw cotton during July–May, 2016 as against their combined share of 94.80% in the corresponding period of last year.

III - Direction of Exports

Exports by Territories/Regions and Major countries during May, 2016 compared with May, 2015 are given in table 3 & 4 and cumulative Exports by Territories/Regions and Major countries for the July–May, 2016 of the current financial year compared with the same period of last year are given in table 5 & 6 respectively.

During the month of May, 2016 (34.08%) of total exports went to European Union. The share of North America during May, 2016 was 17.17% as against 18.48% in May, 2015. The share of Middle East during May, 2016 was 11.10% as against 9.76% in May, 2015. Country-wise, U.S.A. was at the top of the exports list for May, 2016 followed by United Kingdom, China, Afghanistan, Germany and Spain. The share of these six countries in total exports of May, 2016 was 46.50% as against their share of 52.05% in May, 2015.

During July–May, 2016 the share of European Union in total exports was 31.86%. The share of North America increased to 17.69% from 16.44% during the same period of last year. The share of Middle East decreased to 10.81% from 11.55% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for July–May, 2016 followed by China, United Kingdom, Afghanistan, Germany and United Arab Emirates. The share of these six countries in total exports for July–May, 2016 of the current financial year was 48.71% as against 44.64% in the same period of last year.

IV - Exports by Economic Categories

Performance of export by economic categories during May, 2016 and July–May, 2016 of the current financial year compared to the same period of last year are shown in table-7.

During May, 2016 exports of primary commodities and manufactured goods increased by 2.13% and 2.96% respectively, while semi-manufactures decreased by 37.27% during the current month as compared to the same month of last year.

During July–May, 2016 exports of primary commodities were lower by 12.64%, of semi manufactures by 27.60% and manufactured goods by 5.35% compared to the same period of last year.

I – Import by Groups/Commodities

Imports into Pakistan during May, 2016 amounted to Rs. 416,800.74 million as against the imports of Rs. 399,929.33 million in the previous month and Rs. 379,073.75 million during the corresponding month of last year showing an increase of 4.22% over previous month and by 9.95% over the corresponding month of last year.

Imports during July–May, 2016 amounted to Rs. 4,194,622.09 million as against Rs. 4,199,592.05 million during the corresponding period of last year showing a decrease of 0.12%.

Comparative figures of imports by groups/commodities during May, 2016, April, 2016 and May, 2015 are given in Table-8 and cumulative imports for July-May, 2016 of current financial year and the previous year are given in Table-9.

Food Group

During May, 2016 the 5 selected commodities of Food Groups contributed 7.45% of total imports in which the share of palm oil, pulses and tea were 4.33%, 1.08% and 0.92% respectively.

During July–May, 2016 this group contributed 7.33% of total imports showing an increase of 19.10% as against their combined share of 6.16% during the corresponding period of last year.

Machinery & Transport Group

During May, 2016 Machinery & Transport Group contributed 24.91% of total imports in which the share of machinery and transport equipment were 17.72% and 7.19% respectively.

During July–May, 2016 this Group contributed 25.30% of the total imports showing an increase of 16.39% as against their combined share of 21.74% during the corresponding period of last year.

Petroleum Group

During May, 2016 Petroleum Groups contributed 18.18% of total imports in which the share of Petroleum Products and Petroleum Crude were 14.68% and 3.50% respectively.

During July–May, 2016 this group contributed 16.91% of total imports showing a decrease of 34.34% as against their combined share of 25.76% during the corresponding period of last year.

Textile Group

During May, 2016 Textile Groups contributed 2.44% of total imports in which the share of synthetic & artificial silk yarn and synthetic fibre were 1.34% and 1.09% respectively.

During July–May, 2016 this group contributed 2.54% of total imports showing a decrease of 3.91% as against their combined share of 2.65% during the corresponding period of last year.

Chemical Group

During May, 2016 the Chemical Groups contributed 15.98% of total imports in which the share of chemical (excl. fertilizer, medicines & insecticide) (13.16%), medicinal products (2.04%), fertilizer manufactured (0.43%) and insecticide (0.35%).

During July–May, 2016 Chemical group contributed 16.48% of the total imports showing a decrease of 0.54% as against their combined share of 16.57% during the corresponding period of last year.

Metal Group

During May, 2016 the Metal Groups contributed 6.72% of total imports in which the share of iron & steel and iron & steel scrap were 3.86% and 2.87% respectively.

During July–May, 2016 this group contributed 6.94% of total imports showing an increase of 11.20% as against their combined share of 6.24% during the corresponding period of last year.

Miscellaneous Group

During May, 2016 the Miscellaneous Group contributed 2.10% of total imports in which the share of paper & paper product and tyres & tubes were 1.31% and 0.79% respectively.


During July–May, 2016 this group contributed 1.85% of total imports showing an increase of 12.27% as against their combined share of 1.64% during the corresponding period of last year.

II – Analysis of Selected Commodities of Import

POL

Imports of POL during May, 2016 valued at Rs. 75,779.45 million was higher by 42.06% compared to April, 2016 Rs. 53,341.41 million but lower by 9.34% compared to May, 2015 Rs. 83,583.02 million. Cumulative imports of POL during the period July–May, 2016 amounted to Rs. 709,494.31 million as against Rs. 1,081,902.38 million during the corresponding period of last year showing a decrease of 34.42%. The share of POL in total imports in May, 2016 was 18.18% as against 13.34% in April, 2016 and by 22.05% in May, 2015. During July–May, 2016 its share was 16.91% as against 25.76% in the corresponding period of last year.

Imports of chemicals during May, 2016 valued at Rs. 54,860.54 million was higher by 2.75% compared to April, 2016 Rs. 53,394.75 million and by 4.31% compared to May, 2015 Rs. 52,594.17 million. During July–May, 2016 its imports amounted to Rs. 516,442.97 million which was higher by 2.13% compared to imports of Rs. 505,675.75 million during the corresponding period of last year.

The share of chemicals in total imports in May, 2016 was 13.16% as against 13.35% in April, 2016 and 13.87% in May, 2015. During July–May, 2016 its share was 12.31% as against 12.04% in the corresponding period of last year.

Machinery

Imports of machinery during May, 2016 valued at Rs. 73,856.02 million was lower by 18.41% compared to April, 2016 Rs. 90,516.79 million but increased by 26.39% compared to May, 2015, Rs. 58,435.10 million. Cumulative imports of machinery during the period July–May, 2016 amounted to Rs. 816,287.30 million as against Rs. 680,097.00 million during the corresponding period of last year showing an increase of 20.03%.

The share of machinery in total imports in May, 2016 was 17.72% as against 22.63% in April, 2016 and 15.42% in May, 2015. During July–May, 2016 its share was 19.46% as against 16.19% in the corresponding period of last year.

III - Direction of Imports

Imports by Territories/Regions and major countries during May, 2016 and July–May, 2016 of current financial year compared with the corresponding period of last year are given in table 10, 11, 12 and 13 respectively.

During May, 2016 (9.80%) of total imports were from European Union. The share of imports of Middle East was 20.11% and North America was 5.32%. Country-wise, China was at the top of imports list during May, 2016 followed by United Arab Emirates, U.S.A., Indonesia, Japan and India. The combined share of these six countries during May, 2016 was 59.18% as against their combined share of 51.90% during May, 2015.

During July–May, 2016 imports from European Union 10.31%, imports from Middle East were 21.15% and from North America 4.87% of total imports during this period. Country-wise China was on the top of the imports list followed by United Arab Emirates, Saudi Arabia, Indonesia, Japan and India during July–May, 2016. The combined share of these six countries in total imports during this period was 57.64% as against their combined share of 57.15% during the corresponding period of last year.

IV - Imports by Economic Categories

During May, 2016 imports of consumer goods increased by 14.25%, raw material for consumer goods by 4.38% compared to May, 2015. Imports of capital goods during May, 2016 increased by 17.41% and of raw materials for capital goods by 6.87% compared to the same month of last year.

During the eleven months of current financial year July–May, 2016, imports of consumer goods was higher by 7.22%, raw material for consumer goods lower by 14.51% compared to July–May, 2015. Imports of capital goods during Jul-May, 2016 increased by 18.53% and raw material for capital goods by 7.28% compared to the corresponding period of last year.

Performance of imports by economic categories is shown in table-14.
