2. DETAILED DESCRIPTION

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI). Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In November, 2018 the CPI increased by 0.11%, WPI increased by 0.70% while SPI increased by 1.33% respectively.

Month-on-Month: Top few items which varied from previous month i.e. October, 2018 are given below: -

Increased: Chicken Farm (14.78%), Eggs (10.20%), Dettol (8.49%), Potatoes (6.99%), Diesel (5.98%), Sweater Gents (5.59%), Petrol (5.69%), Sweater Ladies (5.32%), Second hand Sweaters for Men (4.89%), Heavy Weight Suiting (4.23%), Pistachio (4.07%) and Fish Rahu (4.03%).

Decreased: Tomatoes (43.78%), Peas (41.75%), Cauliflower (41.02%), Turnip (38.02%), Radish (36.85%), Carrot (23.51%), Cucumber (22.45%), Karaila (19.62%), Brinjal (13.91%), Malta (11.57%), Chilies Green (11.10%), Guava (8.04%) and LPG (7.64%).

Year-on-Year: Top few items which varied from previous year i.e. November, 2017 are given below: -

Increased: Gas Quintile-5 (143.33 %), Gas Quintile-4 (86.67%), Gas Combined (85.31%), Dettol (64.62%), Newspaper (55.64%), Bus Fare Outside (50.60%), A/C Bus Fare Outside City (45.52%), Chicken Farm (44.45%), Diesel (33.51%), Cinema Non A/C (33.45%), Sancos Syrup (32.50%), Betel Leaves (32.02%), CNG (29.67%), Chilies Powder (29.55%), Kerosene Oil (28.81%) and Petrol (28.74%).

Decreased: Tomatoes (61.30%), Onion (58.10%), Chilies Green (29.79%), Peas (22.88%), Potatoes (20.26%), Garlic (20.05%), Cucumber (19.69%), Radish (18.68%), Turnip (17.03%), Gram Whole Yellow (16.56%), Pulse Mash (12.15%), Brinjal (10.94%), and Eggs (10.35).

Increased: Kerosene Oil (34.56%), Gas (34.12%), Petrol (26.56%), Newspaper (17.71%), Transport Services (15.74%), Education (12.48%), Motor Vehicles (11.91%), Water Supply (11.74%), Meat (11.35%), Spices (11.27%), Dry Fruits (10.65%), construction Input Items (10.47%) and Doctor MBBS Fee (10.40%).

Decreased: Onions (41.55%), Pulse Mash (21.26%), Potatoes (20.22%), Tomatoes (15.06%), Gram Whole (8.78%), Pulse Masoor (8.66%), Pulse Moong (6.47%), Besan (5.19%), Pulse Gram (4.60%), Sugar (1.58%), Gur (1.45%) and Eggs (1.17%).

Trimmed Core Inflation

During the month of November, 2018 over November, 2017, the Year on Year increase in the Trimmed Core Inflation was observed at 6.7% whereas it was 4.2% during November, 2017 over November, 2016.

Non-Food & Non-Energy Core Inflation

During the month of November, 2018 over November, 2017, the Year on Year increase in the Non-food & Non-energy Core Inflation has been observed as 8.3% whereas it was 5.5% during November, 2017 over November, 2016.
