2. Detail Description:

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In February, 2018 the CPI decreased by 0.31%, WPI decreased by 0.15% while SPI decreased by 1.21% respectively.

Core inflation of CPI

i. Trimmed Core Inflation

During the month of February, 2018 over January, 2018, the trimmed core inflation has been observed as 4.3% while it was 4.1% during February, 2017.

ii. Non-Food & Non-Energy Core Inflation

During the month of February, 2018 over January, 2018, the Non-food & Non-energy core inflation has been observed as 5.2% while it was 5.3% during February, 2017.
