2. DETAILED DESCRIPTION

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In December, 2018 the CPI decreased by 0.41%, WPI decreased by 0.88% while SPI increased by 2.0% respectively.

<u>Month-on-Month:</u> Top few *items* which varied from previous month i.e. November, 2018 are given below: -

Increased: Train Fare(1st Sleep) (101-500KM) (19.30%), LPG (6.69%), Gold Tezabi (5.75%), Pulse Moong (4.06%), Tea Lipton (3.48%), Motor Cycle Honda (3.06%), Pulse Gram (2.96%), Motor Car Tyre W/O Tube (2.70%), Pulse Masoor (2.65%), Pulse Mash (2.55%) and Cooking Oil (2.88%).

Decreased: Tomatoes (21.14%), Potatoes (20.23%), Onion (13.23, Train Fare Economy Class(101-500KM) (9.52%), Chicken Farm (6.80%), Iron Bar 1/2" (2.39%), Petrol (2.04%), Diesel (1.77%), Eggs (1.32%) and Kerosene Oil (1.00%).

Year-on-Year: Top few items which varied from previous year i.e. December, 2017 are given below: -

Increased: Gas (Combined) (85.31%), Train Fare(1st Sleep) (1-100KM) (56.40%), CNG (29.87%), Diesel (29.08%), Iron Bar ½" (24.11%), Petrol (23.70%), Kerosene Oil (22.15%), Gold Tezabi (20.50%) and Telephone Call Charges (18.02%).

Decreased: Tomatoes (56.30%), Onion (53.45%), Potatoes (36.09%), Air Fare Economy (22.22%), Gram Whole Yellow (16.05%), Train Fare 1st Sleep (Above 500KM) (13.57%), Eggs (9.05%), Pulse Mash (6.32%) and Pulse Masoor (1.16%).

Gas (42.66%), Kerosene Oil (32.60%), Motor Fuel (26.41%), Newspaper (19.31%), Transport Services (15.78%), Motor Vehicles (12.41%), Education (12.16%), Water Supply (12.05%), Spices (11.88%), Meat (11.65%), Construction Input Items (10.71%), Dry Fruits (10.61%), Chicken (10.40%), Doctor MBBS Fee (10.33%), Personal Equipment (10.12%) and Cosmetics (10.09%).

Decreased:

Onions (34.34%), Potatoes (22.86%), Pulse Mash (18.57%), Tomatoes (9.23%), Gram Whole (8.86%), Pulse Masoor (7.20%), Besan (4.85%), Pulse Moong (4.21%), Fresh Vegetables (3.89%), Pulse Gram (3.09%), Eggs (1.91%), Gur (1.25%) and Sugar (0.81%).

Trimmed Core Inflation

During the month of December, 2018 over December, 2017, the Year on Year increase in the Trimmed Core Inflation was observed at 6.9% whereas it was 4.7% during December, 2017 over December, 2016.

Non-Food & Non-Energy Core Inflation

During the month of December, 2018 over December, 2017, the Year on Year increase in the Non-food & Non-energy Core Inflation has been observed as 8.4% whereas it was 5.5% during December, 2017 over December, 2016.
