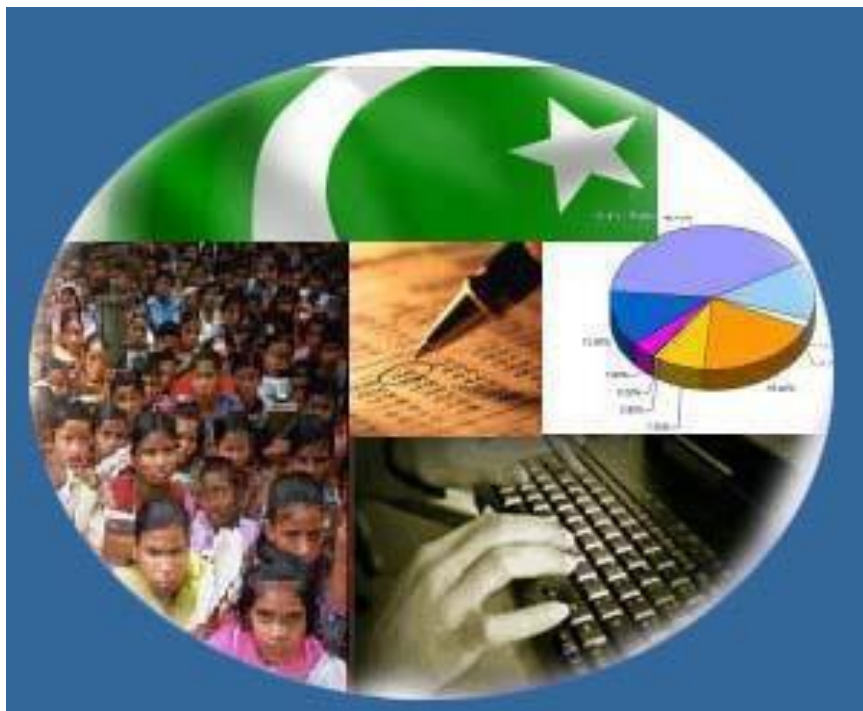




# Monthly Review on Price Indices

## Inflation in Brief

1. CPI inflation General increased by 3.8% on year-on-year basis in February 2018 as compared to an increase of 4.4% in the previous month and 4.2% in February 2017. On month-on-month basis, it decreased by 0.3% in February 2018 as compared to a increase of 0.0% in the previous month and increase of 0.3% in February 2017.
2. Core inflation measured by non-food non-energy CPI (Core NFNE) increased by 5.2% on (YoY) basis in February 2018 as compared to an increase of 5.2% in the previous month and 5.3% in February 2017. On (MoM) basis, it increased by 0.2% in February 2018 as compared to increase of 0.8% in previous month, and an increase of 0.2% in corresponding month of last year i.e. February 2017.
3. Core inflation, measured by 20% weighted trimmed mean CPI (Core Trimmed) increased by 4.3% on (YoY) basis in February 2018 as compared to 4.6% in the previous month and by 4.1% in February 2017. On (MoM) basis, it increased by 0.1% in February 2018 as compared to an increase of 0.6% in the previous month and an increase of 0.2% in corresponding month of last year i.e. February 2017.
4. SPI inflation on YoY increased by 0.5% in February 2018 as compared to an increase of 2.0% a month earlier and an increase of 1.1% in February 2017. On MoM basis, it decreased by 1.2% in February 2018 as compared to a decrease of 1.0% a month earlier and an increase of 0.2% in February 2017.
5. WPI inflation on YoY basis increased by 4.1% in February 2018 as compared to an increase of 4.7% a month earlier and an increase of 5.3% in February 2017. WPI inflation on MoM basis decreased by 0.1% in February 2018 as compared to an increase of 1.8% a month earlier and an increase of 0.5% in corresponding month of last year i.e. February 2017.

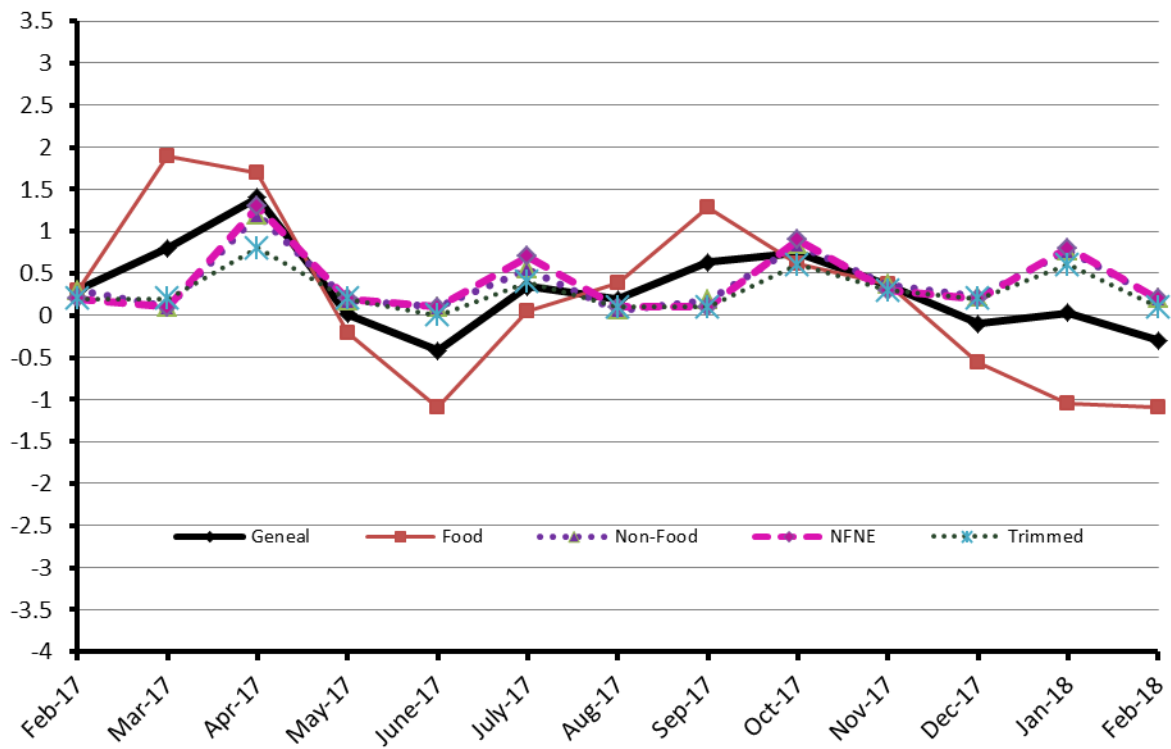
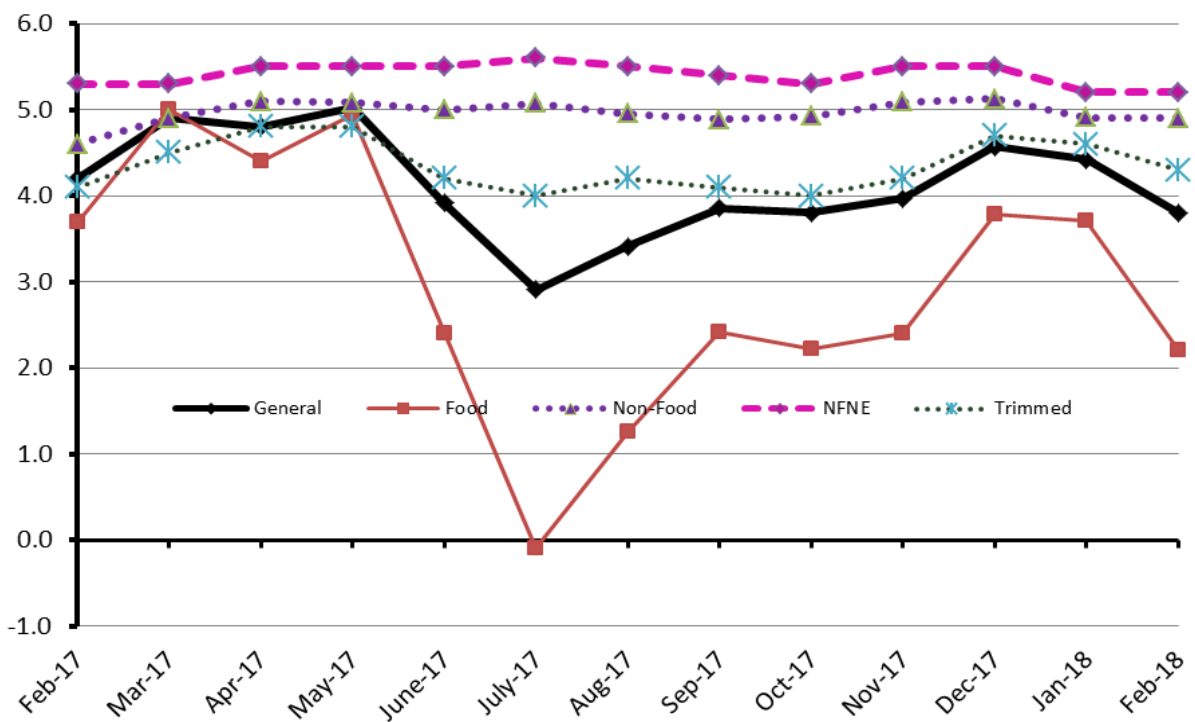


Figure 1: CPI Inflation YoY, Special Indices

6. Figures 1 and 2 show graphically the data of Table 1. Table 1.1 shows "Period Average" and "YoY" percent changes in indices of three years.

Figure 2: CPI Inflation MoM, Special Indices

## II. Consumer Price Index (CPI)

The Consumer Price Index of February 2018, is decreased by 0.31% over January 2017 and increased by 3.80% over corresponding month of the last year i.e. February 2017.

Main contributors to month-on-month and year-on-year percentage changes are given below and detail is given in Annexure A.

- 1. Month-on-month** Top few commodities which varied from previous month are given below:-

**Food Items Increased:** Betel Leaves & Nuts (53.06%), Fresh Fruits (5.83%) and Tea (1.74%).

**Decreased:** Onion (25.29%), Tomatoes (20.52%), Potatoes (18.76%), Eggs (10.02%), Fresh Vegetables (8.10%), Chicken (5.02%), Gur (4.66%), Sugar (3.44%), Pulse Mash (3.30%), Pulse Masoor (1.63%), Gram Whole (1.45%) and Besan (1.03%).

**Non-food Items Increased:** Kerosene Oil (3.75%), Motor Fuel (2.10%), Doctor MBBS Fee (1.93%), Dopatta (1.42%) and Cleaning & Laundry (1.17%).

**Decreased:** Woolen Readymade Garments (0.15%).

- 2. Year-on-Year:** Top few commodities which varied from previous year i.e. February 2017 are given below:-

**Food Items Increased:** Betel Leaves & Nuts (210.13%), Onion (45.59%), Chicken (20.15%), Rice (14.01%), Fresh Fruits (10.77%), Meat (8.42%), Potatoes (7.49%), Readymade Food (6.52%), Tea (6.47%), Honey (5.84%), Dry Fruits (5.14%) and Milk Products (5.05%).

**Decreased:** Pulse Mash (23.56%), Cigarettes (19.82%), Sugar (17.80%), Pulse Gram (17.22%), Pulse Masoor (16.39%), Pulse Moong (13.88%), Besan (12.43%), Gur (8.24%), Eggs (6.99%), Tomatoes (3.77%), Gram Whole (2.54%) Fresh Vegetables (1.31%), and Wheat (1.05%).

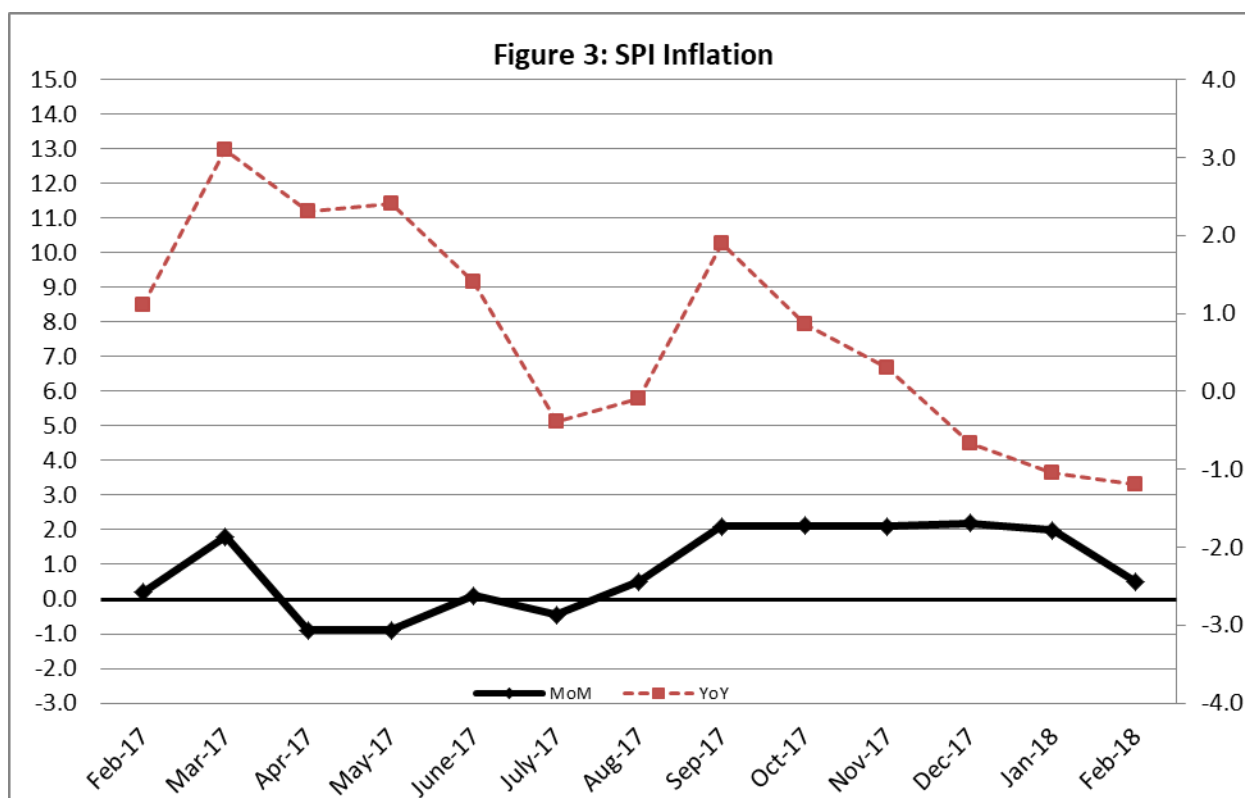
**Non-food Items Increased:** Kerosene Oil (24.06%), Motor Fuel (12.22%), Education (12.13%), Cleaning & Laundry (8.85%), Tailoring (8.45%), Construction Wage Rates (8.27%), Personal Equipments (8.23%), Doctor MBBS Fee (8.19%), Medical Tests (6.59%), Readymade Garments (6.31%), Utensils (6.30%), Water Supply (5.51), House Rent (5.43%), Marriage Hall Charges (5.27%), Personal Care (5.17%), and Household Servant (5.15%).

### III. Sensitive Price Indicator

Quintile-wise percentage changes YoY and MoM are given below in Table 3. The series from February 2017 to February 2018 is also graphed below in Figure 3.

## IV. Wholesale Price Index

The Wholesale Price Index for February, 2018 decreased by 0.15% over January, 2018. It increased by 4.08% over the corresponding month of the last year. YoY and MoM movements, from February, 2017 to February, 2018 are also graphed below in Figure 4.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January, 2018 are given below:-

**Increased:** Furnace Oil (11.46%), Fresh Fruits (9.48%), Kerosene Oil (9.25%), Diesel (8.27%), Petrol (3.66%), Coffee, Tea and Chemicals (3.22%) each, Salt & Pure Sodium Chloride (2.81%), Timber (1.58%), Jowar (1.31%).

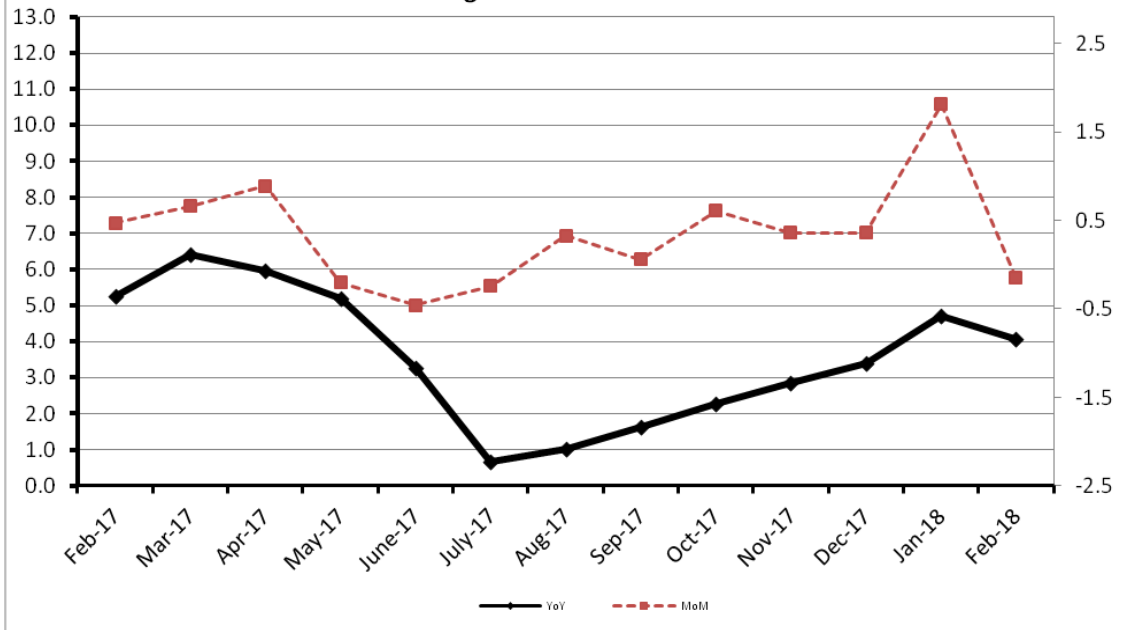
**Decreased:** Potatoes (22.77%), Vegetables (18.88%), Eggs (10.39%), Fiber Crops (7.21%), Sugar (5.39%), Poultry (4.93%), Maize (3.12%), Other Oil Seeds (1.50%) and Pulses (1.34%).

2. **Year-on-year** Top few commodities which varied from previous year i.e. February, 2017 are given below:-

**Increased:** Kerosene Oil (62.66%), Diesel (31.47%), Poultry (24.54%), Furnace Oil (23.37%), Stimulant & Spice Crops (20.04%), Petrol (18.56%), Fresh Fruits (14.75%), Dried Fruits & Nuts (12.51%), Cotton Yarn (12.03%), Ice Cream (11.75%), Steel Bar & Sheets (11.67%), Processed Milk (11.49%), Meat of Animals (11.37%), Salt & Pure Sodium Chloride (10.83%), Dry Fruits (10.68%), Rice (10.54%), Unmanufactured Tobacco (10.11%) and Chemicals (10.08%).

**Decreased:** Tobacco Products (28.59%), Sugar (19.68%), Other Cereal Flour (19.12%) and Pulses (8.01%).
