2. Detail Description:

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In March, 2016 the CPI increased by 0.15% while WPI and SPI decreased by 0.40% and 0.15% respectively.

Main contributors to month-on-month and year-on-year are given below:

i) <u>Month-on-month</u> Top few commodities which varied from previous month i.e. February, 2016 are given below:-

Food Items Increased: Chicken (13.92), Fresh Fruit (8.31%), Fresh Vegetables (6.73%), Betel Leaves & Nuts (2.22%) and Potatoes (1.6%).

Decreased: Tomatoes (18.67%), Eggs (16.56%) and Tea (7.57%).

Non-food Items Increased: Personal equipments (2.13%), Kerosene Oil (1.23%), Medical Tests (1.21%), Readymade garments (1.15) and Woolen Cloth (1.11%).

Decreased: Motor Fuel (7.3%) and Transport Services (1.94%).

ii) <u>Year-on-Year:</u> Top few commodities which varied from previous year i.e. March, 2015 are given below:-

Food Items Increased: Pulse Mash (53.99%), Pulse Gram (52.32%), Besan (47.78%), Onion (43.44%), Cigarettes (27.22%), Gram Whole (24.11%), Tea (19.18%), Sugar (14.91%) and Betel Leaves and Nuts (13.76%).

<u>Decreased:</u> Tomatoes (49.6%), Potatoes (18.29%), Cooking Oil (12.83%), Rice (12.8%), Eggs (10.49%) and Vegetable Ghee (8.71%).

Non-food Items Increased: Sewing Needle (11.31%), Gas (9.92%), Tailoring (9.75%), Education (9.61%), Readymade Garments (8.63%), Household Servants (8.22%), Construction Wage Rates (7.87%), Water Supply (7.46%) and Doctor MBBS Fee (7.02%).

<u>Decreased:</u> Motor Fuel (8.76%), Kerosene Oil (7.02%), Motor Vehicle Accessories (4.02%) and Transport Services (2.71%)

Top few commodities which varied from previous year average i.e. July-March, 2014-15 are given below:-

Increased: Pulse Gram (50.71%), Besan (44.89%), Onion (43.72%), Pulse Mash (38.08%), Tea (24.89%), Cigarettes (21.05%), Gram Whole (19.75%), Sewing Needle (10.06%), Sugar (9.32%), Education (9.06%), Tailoring (8.95%), Betel Leaves and Nuts (8.59%), Woolen Readymade Garments (8.47%) and Construction Wage Rates (8.12%).

<u>Decreased:</u> Potatoes (49.19%), Kerosene Oil (17.40%), Cooking Oil (14.42%), Rice (14.42%), Motor Fuel (13.96%), Vegetable Ghee (10.98%). Eggs (9.73%) and Transport Services (6.46%).

3. Core inflation of CPI

i. Trimmed Core Inflation

During the month of March, 2016 over March, 2015, the trimmed core inflation has been observed as 3.8% while it was 3.8% during March, 2015 over March, 2014.

ii. Non-Food & Non-Energy Core Inflation

During the month of March, 2016 over March, 2015, the Non-food & Non-energy core inflation has been observed as 4.7% while it was 5.9% during March, 2015 over March, 2014.
