# PRESS RELEASE ON INFLATION RATE FOR THE MONTH OF SEPTEMBER, 2014 WITH BASE 2007-08=100

### 1. SUMMARY OF INFLATION RATES

### 2. Detail Description:

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In September, 2014 the CPI, SPI and WPI increased by 0.35%, 0.24% and 0.15% respectively.

Main contributors to month-on-month and year-on-year are given below:

i) <u>Month-on-month</u> Top few commodities which varied from previous month i.e. September, 2014 over August, 2014 are given below:-

**Food** Items Increased: Tomatoes (33.88%), Sugar (6.33%), Gur (2.75%), Honey (2.32%), Pulse Mash (2.24%), Onions (2.19%), Tea (1.42%) and Eggs (1.21%).

**Decreased:** Chicken (11.41%), Fresh Fruits (4.17%), Pulse Moong (2.73%), and Potatoes (2.35%).

Non-food Items Increased: Motor Fuel (0.55%) and Kerosene Oil (0.14%).

ii) <u>Year-on-year</u> Top few commodities which varied from corresponding month of previous year i.e. September, 2014 over September 2013 are given below:-

**Food Items Increased:** Potatoes (99.71%), Cigarettes (22.60%), Pulse Moong (19.70%), Pulse Mash (19.04%) and Honey (16.13%).

Decreased: Tea (17.61%) and Onions (9.42%).

**Non-food Items Increased**: Motor Vehicle Tax (36.71%), Electricity (15.82%) and Education (15.28%).

### Average Inflation Rate

The Consumer Price Index of July- September, 2014-15 has increased by 7.52% over July-September, 2013-14 as per details given below:-

Top few commodities which varied from previous year average i.e. July-Sep 2013-14 are given below:-

**Increased:** Potatoes (111.58%), Motor Vehicle Tax (36.71%), Pulse Moong (22.82%), Cigarettes (22.61%), Electricity (15.82%), Pulse Mash (15.79%), Milk Powder (15.73%), Education (15.69%) and Cotton Cloth (15.24%).

**Decreased:** Tomatoes (31.79%), Tea (17.96%) and Onions (15.00%).

# 3. Core inflation of CPI

### i. Trimmed Core Inflation

During the month of September, 2014 over September, 2013, the trimmed core inflation has been observed as 7.1%, while it was 7.6% during September, 2013 over September, 2012.

### ii. Non-Food & Non-Energy Core Inflation

During the month of September, 2014 over September, 2013, the Non-food & Non-energy core inflation has been observed as 8.1%, while it was 8.6% during August, 2013 over September, 2012.
