Review of Foreign Trade July, 2011

EXPORTS

The total exports of Pakistan during July, 2011 amounted to Rs. 185,586.57million as against Rs. 207,777.78 million in June, 2011 and Rs. 147,596.39 million during July, 2010 showing a decrease of 10.68% over June, 2011 and higher by 25.74% over July, 2010.

In terms of U.S dollars, the exports during July, 2011 amounted to \$ 2,157.47 million as against \$ 2,422.05 million in June, 2011 and \$ 1,726.21 million during July, 2010 showing a decrease of 10.92% over June, 2011 while higher by 24.98% over July, 2010.

IMPORTS

The total Imports of Pakistan during July, 2011 amounted to Rs. 317,339.94million as against Rs. 331,356.12 million in June, 2011 and Rs. 276,927.61 million during July, 2010 showing a decrease of 4.23% over June, 2011 while higher by 14.59% over July, 2010.

In terms of US dollars the imports during July, 2011 amounted to \$ 3,689.12 million as against \$ 3,862.59 million in June, 2011 and \$ 3,238.80 million during July, 2010 showing a decrease of 4.49% over June, 2011 while higher by 13.90% over July, 2010.

Based on the above figures of exports & imports the balance of trade in July, 2011 was unfavourable for Pakistan to the tune of 131,753.37 million rupees equal to US \$ 1,531.65 million.

I - Exports by Group/Commodities

Exports from Pakistan during July, 2011 amounted to Rs. 185,586.57 million as against the exports of Rs. 207,777.78 million in previous month and Rs. 147,596.39 million during the corresponding month of last year showing a decrease of 10.68% over previous month and higher by 25.74% over the corresponding month of last year.

Comparative figure of exports by group/commodities during July, 2011 compared to June, 2011 and July, 2010 are given in table-1.

Primary Commodities

During July, 2011 these 6 selected commodities of Primary Commodities contributed 11.24% of total exports in which the share of Rice was (8.35%), Fruits, vegetables & preparation thereof (1.62%) and Fish & fish preparation (0.67%).

Textile Manufactures

During July, 2011 these 9 selected commodities of Textile Manufactures contributed 49.97% of total exports in which the share of Cotton fabrics (11.00%), Knitwear (10.61%), Bed-wear (8.50%), Articles of apparel & clothing accessories (excl. knitwear) (7.41%) and Cotton yarn (5.68%).

Other Manufactures


During July, 2011 these 7 selected commodities of Other Manufactures contributed 12.99% of total exports in which the share of Petroleum products (5.06%), Leather clothes & accessories (2.59%), Leather (1.85%), Sports goods (excl. toys) (1.35%) and Surgical instruments (1.16%).

II – Analysis of Selected Commodities of Exports

Cotton Fabrics

Cotton fabrics maintained its first position in its group during July, 2011 as in the previous month. During this month its exports amounted to Rs. 20,417.02million as against Rs. 26,284.71 million in June, 2011 and Rs. 14,872.99 million during July, 2010 showing a decrease of 22.32% over June, 2011 while higher by 37.28% over July, 2010.

During July, 2011 of current financial year 174,473 thousand sq. meters of cotton fabrics valued at Rs.20,417.02 million were exported as against 160,125 thousand sq. meters valued at Rs. 14,872.99million during the same period of last year showing an increase of 8.96% in terms of quantity and 37.28% in terms of value. During July, 2011 the average unit price of cotton fabrics increased to Rs. 117.02per sq. meter from Rs. 92.88 per sq. meter during the corresponding period of last year showing an increase of 25.99 percent.

Main buyers of cotton fabrics during July, 2011 of current financial year were Bangladesh (Rs. 2,555.39million), Cambodia (Rs. 1,475.51million), U.S.A. (Rs. 1,277.40 million), Italy (Rs. 802.10million), South Africa (Rs. 892.09million), Germany (Rs.866.31million), Turkey (Rs. 836.73million), United Kingdom (Rs. 681.75million) Mexico (Rs. 676.92million), Sri Lanka (Rs. 670.48million), Viet Nan (Rs. 647.53million), Russian Federation (Rs. 517.55million) and Egypt (U.A.R) (Rs. 516.68million). Their total take-off accounted for 61.27% of total exports of cotton cloth as compared to their combined share of 63.37% during the same period of last year.

Variety-wise exports of cotton fabrics during July, 2011 of current financial year and the corresponding period of last year are given below.

Cotton Yarn

Cotton yarn maintained its fifth position in its group during July, 2011 as in the previous month. Its exports in this month amounted to Rs. 10,548.01 million as against Rs. 13,974.97 million in June, 2011 and Rs. 9,633.14 million in July, 2010 showing a decrease of 24.52% over June, 2011 while higher by 9.50% over July, 2010.

During July, 2011 exports of cotton yarn amounted to Rs. 10,548.01 million as against Rs. 9,633.14million in the corresponding period of last year showing a rise of 9.50 percent. In terms of quantity 31,055 thousand Kg. of cotton yarn was exported during July, 2011 of current financial year as against 35,416 thousand Kg. during the corresponding period of last year showing a decrease of 11.64 percent. The average unit price of cotton yarn for the period July, 2011 of current financial year was Rs. 339.66per Kg. as against Rs. 272.00 per Kg. in the same period of last year showing an increase of 24.48 percent.

China (Rs. 4,840.50million), Hong Kong (Rs. 937.48million), Bangladesh (Rs. 725.33million), Korea Rep. of (Rs. 482.47million), Turkey (Rs. 458.52million), Japan (Rs. 418.67million), U.S.A. (Rs. 376.56million) and Portugal (Rs. 283.02million), were major buyers of cotton yarn during this period. Their combined share accounted for 80.80% of total exports of cotton yarn as compared to their combined share of 81.83% during the same period of last year.

Variety-wise exports of cotton yarn in terms of quantity and value during July, 2011 of the current financial year and corresponding period of last year are given below:-

Rice

Rice maintained its first position in its group during July, 2011 as in the previous month. In this month it fetched Rs. 15,490.72million as against Rs. 15,576.64 million in June, 2011 and Rs. 18,641.51 million in July, 2010 showing a decrease of 0.55% over June, 2011 and by 16.90% over July, 2010.

During July, 2011 its exports amounted to Rs. 15,490.72 million as against the exports of Rs. 18,641.51 million during the corresponding period of last year showing a decrease of 16.90 percent. United Arab Emirates was the leading buyer of rice during July, 2011 with its share of 21.52% in the total exports of this item. Other major buyers were Afghanistan (10.85%), Kenya (10.37%), Oman (6.45%), Iran (4.67%), United Kingdom (4.28%) and Qatar (3.71%). These seven countries accounted for 61.87% of total exports of rice during this period.

Exports of rice to major countries during July, 2011 and the corresponding period of last year are given below.

Unit price of rice "Other Varieties" decreased to Rs. 43,358.18per tonne in July, 2011 from Rs. 34,219.26 in July, 2010 showing a rise of 26.71 percent.

Petroleum Products

Petroleum products maintained its first position in its group during July, 2011 as in the previous month. In this month its exports amounted to Rs. 9,397.05million as against Rs. 9,024.74 million in June, 2011 and Rs. 5,339.96 million in July, 2010 showing an increase of 4.13% over June, 2011 and by 75.98% over July, 2010.

In terms of quantity 99,669tonnes of petroleum products were exported during July, 2011 of current financial year as against 85,604tonnes exported during the corresponding period of last year showing an increase of 16.43 percent.

The main buyers of petroleum products during July, 2011 were Afghanistan (Rs. 7,032.18 million) and United Arab Emirates (Rs. 2,357.99 million). These three countries accounted for 99.93% of total exports of petroleum products during July, 2011 as against their combined share of 95.62% during the same period of last year.

Leather

Leather maintained to third position in its group during July, 2011 as the same position in the previous month. Its exports in this month amounted to Rs. 3,428.23million as against Rs. 3,628.14million in June, 2011 and Rs. 3,167.89 million in July, 2010 showing a decrease of 5.51% over June, 2011 while higher by 8.22% over July, 2010.

In terms of quantity 2,458,581 sq. meter of leather was exported during July, 2011 as against 2,499,583 sq. meters exported during the corresponding period of last year showing a decrease of 1.64 percent.

The main buyers of leather during July, 2011 were Hong Kong (Rs. 922.97 million), China (Rs. 476.84 million), Korea Rep. of (Rs. 437.29 million), Italy (Rs. 262.06million), Turkey (Rs. 149.87 million), Viet Nam (Rs. 122.76 million) and India (Rs. 106.63 million) whose combined share in total exports of leather was 75.77% as against their combined share of 78.02% during the same period of last year.

Carpets, Carpeting, Rugs & Mats

Carpets, carpeting, rugs and mats maintained its seventh position in its group during July, 2011 as in the previous month. Its exports in July, 2011 amounted to Rs.832.49 million as against Rs. 880.53million in June, 2011 and Rs. 616.87 million in July, 2010 showing a decrease of 5.46% over June, 2011 while by 34.95% over July, 2010.

In terms of quantity 223,988 sq. meters of carpets, carpeting, rugs & mats were exported during July, 2011 of current financial year as against 146,582 sq. meters exported during the corresponding period of last year showing an increase of 52.81 percent.

The average unit price of carpets of wool hand knotted was Rs. 6,075.52 per sq. meter during July, 2011 as against Rs. 5,090.10per sq. meter in the corresponding period of last year showing a rise of 19.36 percent. U.S.A. (Rs. 289.87 million), Germany (Rs. 115.56million), Turkey (Rs. 97.21 million), Afghanistan (Rs. 38.42 million), France (Rs. 32.81 million) South Africa (Rs. 30.03 million) Japan (Rs. 28.72 million) and Austria (Rs. 28.30 million) were the main buyers of carpets, carpeting, rugs & mats during July, 2011. They together accounted for 79.39% during July, 2011 as compared to their combined share of 59.03% during the same period of last year.

Raw Cotton

Raw Cotton maintained its fourth position in its group during July, 2011 as in the previous month. Its exports in this month amounted to Rs. 991.30million as against Rs. 1,276.29million in June, 2011 and Rs. 87.75 million in July, 2010 showing a decrease of 22.33% over June, 2011 while higher by 1,029.69% over July, 2010.

Exports of this item during July, 2011 In terms of quantity 4,414 tonnes of raw cotton was exported during July, 2011 as against 553 tonnes exported during the same period of last year showing an increase of 698.19 percent.

The main buyers of raw cotton during July, 2011 were Indonesia (Rs. 182.40 million), China (Rs. 157.76 million), Viet Nam (Rs. 143.12 million) and Thailand (Rs. 129.58 million). They together accounted for 61.82% of total exports of raw cotton during July, 2011 as against their combined share of 99.99% during the corresponding period of last year.

III - Direction of Exports

Exports by Territories/Regions and Major countries during July, 2011 compared to the same month of last year are given in table 2 and 3 respectively.

During the month of July, 2011, (24.49%) of total exports went to European Union as against 24.66% in July, 2010. The share of North America during July, 2011 was 18.75% as against 21.31% in July, 2010. The share of Middle East during July, 2011 was 17.88% as against 19.93% in July, 2010. Country-wise, U.S.A. was at the top of the exports list for July, 2011 followed by Afghanistan, United Arab Emirates, United Kingdom, China and Germany. The share of these six countries in total exports for July, 2011 was 55.36% as against their combined share of 49.56% in July, 2010.

IV - Exports by Economic Categories

Export of primary commodities during the current month increased to Rs. 28,854.68million from Rs. 24,160.48 million by 19.43 percent over the corresponding month of last year. Its share in total export decreased to 15.55% from 16.37% during this period.

During July, 2011 exports of semi-manufactures amounted to Rs. 19,011.18 million as against Rs. 14,896.28million during July 2010 showing increased of 27.62 percent. The share of Semi-manufactures in total export increased to 10.24~% in this month from 10.09% in the corresponding month of last year.

Export of manufactured goods during July, 2011 increased to Rs. 137,720.71 million from Rs. 108,539.63 million during July, 2010 showing increased by 26.89 percent. The share in total export during the month increased to 74.21% from 73.54% during the corresponding month of last year.

I – Imports by Group/Commodities

Imports into Pakistan during July, 2011 amounted to Rs. 317,339.94 million as against the imports of Rs. 331,356.12 million in the previous month and Rs. 276,927.61 million during the corresponding month of last year showing a decrease of 4.23% over previous month but higher by 14.59% over the corresponding month of last year.

Comparative figures of imports by group/commodities during July, 2011, June, 2011 and July, 2010 are given in Table-4.

Food Group

During July, 2011 the 5 selected commodities of Food Group contributed 9.78% of total imports in which the share of Palm oil and Pulses were 7.22% and 1.47% respectively.

Machinery & Transport Group

During July, 2011 Machinery & Transport Group contributed 14.37% of total imports in which the share of Machinery and Transport equipment were 10.47% and 3.63% respectively.

Petroleum Group

During July, 2011 Petroleum Group contributed 32.18% of total imports in which the share of Petroleum crude and Petroleum products were 21.56% and 10.63% respectively.

Textile Group

During July, 2011 Textile Group contributed 2.96% of total imports in which the share of Synthetic fibre and Synthetic & artificial silk yarn were 1.60% and 1.35% respectively.

Chemical Group

During July, 2011 Chemical Group contributed 18.20% of total imports in which the share of Chemical (excl. fertilizer, medicines & insecticide) were (12.59%), Fertilizer manufactured (3.21%), Medicinal products (1.93%) and Insecticide (0.47%).

Metal Group

During July, 2011 Metal Group contributed 4.25% of total imports in which the share of Iron & steel and Iron & steel scrap were 2.68% and 1.57% respectively.

Miscellaneous Group



II - Analysis of Selected Commodities of Imports

POL

Imports of POL during July, 2011 valued at Rs. 102,132.89 million was lower by 26.42% as compared to June, 2011 Rs. 138,805.96 million but higher by 18.70% compared to July, 2010 Rs. 86,043.66million.

The share of POL in total imports in July, 2011 was 32.18% as against 41.89% in June, 2011 and by 31.07% in July, 2010.

Chemicals (Excluding fertilizer, insecticides & medicines)

Imports of chemicals (Excluding fertilizer, insecticides & medicines) during July, 2011 valued at Rs. 39,948.80million was higher by 17.81% compared to June, 2011 Rs. 33,908.43 million and by 35.51% compared to July, 2010 Rs. 29,479.36million.

The share of chemicals (Excluding fertilizer, insecticides & medicines) in total imports in July, 2011 were 12.59% as against 10.23% in June, 2011 and 10.65% in July, 2010.

Machinery

Imports of machinery during July, 2011 valued at Rs. 34,102.96million was lower by 16.30% compared to June, 2011 Rs. 40,742.33 million and by 21.04% compared to July, 2010 Rs. 43,192.39 million.

The share of machinery in total imports in July, 2011 was 10.75% as against 12.30% in June, 2011 and by 15.60% in July, 2010.

Transport Equipment

Transport equipment were Rs. 11,511.34million was imported during July, 2011 as against its imports of Rs. 12,706.12 million in June, 2011 and Rs. 8,629.99 million in July, 2010 showing a decrease of 9.40% over June, 2011 while an increase by 33.39% over July, 2010.

The share of transport equipment in total imports in July 2011 was 3.63% as against 3.83% in June 2011 and by3.12% in July 2010.

III - Direction of Imports

Imports by Territories/Regions and major countries during July, 2011 compared with July, 2010 are given in table 5 and 6 respectively.

During July, 2011 (8.76%) of total imports were from European Union. The share of imports of Middle East was 39.27% and North America 5.48 percent. Country-wise, United Arab Emirates was at the top of imports list during July, 2011 followed by China, Saudi Arabia, Malaysia, Kuwait and Japan. The combined share of these six countries during July, 2011 was 64.42% as against their combined share of 55.84% during July, 2010.
