Review of Foreign Trade July, 2014

EXPORTS

The total exports of Pakistan during July, 2014 amounted to Rs. 189,756.51 million as against Rs. 198,680.69 million in June, 2013 and Rs. 210,465.35 million during July, 2013 showing a decrease of 4.49% over June, 2014 and 9.84% over July, 2013.

In terms of U.S dollars, the exports during July, 2014 amounted to \$1,923.45 million as against \$2,017.72 million in June, 2013 and \$2,094.70 million during July, 2013 showing a decrease of 4.67% over June, 2014 and by 8.18% over July, 2013.

IMPORTS

The total Imports of Pakistan during July, 2014 amounted to Rs. 319,670.13 million as against Rs. 425,228.93 million in June, 2014 and Rs. 383,244.90 million during July, 2013 showing a decrease of 24.82% over June, 2014 and by 16.59% over July, 2013.

In terms of US dollars the imports during July, 2014 amounted to \$3,240.31 million as against \$4,318.45 million in June, 2014 and \$3,814.32 million during July, 2013 showing a decrease of 24.97% over June, 2014 and 15.05% over July, 2013.

Based on the above figures of exports & imports the balance of trade in July, 2014 was unfavourable for Pakistan to the tune of 129,913.62 million rupees equal to US \$1,316.86 million.

I - Exports by Group/Commodities

Exports from Pakistan during July, 2014 amounted to Rs. 189,756.51 million as against the exports of Rs. 198,680.69 million in previous month and Rs. 210,465.35 million during the corresponding month of last year showing a decrease of 4.49% over previous month and by 9.84% over the corresponding month of last year.

Comparative figure of exports by group/commodities during July, 2014 compared to June, 2014 and July, 2013 are given in table-1.

Primary Commodities

During July, 2014 these 6 selected commodities of Primary Commodities contributed 9.50% of total exports in which the share of Rice was (6.52%), Fruits, vegetables & preparation thereof (1.64%) and Fish & fish preparation (1.10%).

Textile Manufactures


During July, 2014 these 9 selected commodities of Textile Manufactures contributed 58.33% of total exports in which the share of knitwear (12.19%),cotton fabrics (11.03%), bed wear (10.34%), articles of apparel & clothing accessories (excl. knitwear) (9.56%) and cotton yarn (6.99%).

Other Manufactures

During July, 2014 these 7 selected commodities of Other Manufactures contributed 10.85% of total exports in which the share of leather clothes & accessories (3.20%), leather (2.03%), Sports goods (excl. toys) (1.81%), surgical instruments (1.48%) and carpet, carpeting, mats & rugs (0.53%).

II – Analysis of Selected Commodities of Exports

Cotton Fabrics

Cotton fabrics maintained its second position in its group during July, 2014 as in the previous month. During this month its exports amounted to Rs. 20,936.87 million as against Rs. 19,462.88 million in June, 2014 and Rs. 23,139.57 million during July, 2013 showing an increase of 7.57% over June, 2014 but a decrease 9.52% over July, 2013.

During July, 2014 of current financial year 170,475 thousand sq. meters of cotton fabrics valued at Rs. 20,936.87 million were exported as against 214,424 thousand sq. meters valued at Rs. 23,139.57 million during the same period of last year showing a decrease of 20.50% in terms of quantity and 9.52% in terms of value. During July, 2014 the average unit price of cotton fabrics increased to Rs. 122.81 per sq. meter from Rs. 107.92 per sq. meter during the corresponding period of last year showing an increase of 13.81%.

Main buyers of cotton fabrics during July, 2014 of current financial year were Bangladesh (Rs. 3,152.68 million), China (Rs. 2,201.74 million), Turkey (Rs. 1,273.12 million), Germany (Rs.991.73 million), U.S.A. (Rs. 827.67 million), Italy (Rs. 792.12 million), Sri Lanka (Rs. 763.48 million), United Kingdom (Rs. 750.63 million), Netherlands (Rs. 671.16 million) and Egypt (U.A.R) (Rs. 649.82 million). Their total take-off accounted for 57.67% of total exports of cotton cloth as compared to their combined share of 61.64% during the same period of last year.

Variety-wise exports of cotton fabrics during July, 2014 of current financial year and the corresponding period of last year are given below.

Cotton Yarn

Cotton yarn maintained its fifth position in its group during July, 2014 as in the previous month. Its exports in this month amounted to Rs. 13,264.92 million as against Rs. 13,318.25 million in June, 2013 and Rs. 20,394.99 million in July, 2013 showing a decrease of 0.40% over June, 2014 and 34.96% over July, 2013.

During July, 2014 exports of cotton yarn amounted to Rs. 13,264.92 million as against Rs. 20,394.99 million in the corresponding period of last year showing a fall of 34.96%. In terms of quantity 45,407 thousand Kg. of cotton yarn was exported during July, 2014 of current financial year as against 67,166 thousand Kg. during the corresponding period of last year showing a decrease of 32.40%. The average unit price of cotton yarn for the period July, 2014 of current financial year was Rs. 292.96 per Kg. as against Rs. 303.65 per Kg. in the same period of last year showing a decrease of 3.79%.

China (Rs. 8,355.98 million), Bangladesh (Rs. 1,005.11 million), Hong Kong (Rs. 859.04 million), Turkey (Rs. 614.39 million), Korea Rep. of (Rs. 406.18 million), Japan (Rs. 293.43 million), Viet Nam (Rs. 227.75 million), Portugal (Rs. 196.14 million) and Malaysia (Rs. 175.07 million), were major buyers of cotton yarn during this period. Their combined share accounted for 58.84% of total exports of cotton yarn as compared to their combined share of 83.01% during the same period of last year.

Rice

Rice maintained its first position in its group during July, 2014 as in the previous month. In this month it fetched Rs. 12,368.29 million as against Rs. 14,746.96 million in June, 2014 and Rs. 15,153.97 million in July, 2013 showing a decrease of 16.13% over June, 2014 and by 18.38% over July, 2013.

During July, 2014 its exports amounted to Rs. 12,368.29 million as against the exports of Rs. 15,153.97 million during the corresponding period of last year showing a decrease of 18.38%. United Arab Emirates was the leading buyer of rice during July, 2014 with its share of 12.72% in the total exports of this item. Other major buyers were Kenya (12.33%), United Kingdom (9.50%), Saudi Arabia (6.82%), Oman (5.46%), Indonesia (4.02%) and Qatar (3.63%). These seven countries accounted for 54.49% of total exports of rice during this period.

Unit price of rice "Other Varieties" decreased to Rs. 52,340.06 per tonne in July, 2014 from Rs. 47,939.10 in July, 2013 showing a rise of 9.18%.

Petroleum Products

Petroleum products came down to fifth position in its group during July, 2014 from its third position in the previous month. In this month its exports amounted to Rs. 1,865.91 million as against Rs. 3,547.60 million in June, 2014 and Rs. 74.34 million in July, 2013 showing a decrease of 47.40% over June, 2014 while higher by 2,409.97% over July, 2013.

In terms of quantity 19,325 tonnes of petroleum products were exported during July, 2014 of current financial year as against 828 tonnes exported during the corresponding period of last year showing an increase of 2,233.94%.

The main buyers of petroleum products during July, 2014 were Singapore (Rs. 953.71 million), Afghanistan (Rs. 907.76 million), Philippines (Rs. 3.26 million) and China (Rs. 1.19 million). These four countries accounted for 100.00% share of total exports of petroleum products during July, 2014 as against their combined share of 81.77% during the same period of last year.

Leather

Leather maintained its second position in its group during July, 2014 as the same position in the previous month. Its exports in this month amounted to Rs. 3,845.43 million as against Rs. 5,102.25 million in June, 2014 and Rs. 4,533.69 million in July, 2013 showing a decrease of 24.63% over June, 2014 and by 15.18% over July, 2013.

In terms of quantity 1,783,445 sq. meter of leather was exported during July, 2014 as against 2,446,943 sq. meters exported during the corresponding period of last year showing a decrease of 27.12%.

The main buyers of leather during July, 2014 were Hong Kong (Rs. 839.17 million), China (Rs. 466.41 million), Italy (Rs. 320.68 million), India (309.10 million), Korea Rep. of (Rs. 274.58 million), Viet Nam (Rs. 212.02 million), Germany (Rs. 198.45 million), Bangladesh (Rs. 145.01 million), South Africa (Rs. 124.29 million) and Turkey (Rs. 123.00 million), whose combined share in total exports of leather was 77.83% as against their combined share of 84.48% during the same period of last year.

Carpets, Carpeting, Rugs & Mats

Carpets, carpeting, rugs and mats maintained its seventh position in its group during July, 2014 as the same position in the previous month. Its exports in July, 2014 amounted to Rs.999.55 million as against Rs. 753.33 million in June, 2014 and Rs. 1,013.64 million in July, 2013 showing an increase of 32.68% over June, 2013 but lover by 1.39% over July, 2013.

In terms of quantity 297,580 sq. meters of carpets, carpeting, rugs & mats were exported during July, 2014 of current financial year as against 265,722 sq. meters exported during the corresponding period of last year showing an increase of 11.99%.

The average unit price of carpets of wool hand knotted was Rs. 3358.93 per sq. meter during July, 2014 as against Rs. 3814.66 per sq. meter in the corresponding period of last year showing a rise of 11.99%. U.S.A. (Rs. 412.40 million), Turkey (129.17), Germany (Rs. 113.19 million) Italy (Rs. 44.54 million), United Kingdom (Rs. 42.38 million), France (Rs. 26.36 million), Japan (Rs. 24.48 million), U.A.E.(Rs. 19.21 million) and Canada (Rs. 16.87 million), were the main buyers of carpets, carpeting, rugs & mats during July, 2014. They together accounted for 82.92% during July, 2014 as compared to their combined share of 78.21% during the same period of last year.

Quantity and value of exports of carpets, carpeting, rugs & mats during July, 2014 and corresponding period of last year are given below.

Raw Cotton

Raw Cotton came up to fourth position in its group during July, 2014 from its fifth position the previous month. Its exports in this month amounted to Rs.329.57 million as against Rs. 135.74 million in June, 2014 and Rs. 879.60 million in July, 2013 showing an increase of 142.80% over June, 2014 while decreased by 62.53% over July, 2013.

In terms of quantity 1,851 tonnes of raw cotton was exported during July, 2014 as against 5,246 tonnes exported during the same period of last year showing a decrease of 64.72%.

The main buyers of raw cotton during July, 2014 were Bangladesh (Rs. 200.95 million), Indonesia (Rs. 68.52 million), India (Rs. 36.14 million) and Thailand (Rs. 23.95 million). They together accounted for 100.00% of total exports of raw cotton during July, 2014 as against their combined share of 46.96% during the corresponding period of last year.

III - Direction of Exports

Exports by Territories/Regions and Major countries during July, 2014 compared to the same month of last year are given in table 2 and 3 respectively.

During the month of July, 2014, (32.46%) of total exports went to European Union as against 25.15% in July, 2013. The share of North America during July, 2014 was 19.15% as against 18.74% in July, 2013. The share of Middle East during July, 2014 was 11.55% as against 12.89% in July, 2013. Country-wise, U.S.A. was at the top of the exports list for July, 2014 followed by United Kingdom, China, Afghanistan, Germany and United Arab Emirates. The share of these six countries in total exports for July, 2014 was 49.45% as against their combined share of 52.84% in July, 2013.

IV - Exports by Economic Categories

Export of primary commodities during the current month decreased to Rs.22,490.38 million from Rs. 29,584.28 million by 23.98% over the corresponding month of last year. Its share in total export decreased to 11.85% from 14.06% during this period.

During July, 2014 exports of semi-manufactures amounted to Rs. 24,718.83 million as against Rs. 35,086.48 million during July 2013 showing a decrease of 29.55%. The share of Semi-manufactures in total export decreased to 13.03% in this month from 16.67% in the corresponding month of last year.

Export of manufactured goods during July, 2014 decreased to Rs. 142,547.31 million from Rs. 145,794.59 million during July, 2013 showing a decrease of 2.23%. The share in total export during the month increased to 75.12% from 69.27% during the corresponding month of last year.

Exports by Economic Categories

I – Imports by Group/Commodities

Imports into Pakistan during July, 2014 amounted to Rs. 319,670.13 million as against the imports of Rs. 425,228.93 million in the previous month and Rs. 383,244.90 million during the corresponding month of last year showing a decrease of 24.82% over previous month by 16.59% over the corresponding month of last year.

Comparative figures of imports by group/commodities during July, 2014, June, 2014 and July, 2013 are given in Table-4.

Food Group

During July, 2014 the 5 selected commodities of Food Group contributed 6.51% of total imports in which the share of palm oil and tea were 4.07% and 0.71% respectively.

Machinery & Transport Group

During July, 2014 Machinery & Transport Group contributed 20.03% of total imports in which the share of Machinery and Transport equipment were 16.31% and 3.72% respectively.

Petroleum Group

During July, 2014 Petroleum Group contributed 28.12% of total imports in which the share of Petroleum products and Petroleum crude were 21.02% and 7.10% respectively.

Textile Group

During July, 2014 Textile Group contributed 3.24% of total imports in which the share of Synthetic & artificial silk yarn and Synthetic fibre were 1.89% and 1.34% respectively.

Chemical Group

During July, 2014 Chemical Group contributed 16.60% of total imports in which the share of Chemical (excl. fertilizer, medicines & insecticide) were (13.48%), Medicinal products (1.55%), Fertilizer manufactured (1.26%) and Insecticide (0.31%).

Metal Group

During July, 2014 Metal Group contributed 5.67% of total imports in which the share of Iron & steel and Iron & steel scrap were 3.47% and 2.20% respectively.

Miscellaneous Group



III - Direction of Imports

Imports by Territories/Regions and major countries during July, 2014 compared with July, 2013 are given in table 5 and 6 respectively.

During July, 2014 (9.34%) of total imports were from European Union. The share of imports of Middle East was 32.99% and North America 3.95%. Country-wise, China was at the top of imports list during July, 2014 followed by United Arab Emirates, Kuwait, Saudi Arabia, Indonesia and India. The combined share of these six countries during July, 2014 was 62.27% as against their combined share of 59.39% during July, 2013.
