FOREIGN TRADE STATISTICS

Exports during September , 2011:

Exports from Pakistan during September, 2011 amounting to Rs. 160,629 million (Provisional) as against Rs. 170,111 million (Provisional) in August, 2011 showing a decrease of 5.57%.

In terms of US dollars, the exports from Pakistan during September, 2011 amounting to 1,836 million US \$ (Provisional) as against 1,964 million US \$ (Provisional) in August, 2011 showing a decrease of 6.52%.

Main commodities of exports during August, 2011 were:

Food Group: Rice basmati (Rs.5,472 million or 62,555 thousand US \$), and rice other (Rs. 5,115 million or 58,474 thousand US \$).

Textile Group: Cotton cloth (Rs. 17,388 million or 198,778 thousand US \$), knitwear (Rs.14,594 million or 166,837 thousand US \$), bed wear (Rs.13,449 million or 153,748 thousand US \$), cotton yarn (Rs. 12,120 million or 138,555 thousand US \$) readymade garments (Rs.9,942 million or 113,656 thousand US \$), and towels (Rs.4,913 million or 56,165 thousand US \$).

Petroleum Group & Coal: Petroleum products (excl. top naphta) (Rs. 4,962 million or 56,725 thousand US \$) and petroleum top naphta (Rs. 4,657 million or 53,238 thousand US \$).

Exports during July - September , 2011:

Exports during July-September, 2011 totalled Rs. 520,248 million (Provisional) as against Rs. 433,038 million during the corresponding period of last year showing an increase of 20.14%.

In terms of US dollars, the exports during July-September, 2011 totalled \$ 6,003 million (Provisional) as against \$ 5,058 million during the corresponding period of last year showing an increase of 18.68%.

Imports during September, 2011:

Imports into Pakistan during September, 2011 amounting to Rs. 316,797 million (Provisional) as against Rs. 329,704 million (Provisional) in August, 2011 showing a decrease of 3.91%.

In terms of US dollars, the imports into Pakistan during September, 2011 amounting to 3,622 million US \$ (Provisional) as against 3,806 million US \$ (Provisional) in August, 2011 showing a decrease of 4.83%.

Main commodities of imports during August, 2011 were:

Food Group: Palm oil (Rs. 16,379 million or 187,243 thousand US\$).

Machinery Group: Power generating machinery (Rs. 5,268 million or 60,223 thousand US \$), telecom (mobile phone) (Rs.5,161 million or 59,000 thousand US \$) and other apparatus (Rs.4,579 million or 52,347 thousand US \$).

Petroleum Group: Petroleum products (Rs.68,972 million or 788,482 thousand US \$) and petroleum crude (Rs.39,833 million or 455,367 thousand US \$).

Textile Group: Synthetic & artificial silk yarn (Rs. 5,214 million or 59,606 thousand US \$).

Agricultural and Other Chemicals Group: Plastic materials (Rs. 11,864 million or 135,628 thousand US \$) and fertilizer manufactured (Rs. 6,059 million or 69,266 thousand US \$).

Metal Group: Iron and steel (Rs. 10,465 million or 119,635 thousand US\$).

Imports during July - September , 2011:

Imports during July-September, 2011 totalled Rs. 963,841 million (Provisional) as against Rs. 773,076 million during the corresponding period of last year showing an increase of 24.68%.

In terms of US dollars, the imports during July-September, 2011 totalled \$ 11,117 million (Provisional) as against \$ 9,029 million during the corresponding period of last year showing an increase of 23.13%.

Balance of Trade:

Based on the provisional figures of imports and exports, the balance of trade in September, 2011 was (-)156,168 million in terms of Rupees and (-)1,786 million in US dollars. The balance of trade figures cumulative from July-September, 2011 were (-)443,593 million in terms of Rupees and (-)5,114 million in US dollars.



PRICE INDICES AND ANALYSIS

Consumer Price Index, October, 2011:

The Consumer Price Index for October, 2011 with 2000-01 base stood at 160.79 showing an increase of 1.44% over the Index for September, 2011 which showed an increase of 10.96% as compared to October, 2010.

The main commodities which showed an increase in their prices during Octomber, 2011 over Setember, 2011 are as under:

Food & Non-Alcoholic Beverages: Tomatoes (75.00%), onion (25.84%), fresh vegetable (6.59%), gur (3.42%), fish (3.29%), fresh fruits (2.93%), beans (2.42%), gram whole (2.25%), wheat product (1.94%), bakery & confectionery (1.33%), milk powder (1.28%), mustard oil (1.22%), cereals (1.11%), spices & pulse moong (1.08% each), pulse mash washed (1.02%), meat (1.00%) and sweet meet (0.98%).

Clothing & Footwear: Hosiery (3.82%), woolen cloth (3.79%), cleaning & laundering (3.16%), tailoring (1.54%), cotton cloth (1.26%) and dopatta (1.14%).

Household, Water, Electricity, Gas & Other Fuel: Fire wood whole (3.34%), house rent (2.13%) and construction input items (1.34%).

Furnished Household Equipment & Maintenance etc: Household servant (7.86%), washing soap & detergent (2.53%), plastic products (2.08%), household textile (2.07%), marriage hall charges (1.71%), furniture (1.46%) and sewing needle & dry cell (1.01%).

Health: Dr. (MBBS) clinic fee (2.35%) and medical test (1.97%).

Transport: Motor fuel (2.44%) and motor vehicle accessories (1.28%).

Recreation & culture: Newspapers (5.59%).

Miscellaneous goods and services: Personal care (3.10%), blades (1.48%) and cosmetics (1.13%).

The main commodities which showed a decrease in their prices during October, 2011 over Setember, 2011 are as under:

Food & Non-Alcoholic Beverages: Sugar (5.29%), chicken (3.64%) and potatoes (2.61%).

Miscellaneous goods and services: Personal equipments (5.65%).

Consumer Price Index, July-October, 2011:

The Consumer Price Index for JulyOctober, 2011 period with 2000-01 base stood at 157.72 showing an increase of 11.34% compared to the corresponding period of last year.

Wholesale Price Index, October, 2011:

The Wholesale Price Index for October, 2011 with 2000-01 base stood at 179.34 showing an increase of 0.37% over the Index for September, 2011 which showed an increase of 15.41% as compared to October, 2010.

The main commodities which showed an increase in their prices during October,2011 over September, 2011 are as under:

Agriculture Forestry & Fishery Products: Vegetables (14.49%), other oil seeds (2.08%), fuel wood in logs (1.83%), fresh fruits (1.62%), raw animal material/wool (1.46%), hides and fur skins, raw (1.29%), cotton seeds (1.13%), dry fruits (1.02%) and milk from boyine animals (1.01%).

Ores & Minerals, Electricity Gas & Water: Salt & pure sodium chloride (2.12%).

Food Products, Beverages and Tobacco, Textiles, Apparel and Leather Products: Nylon yarn (8.86%), blankets (3.78%), other fabrics (3.74%), towels (3.55%), other leather N.E.C. (3.24%), woven fabrics (3.23%), meat of animals (2.69%), dairy products N.E.C. (2.21%), leather without hairs (1.76%), cotton yarn (1.73%), fruit juice (1.11%) and cotton fabrics (1.02%).

Other Transportable Goods Except Metal Products, Machinery and Equipments: Motor sprit (4.90%), fertilizers (4.87%), glass sheets (3.29%), bricks blocks and tiles (3.05%), cement (2.75%), chemicals (2.13%), pesticides (1.84%), soaps & detergent (1.02%) and other glass articles (0.93%).

Metal Product Machinery & Equipment: Motor vehicles (4.25%), steel products (2.68%), lighting equipments (1.60%), bicycles (1.27%) and electrical wires (1.03%).

The main commodities which showed a decrease in their prices during October, 2011 over September, 2011 are as under:

Agriculture Forestry & Fishery Products: Fiber crops (5.27%), poultry (5.22%), maize (3.23%), edible roots/potatoes (2.83%), millet/bajra (2.12%), stimulant & spice crops (1.56%), sorghum/jowar (1.20%) and fishes live fresh or chilled (0.98%).

Food Products, Beverages and Tobacco, Textiles, Apparel and Leather Products: Sugar refined (7.41%), milk & cream in solid form (2.99%), chocolate (1.18%), other cereals flour (1.05%) and ready made garments (0.91%).

Other Transportable Goods Except Metal Products, Machinery and Equipments: Furnace oil (3.56%).

Wholesale Price Index, July-October, 2011:

The Wholesale Price Index for July-October, 2011 period with base 2000-01 stood at 178.38 showing an increase of 17.80% compared to the corresponding period of last year.



BRIEF ONGOING ACTIVITIES OF POPULATION CENSUS ORGANIZATION

Meeting:

- A review meting under the Chairmanship of Secretary, Statistics Division with Provincial Census Commissioner, Senior Officers of Federal Bureau of Statistics, Population Census Organization, Agricultural Census Organization and Statistics Division was held on 20th October, 2011 at Envoy Continental Hotel, Islamabad.
 - Preparatory work for conducting 6th Population and Housing Census including formation of coordination committees/vigilance teams establishment of control rooms as well as requirements of logistic material for training of field staff and for main census 2011 is in progress.
- Preparatory work for conducting 6th Population and Housing Census including formation of coordination committees/vigilance teams establishment of control rooms as well as requirements of logistic material for training of field staff and for main census 2011 is in progress.
- Review of Data Processing Plan for the 7th Population and Housing Census is under progress.
- 1998 Census household data and estimated household data as on 31st October, 2011 of three districts i.e. Awaran, Panjgur and Khuzdar of Balochistan Province for Benazir Income Support Programme survey has been prepared and supplied to BISP Section.
- Province wise population of Pakistan according to 1998 census and its estimated population as on 2000 and 2010 has been supplied to Government College University, Lahore.
- A soft copy of District Census Reports of Rawalpindi and Islamabad district according to 1998 census has been supplied to Oxford Policy Management, Islamabad.
- The editing coding of Benazir Income Support Programme Forms of district Mastung received from PCO Quota is in progress.

- The field work regarding verification/ updating of block boundaries and collection of GPS points of important features of Rawalpindi Municipal Corporation has been completed.
- After the verification/updating of block boundaries, the work regarding re-writing of Delimitation Forms with the help GPS points of Rawalpindi Municipal Corporation is in progress.
- Digitization of boundaries of the urban charges, circles & blocks of Rawalpindi Municipal Corporation and Islamabad (urban) on the basis of GPS collected data is in progress.
- The work regarding re-writing the block boundaries description on delimitation Forms of 47 circles out of 92 circles with the help GPS points of Rawalpindi Municipal Corporation has been completed.



BRIEF ONGOING ACTIVITIES OF AGRICULTURE CENSUS ORGANIZATION

- Data Punching: The punching of data for Agricultural Census 2010 of Azad Jammu & Kashmir is in progress at DP Centre, Lahore. Rest of the job has been completed for four provinces as well as for Gilgit Baltistan.
- Computer Edit-Correction: The editing and corrections of computer printouts for whole of the Punjab and Sindh provinces has been completed. The same exercise for 21 districts of Khyber Pakhtunkhwa province has also been completed.
- **Data Cleaning:** Computer edit correction and data cleaning are going side by side. The data of 82 districts have been declared error-free.
- **Tabulations:** The tabulations of 30 districts of the Punjab province and 10 districts of Sindh province have been produced and are under the process of quality control.
- Report Writing: The write up portion for census reports has been initiated at ACO office. The same is under the process of improvement at ACO, Lahore.
- Mouza Census 2013: The next Mouza Census in the series is due in 2013. Planning of Mouza Census 2013 has been initiated in ACO, Lahore. As first step, the administrative approval has been solicited from the worthy Secretary, Statistics Division, Islamabad.




