### Analysis of Consumer Price Index (CPI) Base Year (2015-16)

2. The CPI on new base (2015-16) comprises of urban CPI and Rural CPI. The Urban CPI covers 35 cities and 356 consumer items. The Rural CPI covers 27 Rural Centers and 244 consumer items. In the new base year (2015-16) National CPI for 12 major groups is also computed by taking weighted average of Urban CPI and Rural CPI.

#### **MONTHLY ANALYSIS (M.o.M)**

#### March, 2020 over February, 2020

**CPI National** with base year (2015-16) for the month of March, 2020 increased by 0.04% over February 2020. The Urban CPI with base year (2015-16) recorded an increase of 0.13% while Rural CPI with base year (2015-16) recorded a decrease of 0.1%. (Details are in the Monthly Review). CPI with old base year (2007-08) recorded an increase of 0.25%.

**Decreased:** Tomatoes(23.29%), Fish(9.25%), Wheat(8.43%), Fresh vegetables(7.78%), Motor fuel(6.17%), Transport services(5.45%) Pulse gram(5.13%), Pulse masoor(3.39%), Wheat flour (3.17%), Pulse mash(2.33%), Solid Fuel(1.13%) and Sugar(0.54%).

#### **RURAL:**

**Increased:** Onions(40.95%), Fresh fruits(8.04%), Potatoes(6.82%), Beans(3.77%) Footwear(2.93%), Medical Tests(2.7%), Mechanical Services(2.53%), Cotton Cloth(1.88%), Cleaning and Laundering(1.84%), Readymade Garments(1.59%), Construction Wage Rates(1.43%) and Vegetable ghee(1.05%).

**Decreased:** Tomatoes(36.43%), Wheat(7.39%), Motor Fuels(6.69%) Fresh Vegetables(5.64%), Pulse Gram(5.07%), Chicken(4.85%), Pulse Masoor(3.45%), Eggs(3.17%), Transport Services(3.43%), Gram Whole(2.58%), Wheat Flour(2.52%), Pulse Mash(2.05%) and Gur(1.02%).

*Increased:* Onions (107.67%), Garlic (105.80%), Peas (97.85%), Cardamom small (72.68%), Gas charges combined (72.63%), Pulse Moong (59.65%), Ginger (58.37%) and Potatoes (57.46%).

**Decreased:** Gram Whole (5.78%), Cement (4.51%), Lemon (3.72%) and eggs (2.33%).

#### **RURAL**:

*Increased:* Onions (112.12%), Garlic (102.60%), Peas (100.72%), Ginger (64.34%), Pulse Moong (55.40%) and Potatoes (51.46%).

**Decreased:** Lemon (7.65%), Cement (3.66%), Gram Whole (2.58%) and Eggs (2.20%).
