




# **Monthly Review on Price Indices**



**April, 2012

## I. Inflation in Brief

1. CPI inflation, General, increased by 11.3% on year-on-year basis in April 2012 as compared to 10.8% in the previous month and 12.5% in April 2011. On month-on-month basis, it increased by 1.8% in April 2012 as compared to an increase by 1.2% in the previous month and an increase by 1.4% in April 2011.
2. Core inflation measured by non-food non-energy CPI (Core NFNE) increased by 10.8% in April 2012 as well as in March 2012(YoY) and by 9.5 % in April 2011. Core NFNE inflation on MoM basis increased by 1.4% in April 2012 as compared to 1.0% a month earlier and 1.4 %in April 2011.
3. Core inflation, measured by 20% weighted trimmed mean CPI (Core Trimmed) increased by 11.0% in April 2012 and by 10.5% in March 2012 (YoY) which increased by 12.0% in April 2011. Core Trimmed inflation has increased by 1.3% on MoM basis in April 2012 compared with 0.8% in March 2012 which increased by 1.0% in April 2011.
4. SPI inflation on YoY basis increased by 7.5% in April 2012 compared with 6.1% a month earlier and 14.2% in April 2011. On MoM basis, it increased by 1.7% in April 2012 as compared to an increase by 1.5% a month earlier and an increase of 0.3% in April 2011.
5. WPI inflation on YoY basis increased to 3.8% in April 2012 compared with 4.5% a month earlier and 24.9% in April 2011. WPI inflation on MoM basis increased by 1.8% in April 2012 as compared to an increase of 0.7% a month earlier and an increase of 2.5% in April 2011.
6. Figures 1 and 2 show graphically the data of Table 1. Table 1.1 shows “Period Average” and “YoY” percent changes in indices of three years.





The Consumer Price Index of April, 2012 has increased by 1.83% over March, 2012 and increased by 11.27% over corresponding month of last year.

Main contributors to month-on-month and year-on-year percentage changes are given below and detail is given in Annexure A.

1. **Month-on-month** Top few commodities which varied from previous month i.e. March 2012 are given below:-

**Food Items Increased:** Tomatoes (77.01%), Potatoes (21.96%), Chicken (12.14%), Fresh Fruits (10.93%), Besan (4.81%), Fresh Vegetables (4.35%), Cigarettes (3.23%), Cooking Oil (2.79%), Milk Powder (2.50%), Rice (2.20%), Vegetable Ghee (1.95%), Milk Fresh (1.39%), Tea and Beverages (1.32% each), Milk Products (1.26%), Honey (1.20%), Betel Leaves & Nuts (1.15%) and Nimco (1.11%).

**Decreased:** Onion (27.94%), Eggs (22.27%), Pulse Mash Washed (1.72%), Spices (1.25%), Pulse Masoor (0.61) and Pulse Moong (0.56%).

- a. **Non-food Items Increased:** Motor Fuel (7.41%), Education (4.31%), Text Books (4.09%), Kerosene Oil (3.45%), Firewood Whole (3.04%), Cleaning & Laundering (2.88%), Marriage Hall Charges (2.54%), Transport Services (2.50%), Cotton Cloth (2.35%), Utensils (2.24%), Readymade Garment (2.03%), Washing Soap & Detergents (1.68%), Dopatta (1.58%) and Sewing Needle & Dry Cell (1.51%).
- Decreased:** Personal Equipments (1.18%).

2. **Year-on-year** Top ten commodities which varied from previous year i.e. April 2011 are given below:-

- a. **Food Items Increased:** Tomatoes (62.31%), Pulse Gram (35.54%), Gram Whole (32.55%), Besan (30.78%), Condiments (25.56%), Chicken (22.58%), Milk Powder (18.69%), Milk Products (18.18%), Spices (17.99%) and Onion (17.96%).  
**Decreased:** Sugar (15.88%), Pulse Masoor (13.35%), Gur (11.62%), Pulse Moong (11.44%) and Pulse Mash (Washed) (11.15%).
- b. **Non-food Items Increased:** Motor Vehicle Tax (52.02%), Household Servant (32.68%), Firewood Whole (29.49%), Gas (29.41%), Motor Fuel (28.87%), Woolen Cloth (23.63%), Dopatta (22.07%), Mechanical Service (21.24%), Motor Vehicle Accessories (20.75%) and Washing Soaps & Detergents (20.13%).  
**Decreased:** None.


### III. Sensitive Price Indicator

#### IV. Wholesale Price Index

The Wholesale Price Index for April 2012 increased by 1.80% over March 2012. It increased by 3.81% over the corresponding month of the last year. YoY and MoM movements, from March 2011 to April 2012 are also graphed below in Figure 4.

1. **Month-on-month** Top few commodities which varied from previous month i.e. March 2012 are given below:-


**Increased:** Fresh Fruits (37.70%), Vegetables (13.13%), Poultry (9.54%), Edible Roots/Potatoes (9.48%), Motor Spirit (5.84%), Cement (5.51%), Diesel Oil (4.76%), Coal not Agglomerated (4.54%), Ice Cream (4.38%), Paint and Varnish (4.27%) and Cotton Yarn (4.06%).

**Decreased:** Egg (29.08%), Stimulant and Spice Crops (2.12%), Cotton seeds (1.61%), Oil Cakes (1.34%), Dried Fruits and Nuts (1.24%), Chemicals (1.23%) and Dry Fruits (0.77%).

2. **Year-on-year** Top ten commodities which varied from previous year i.e. April 2011 are given below:-

**Increased:** Spices (52.14%), Coal not Agglomerated (43.75%), Fresh Fruits (43.73%), Hard Board (38.18%), Vegetables (35.12%), Fish Live Fresh or Chilled (33.82%), Other Cereal Flour (33.00%), Natural Gas Liquid (32.50%), Fertilizers (29.90%), Dairy Products n.e.c (27.99%), Footwears (26.63%), Paints and Varnishes (25.20%), Towels (25.15%) and Mineral Water (25.02%).

**Decreased:** Fiber Crops (50.90%), Cotton Yarn (29.26%), Stimulant and Spice Crops (20.39%), Oil Cakes (16.77%), Sugar Refined (16.43%), Blended Yarn (15.23%), Edible Roots and Potatoes (11.91%), Milk and Cream in Solid Form (10.02%), Sugar Crops (9.67%) and Insecticides (7.57%).
