

I. Inflation in Brief

1. CPI inflation, General, increased by 11.0% on year-on-year basis in February 2012 as compared to 10.1% in the previous month and 12.8 % in February 2011. On month-on-month basis, it increased by 0.3% in February 2012 as compared to an increase by 1.5% in the previous month and decrease by 0.6% in February 2011.
2. Core inflation measured by non-food non-energy CPI (Core NFNE) increased by 10.6% in February 2012 as compared to an increase of 10.2% in January 2012(YoY) and by 9.7 % in February 2011. Core NFNE inflation on MoM basis increased by 0.7% in February 2012 as compared to 1.1% a month earlier and 0.4 %in February 2011.
3. Core inflation, measured by 20% weighted trimmed mean CPI (Core Trimmed) increased by 10.7% in February 2012 and by 10.4% in January 2012 (YoY) which increased by 12.0% in February 2011. Core Trimmed inflation has increased by 0.5% on MoM basis in February 2012 compared with 0.8% in January 2012 which increased by 0.4% in February 2011.
4. SPI inflation on YoY basis increased by 5.2% in February 2012 compared with 3.9% a month earlier and 15.3% in February 2011. On MoM basis, it decreased by 0.1% in February 2012 as compared to an increase by 1.0% a month earlier and a decrease of 1.3% in February 2011.
5. WPI inflation on YoY basis increased to 7.2% in February 2012 compared with 8.7% a month earlier and 22.1% in February 2011. WPI inflation on MoM basis increased by 0.6% in February 2012 as compared to an increase of 2.3% a month earlier and an increase of 2.0% in February 2011.





Figure 2: CPI Inflation MoM, Special Indices

6. Figures 1 and 2 show graphically the data of Table 1. Table 1.1 shows “Period Average” and “YoY” percent changes in indices of three years.

Figure 1: CPI Inflation YoY, Special Indices

The Consumer Price Index of February, 2012 has increased by 0.30% over January, 2012 and increased by 11.05% over corresponding month of last year.

Main contributors to month-on-month and year-on-year percentage changes are given below and detail is given in Annexure A.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January 2012 are given below:-
 - a. **Food Items Increased:** Chicken (3.32%), Condiments (3.11%), Fish (2.75%), Nimco (2.56%), Beans (2.44%), Readymade Food (1.94%), Honey (1.69%), Dry Fruits (1.46%), Cereals (1.37%), Tea (1.17%), Besan (1.14%) and Bakery & Confectionary (1.12%).
Decreased: Eggs (12.23%), Fresh Vegetables (9.56%), Onions (8.08%), Tomatoes (4.67%), Fresh Fruits (4.15%), Gur (3.93%), Sugar (3.72%), Pulse Moong (2.69%), Potatoes (1.91%) and Pulse Mash (Washed) (1.63%).
 - b. **Non-food Items Increased:** Motor Fuel (7.26%), Motor Vehicle Tax (5.73%), Firewood Whole (5.55%), Woolen Readymade Garments (5.07%), Kerosene Oil (3.71%), Mechanical Service (3.40%) and Personal Equipments (3.36%).
Decreased: Cotton Cloth (2.24%).
2. **Year-on-year** Top ten commodities which varied from previous year i.e. February 2011 are given below:-

- a. **Food Items Increased:** Eggs (39.02%), Onions (37.74%), Condiments (30.94%), Spices (24.04%), Gram Whole (23.18%), Fresh Fruits (23.14%), Chicken (19.98%), Milk Products (19.96%), Tomatoes (18.67%) and Milk Fresh (18.55%).
Decreased: Sugar (24.81%), Gur (14.20%), Pulse Moong (12.21%), Pulse Masoor (11.34%), Pulse Mash (Washed) (10.51%), Potatoes (3.08%) and Pulse Gram (1.77%).
- b. **Non-food Items Increased:** Household Servant (37.37%), Kerosene Oil (30.76%), Gas (29.41%), Firewood Whole (29.36%), Motor Fuel (29.19%), Personal Equipments (27.30%), Motor Vehicle Tax (26.33%), Blades (25.20%), Woolen Cloth (24.55%) and Medical Equipments (24.24%).
Decreased: None.


III. Sensitive Price Indicator

IV. Wholesale Price Index

The Wholesale Price Index for February 2012 increased by 0.56% over January 2012. It increased by 7.21% over the corresponding month of the last year. YoY and MoM movements, from January 2011 to February 2012 are also graphed below in Figure 4.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January 2012 are given below:-

Increased: Coal not Agglomerated (16.67%), Fresh Fruits (6.22%), Motor Sprit (6.00%), Ceramics & Sanitary Fixture (5.14%), Diesel Oil (4.29%), Fuel, Wood in logs (3.44%), Poultry (3.27%), Towels (3.18%), Kerosene Oil (3.12%), Timber (2.86%), Cotton Yarn (2.78%), Hard Board (2.78%), Other Glass Articles (2.75%), Printing Paper (2.71%), Sorghum/Jowar (2.68%), Salt & Pure Sodium Chloride (2.61%) and Fish Live Fresh or Chilled (2.28%).


Decreased: Vegetables (14.65%), Eggs (14.43%), Cotton Seeds (7.59%), Sugar Refined (5.25%), Tractors (4.72%), Edible Roots/Potatoes (4.34%), Insecticides (3.47%), Sugar Crops (3.44%) and Oil Cakes (3.38%).

2. **Year-on-year** Top few commodities which varied from previous year i.e. February 2011 are given below:-

Increased: Eggs (55.16%), Fertilizers (51.49%), Spices (50.55%), Plastic Products (37.94%), Dairy Products n.e.c (34.90%), Other Food Products (34.56%), Hard Board (34.55%), Woven Fabrics (34.24%), Diesel Oil (33.91%) and Natural Gas Liquified (LPG) (33.56%).

Decreased: Fiber Crops (46.48%), Cotton Yarn (26.18%), Sugar Refined (22.94%), Milk and Cream in Solid Form (20.65%), Edible Roots/Potatoes (13.10%), Blended Yarn (11.72%), Stimulant and Spice Crops (10.21%), Sorghum/Jowar (7.36%), Sugar Crops (6.66%) and Tobacco Products (6.26%).
