Inflation in Brief

1. CPI inflation, General, increased by 3.2% on year-on-year basis in February 2015 as compared to 3.9% in the previous month and by 7.9% in February 2014. On month-on-month basis, it decreased by 0.9% in February 2015 as compared to increase of 0.1% in the previous month and decrease of 0.3% in February 2014.
2. Core inflation measured by non-food non-energy CPI (Core NFNE) increased by 6.2% on (YoY) basis in February 2015 as compared to 6.4% in the previous month and by 7.8% in February 2014. On (MoM) basis, it shows no change in February 2015 as compared to increase of 0.7% in the previous month and 0.2% in February 2014.
3. Core inflation, measured by 20% weighted trimmed mean CPI (Core Trimmed) increased by 4.2% on (YoY) basis in February 2015 as compared to 4.8% in the previous month and by 8.1% in February 2014. On (MoM) basis, it decreased by 0.2 in February 2015 as compared to increase of 0.3% in the previous month and an increase of 0.2% in February 2014.
4. SPI inflation on YoY basis increased by 0.2% in February 2015 as compared to 1.1% a month earlier and of 7.5% in February 2014. On MoM basis, it is decreased by 1.0 in February 2015 as compared to decrease of 0.9% a month earlier and decrease of 0.1% in February 2014.
5. WPI inflation on YoY basis decreased by 3.4% in February 2015 as compared to decrease of 2.4% a month earlier and an increase of 7.6% in February 2014. WPI inflation on MoM basis decreased by 1.1% in February 2015 as compared to decrease of 1.0% a month earlier and decrease of 0.1% in February 2014.
6. Figures 1 and 2 show graphically the data of Table 1. Table 1.1 shows “Period Average” and “YoY” percent changes in indices of three years.



The Consumer Price Index of February, 2015 has decreased by 0.92 over January, 2015 and increased by 3.24% over corresponding month of the last year, i.e. February 2014.

Main contributors to month-on-month and year-on-year percentage changes are given below and detail is given in Annexure A.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January 2015 are given below:-

Food Items Increased: Tea (0.75%), Tomatoes & Besan (0.68% each), sugar (0.67%) and Pulse Mash (0.60%).

Decreased: Chicken (17.95%), Potatoes (17.00%), Eggs (13.86%), Fresh Vegetables (11.40%), Onions (5.89%), Fresh Fruits (2.09%), Rice (2.02%), Fish (1.80%), Wheat Product (1.58%) and Vegetable Ghee (1.37%).

Non-food Items Increased: Personal Equipment (1.28%) and Construction Wage Rates (1.07%).

Decreased: Kerosene Oil (8.32%), Motor Fuel (6.73%) and Transport Services (1.98%).

2. **Year-on-Year:** Top few commodities which varied from previous year i.e. February 2014 are given below:-

Food Items Increased: Tomatoes (57.80%), Cigarettes (20.39%), Pulse Moong (19.65%), Pulse Mash (18.49%) and Fresh Fruits (13.42%).

Decreased: Onions (30.65%), Potatoes (15.71%), Chicken (12.83%) and Wheat (11.96%).

Non-food Items Increased: Motor Vehicle Tax (36.71%), Education (14.20%), Cotton Cloths (12.25%), Tailoring (10.95%) and Woolen Readymade Garments (10.25%).

Decreased: Kerosene Oil (29.69%) and Motor Fuel (24.11%).


III. Sensitive Price Indicator

IV. Wholesale Price Index

The Wholesale Price Index for February 2015 is decreased by 1.09% over January 2015. It is decreased by 3.36% over the corresponding month of the last year. YoY and MoM movements, from January 2014 to February 2015 are also graphed below in Figure 4.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January, 2015 are given below:-

Increased: Cotton seeds (4.48%), Processed liquid milk (2.88%), Fresh Fruits (2.83%), Coffee & Tea (2.69%), Silk and Rayon Fabrics (1.47%), Maize (1.44%), Other Fabrics (1.15%), Fuel Wood in Logs (1.11%) and Glass Sheets (1.05%).


Decreased: Poultry (22.27%), Potatoes (18.79%), Eggs (16.30%), Kerosene Oil (14.60%), Diesel Oil (10.47%), Motor Spirit (10.22%), Insecticides (9.78%), Vegetables (9.33%), Stimulant & Spice Crops (6.64%).

2. **Year-on-year** Top few commodities which varied from previous year i.e. February, 2014 are given below:-

Increased: Dyeing Material (36.26%), Pesticides (28.71%), Leather without Hair (28.21%), Readymade Garments (21.98%), Tobacco Products (19.85%), Processed Liquid Milk (19.60%) Fish (17.93%), Other Fabrics (17.21%) and Woolen Carpets (16.23%).

Decreased: Furnace Oil (47.55%), Kerosene Oil (37.87%), Motor Spirit (37.69%), Diesel (37.37%), Potatoes (28.96%), Fiber Crops (28.23%) and Cotton Yarn (21.57%).
