

Inflation in Brief

1. CPI inflation, General increased by 4.0% on year-on-year basis in February 2016 as compared to an increase 3.3% in the previous month and 3.2% in February 2015. On month-on-month basis, it decreased by 0.3% in February 2016 as compared to increase of 0.2% in the previous month and decrease of 0.9% in February 2015.
2. Core inflation measured by non-food non-energy CPI (Core NFNE) increased by 4.5% on (YoY) basis in February 2016 as compared to increase 4.3% in the previous month and 6.2% in February 2015. On (MoM) basis, it increased by 0.2% in February 2016 as compared to increase of 0.9% in the previous month and 0.0% in February 2015.
3. Core inflation, measured by 20% weighted trimmed mean CPI (Core Trimmed) increased by 3.6% on (YoY) basis in February 2016 as compared to 3.0% in the previous month and by 4.2% in February 2015. On (MoM) basis, it increased by 0.1% in February 2016 as compared to increase of 0.6% in the previous month and decrease of 0.2% in February 2015.
4. SPI inflation on YoY increased by 3.6% in February 2016 as compared to increase of 3.1% a month earlier and an increase of 0.2% in February 2015. On MoM basis, it decreased by 0.5% in February 2016 as compared to a decrease of 0.7% a month earlier and decrease of 1.0% in February 2015.
5. WPI inflation on YoY basis increased by 0.6% in February 2016 as compared to increase of 0.1% a month earlier and a decrease of 3.4% in February 2015. WPI inflation on MoM basis decreased by 0.6% in February 2016 as compared to decrease of 0.5% a month earlier and decrease of 1.1% in February 2015.





Figure 2: CPI Inflation MoM, Special Indices

6. Figures 1 and 2 show graphically the data of Table 1. Table 1.1 shows “Period Average” and “YoY” percent changes in indices of three years.

Figure 1: CPI Inflation YoY, Special Indices

The Consumer Price Index of February , 2016 has decreased by 0.25% over January, 2016 and increased by 4.02% over corresponding month of the last year, i.e. February 2015.

Main contributors to month-on-month and year-on-year percentage changes are given below and detail is given in Annexure A.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January 2016 are given below:-

Food Items Increased: Sugar (4.33).

Decreased: Chicken (19.58%), Potatoes (11.84%), Onion (7.55%), Tomatoes (7.06%), Fish (3.08%), Besan (2.84%), Wheat product (1.54%), Eggs (1.54%), Pulse Gram (1.50%), and Pulse Moong (1.06%).

Non-food Items Increased: Water Supply (5.06%), Personal Equipments (2.33%), Medical Tests (2.26%), Household Servants (2.12%), Doctor (MBBS) Clinic Fee (1.39%), Stationery (1.39%) and Drugs & Medicines (1.38%).

Decreased: Kerosene Oil (7.02%), Motor Fuel (4.22%), Motor Vehicle Accessories (3.01%), Woolen Readymade Garments (2.29%), and Transport Services (1.38%).

2. **Year-on-Year:** Top few commodities which varied from previous year i.e. February 2015 are given below:-

Food Items Increased: Onion (76.92%), Pulse Mash (52.80%), Pulse Gram (49.68%), Besan (44.71%), Tea (30.14%), Cigarettes (26.80%), Gram Whole (23.37%), Sugar (14.68%) and Betel Leaves and Nuts (11.25%).

Decreased: Tomatoes (32.96%), Potatoes (24.69%), Rice (14.16%), Cooking Oil (13.84%), Chicken (10.98%) and Vegetable Ghee (9.18%).


Non-food Items Increased: Sewing Needle & Dry Cell (10.42%), Gas (9.92%), Education (9.22%), Tailoring (8.93%), Construction Wage Rates (7.82%), Household Servants (7.66%), Woolen Readymade Garments (7.65%) and Water Supply (7.46%).

Decreased: Kerosene Oil (8.85%) and Motor Vehicle Accessories (4.02%).

III. Sensitive Price Indicator

Quintile-wise percentage changes YoY and MoM are given below in Table 3. The series from January 2015 to February 2016 is also graphed below in Figure 3.

IV. Wholesale Price Index

The Wholesale Price Index for February 2016 is decreased by 0.59% over January, 2016. It is increased by 0.58% over the corresponding month of the last year. YoY and MoM movements, from January, 2015 to February 2016 are also graphed below in Figure 4.

1. **Month-on-month** Top few commodities which varied from previous month i.e. January, 2016 are given below:-

Increased: Fresh fruits (8.21%), Bed foam (6.68%), Sugar (5.68%), Medicine (4.28%), Maize (4.21%), Vegetables (3.17%), Soap & Detergent (1.25%) and Dairy products (1.13%)


Decreased: Poultry (23.21%), Potatoes (21.22%), Kerosene oil (10.39%), Coal (9.19%), Diesel oil (8.15%), Motor spirit (6.58%) and Furnace oil (4.06%).

2. **Year-on-year** Top few commodities which varied from previous year i.e. February, 2015 are given below:-

Increased: Other Cereal Flour (52.44%), Coffee & Tea (34.33%), Tobacco Products (33.31%), Woolen carpets (26.13%), Cotton Seeds (23.84%), Fish (16.81%), Pulses (16.79%), Sugar (16.49%), Sugar Confectionary (16.18%), Matches (13.56%) and Vegetables (13.19%).

Decreased: Furnace oil (49.56%), Kerosene oil (35.67%), Potatoes (26.86%), Coal (21.93%), Diesel oil (18.39%), Rice (15.07%), Stimulant & Spice Crops (13.78%) and Steel bars & sheets (12.71%).
