2. Detail Description

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In October, 2018 the CPI increased by 2.56%, WPI increased by 4.17% while SPI increased by 1.19% respectively.

Decreased:

Bananas (9.11%), Lady Finger (5.58%), Onion (4.43%), Spinach (3.30%), Milk Tetra Pack (1.71%), LPG Cylinder ((1.60%), Fish-Rahu (1.37%), Gram Whole (1.31%), Pulse Mash (1.18%) and Kerosene Oil (0.21%).

Decreased:

Onion (55.97%), Tomatoes (28.75%), Garlic (27.92%), Potatoes (21.25%), Pulse Mash (19.66%), Gram Whole Yellow (15.51%), Pulse Masoor (8.17%), Cucumber (7.72%), Pulse Masoor Whole (7.43%), Spinach (6.72%), Pulse Moong (5.80%), Besan (4.86%), Apple (4.02%) and Pulse Gram (3.28%).

Increased: Betel Leaves & Nuts (149.61%), Kerosene Oil (36.11%), Gas (26.23%), Motor Fuel (25.99%), Newspapers (15.23%), Transport Services (15.21%), Education (13.13%), Motor Vehicles (11.28%), Water Supply (11.27%), Meat (11.01%), Dry Fruits (10.70%), Spices (10.60%), Construction Input Items (9.96%), Personal Equipment (9.68%) and Doctor (MBBS) Clinic Fee (9.65%).

Decreased: Onion (35.90%), Pulse Mash (23.31%), Potatoes (20.20%), Pulse Masoor (9.53%), Pulse Moong (8.38%), Gram Whole (8.33%), Pulse Gram (5.62%), Besan (5.26%) and Sugar (2.45%).

Trimmed Core Inflation

During the month of October, 2018 over October, 2017, the Year on Year increase in the Trimmed Core Inflation was observed at 6.7% whereas it was 4.0% during October. 2017 over October, 2016.

Non-Food & Non-Energy Core Inflation

During the month of October, 2018 over October, 2017, the Year on Year increase in the Non-food & Non-energy Core Inflation has been observed as 8.2% whereas it was 5.3% during October, 2017 over October, 2016.
