2. Detail Description:

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In September, 2013 the CPI decreased by 0.29% while SPI and WPI increased by 0.07% and 0.71% over September, 2013 respectively.

Main contributors to month-on-month and year-on-year are given below:

- i) Month-on-month Top few commodities which varied from previous month i.e. Sep, 2013 over Aug, 2013 are given below:
 - **a.** Food Items Increased: Eggs (13.20%), Fresh Vegetables (4.79%), Potatoes (4.53%), Bakery & Confectionary (2.98%), Wheat (2.93%), Wheat Flour (2.80%), Readymade Food (2.48%), Wheat Products (2.37%), Milk Powder (2.03%) and Gur (1.69%).

Decreased: Chicken (24.50%), Tomatoes (23.60%), Onions (15.63%), Fresh Fruits (15.48%), Pulse Gram (3.20%), Gram Whole (2.29%), Pulse Moong (1.22%), Besan (1.19%), Beverages (0.80%), Spices (0.72%), Sugar (0.33%) and Vegetable Ghee (0.12%).

b. Non-food Items Increased: Water Supply (3.02%), Motor Fuel (2.93%), Kerosene Oil (2.92%), Doctor (MBBS) Clinic Fee (2.52%), Personal Equipments (2.42%), Firewood Whole (1.90%), Transport Services (1.71%).

- **Year-on-year** Top few commodities which varied from corresponding month of previous year i.e. Sep, 2013 over Sep, 2012 are given below:
 - **a.** <u>Food Items</u> <u>Increased:</u> Tomatoes (29.36%), Onions (26.13%), Tea (25.97%), Wheat (24.31%), Wheat Flour (23.56%), Gur (23.16%), Wheat Products (17.68%), Potatoes (14.95%), Cigarettes (14.58%), Cereals (12.79%), Chicken (12.56%), Beans (12.42%) and Rice (12.30%).

Decreased: Pulse Gram (31.06%), Besan (26.91%), Gram Whole (22.62%), Spices (19.19%), Fresh Fruits (7.08%), Vegetable Ghee (5.03%), Pulse Mash (3.44%), Cooking Oil (2.22%) and Mustard Oil (1.71%).

b. Non-food Items Increased: Postal Services (25.93%), Footwear (18.56%), Woolen Readymade Garments (18.05%), Text Books (15.92%), Cotton Cloth (15.72%), Tailoring (15.46%), Dopatta (14.28%), Cosmetics (14.16%) and Cleaning & Laundry (13.76%).

Decreased: Motor Fuel (5.43%).

The Consumer Price Index of July- Sep, 2012-13 has increased by 8.06% over July-Sep, 2011-12 as per details given below:-

The items that witnessed significant rise in their prices include Tomatoes (80.26%), Onions (50.74%), Postal Services (25.96%), Tea (25.44%), Wheat Flour (24.67%), Wheat (24.52%), Gur (21.02%), Woolen Readymade Garments (18.72%), Footwear (18.62%), Wheat Products (18.32%), Fresh Vegetables (17.58%) and Tailoring (15.75%).

3. Core inflation of CPI

i. Trimmed Core Inflation

During the month of Sep, 2013 over Sep, 2012, the trimmed core inflation has been observed as 7.6%, while it was 10.4% during Sep, 2012 over Sep, 2011.

ii. Non-Food & Non-Energy Core Inflation

During the month of Sep, 2013 over Sep, 2012, the Non-food & Non-energy core inflation has been observed as 8.7%, while it was 10.4% during Sep, 2012 over Sep, 2011.
