2. Detail Description:

Pakistan Bureau of Statistics collects the retail and the wholesale prices and computes the Consumer Price Index (CPI), Wholesale Price Index (WPI) on monthly basis and Sensitive Price Indicator (SPI) on weekly basis. In May, 2017 the CPI increased by 0.01%, WPI decreased by 0.20% while SPI decreased by 0.89% respectively.

Increased: Lemon (23.62%), Cucumber (22.80%), Potatoes (19.88%), Apple (14.93%), Ice (9.93%), Cinnamon (5.45%), kinnu (5.09%), Car Suzuki (3.69%), Bananas (2.76%), Pulse Gram (2.35%), Gram Whole (2.35%), Rice (2.19%) and Pulse Mash (1.24%).

Decreased: Tinda (49.42%), Tomatoes (40.03%) Bottle Gourd (30.23%), Watermelon (16.85%), Garlic (11.62), Onion (10.67%), Muskmelon (8.50%), Chicken (7.73%), Gas Cylinder (6.85%), Wheat (5.35%), Sugar (2.29%) and Wheat flour (1.24%).

Year-on-Year: Top few items which varied from previous year i.e. May 2016 are given below:-

Increased: : Potatoes (70.09%), Tomatoes (59.28%), Dettol (47.98%), Cucumber (43.05%), Muskmelon (37.28%), Apple (28.19%), Mango Kalmi (26.03%), Watermelon (24.45%), Tea Lipton Yellow label (24.13%) and Gram Whole (21.42%).

Decreased: Pulse Mash (24.48%), Pulse Moong (17.98%), Pulse Masoor (14.56%), Onion (9.58%), Cardamom Large(8.70%), Chicken (7.40%), Sugar (6.82%), Chilies powder (5.45%), and Pulse Gram (5.32%).

Top few commodities which varied from previous year average i.e. July-May, 2015-2016 are given below:-

Increased: Gram Whole (36.11%), Potatoes (32.71%), Pulse Gram (26.02%), Besan (25.10%), Fresh Vegetables (17.55%), Cigarettes (14.32%), Drugs & Medicines (13.38%), Eggs (12.35%) and Education (10.63%).

Decreased: Onion (34.46%), Pulse Moong (10.22%), Motor Vehicle Accessories (4.76%), Chicken (3.85%), Kerosene Oil (3.70%) and Motor Fuel (2.99%).

Core inflation of CPI

i. Trimmed Core Inflation

During the month of May, 2017 over May, 2016 the trimmed core inflation has been observed as 4.8% while it was 3.6% during May, 2016 over May, 2015.

ii. Non-Food & Non-Energy Core Inflation

During the month of May, 2017 over May, 2016 the Non-food & Non-energy core inflation has been observed as 5.5% while it was 4.6% during May, 2016 over May, 2015.
