## **TRADE SUMMARY**

April-June, 2025

### **EXPORTS**

The total exports of Pakistan during Apr-Jun, 2025 amounted to Rs. 2,063,672.37 million showing a decrease of 7.01% over Jan-Mar, 2025 and decreased by 4.59% over Apr-Jun, 2024. In terms of US dollar, the export during Apr-Jun, 2025 amounted to \$ 7,322.28 million showing a decrease of 7.80% over Jan-Mar, 2025 and showing a decrease of 5.50% over Apr-Jun, 2024.

Export during Jul-Jun, 2025 totaled Rs. 8,947,880.50 million showing an increase of 3.16% over the corresponding period of last year. While in terms of US dollars, exports stand at \$ 32,040.39 million showing an increase of 4.45% over the corresponding period of last year.

### **IMPORTS**

The total imports of Pakistan during Apr-Jun, 2025 amounted to Rs. 4,418,228.79 million showing an increase of 13.63% over Jan-Mar, 2025 and increased by 7.82% over Apr-Jun, 2024. In terms of US dollar, the imports during Apr-Jun, 2025 amounted to \$ 15,682.00 million showing an increase of 12.69% over Jan-Mar, 2025 and increased by 6.50% over Apr-Jun, 2024.

Import during Jul-Jun, 2025 totaled Rs. 16,306,752.75 million showing an increase of 5.33% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$ 58,363.04 million showing an increase of 6.54% over the corresponding period of last year.

### **TOTAL TRADE**

The total trade of Pakistan during Apr-Jun, 2025 amounted to Rs. 6,481,901.15 million showing an increase of 6.13% over Jan-Mar, 2025 and increased by 3.65% over Apr-Jun, 2024. In terms of US dollar, the total trade during Apr-Jun, 2025 amounted to \$ 23,004.28 million showing a decrease of 6.13% over Jan-Mar, 2025 and increased by 3.65% over Apr-Jun, 2024.

Total trade during Jul-Jun, 2025 totaled Rs. 25,254,633.25 million showing an increase of 4.55% over the corresponding period of last year. In terms of US dollars, total trade stands at \$ 90,403.43 million showing an increase of 5.79%.

### **BALANCE OF TRADE**

Balance of trade in Apr-Jun, 2025 was unfavorable to Pakistan to the tune of Rs. 2,354,556.42 million equivalents to US \$ 8,359.73 million, whereas during the period of Jul-Jun, 2025 it was unfavorable to the tune of Rs. 7,358,872.25 million rupees equivalent to US \$26,322.65 million.

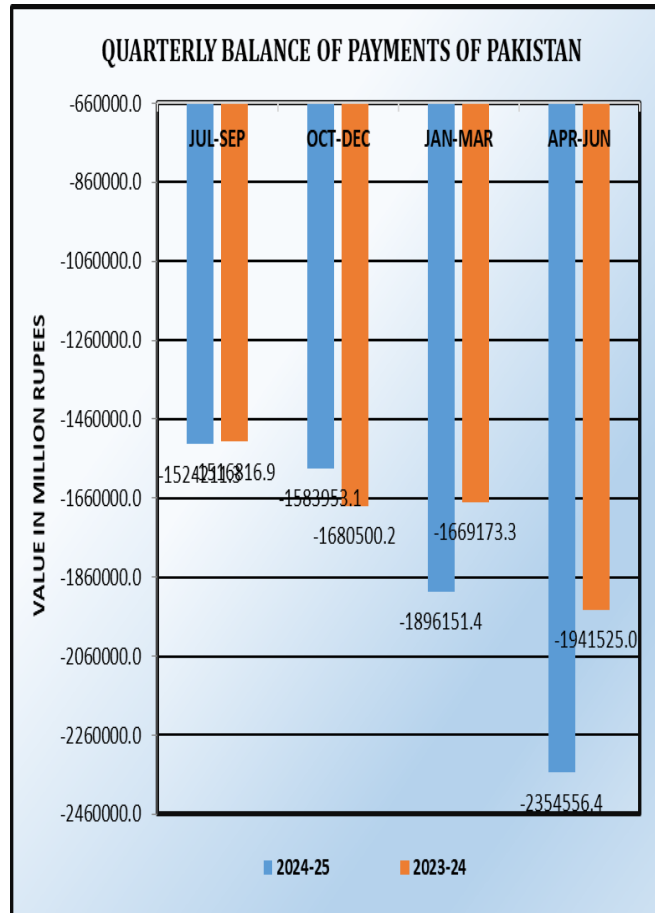
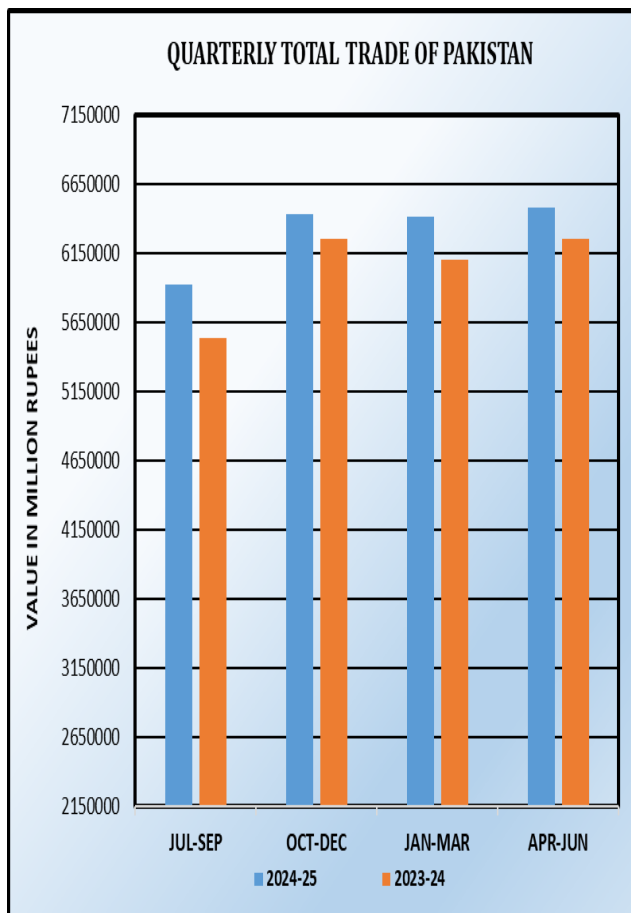
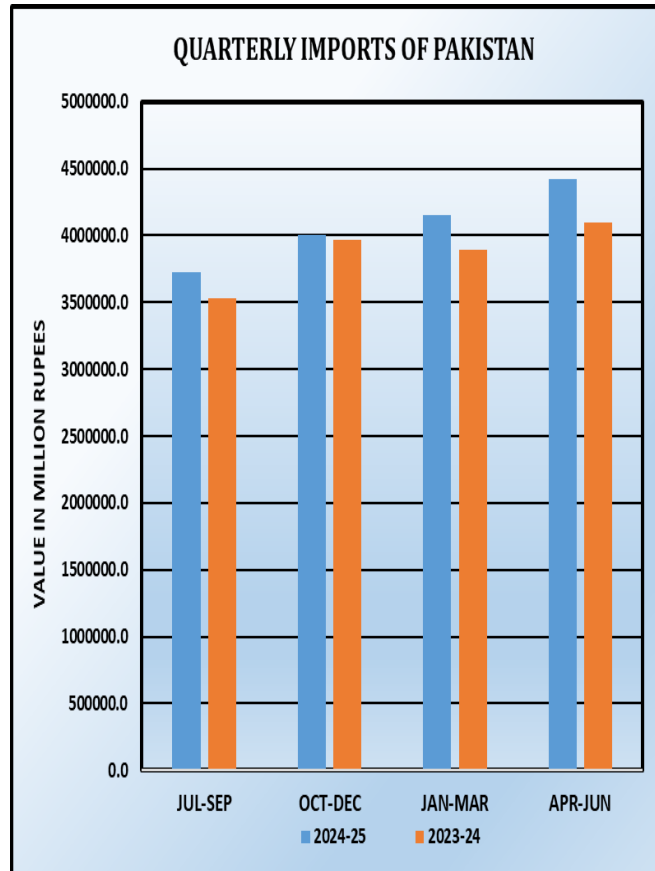
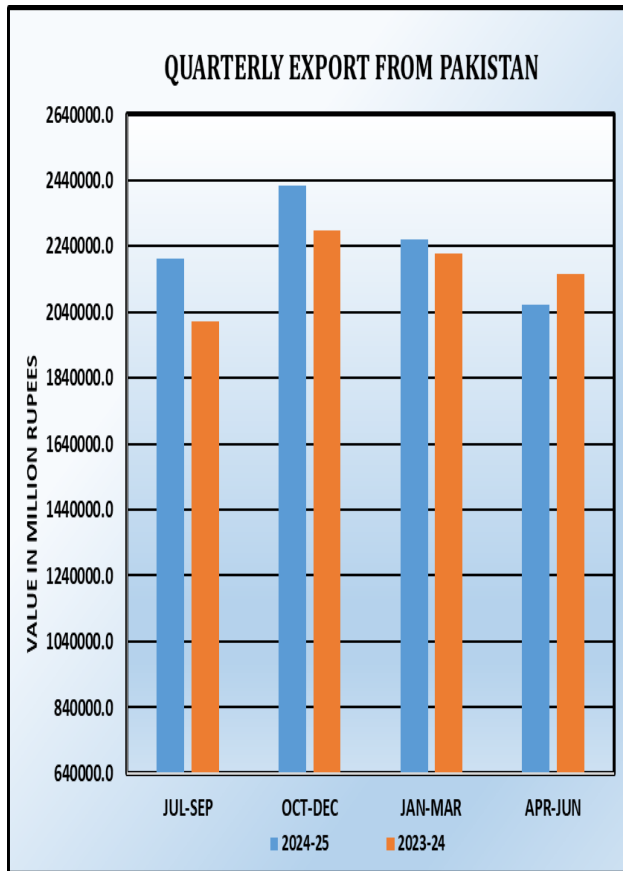

## **CHAPTER-I**

### **I – EXPORT BY GROUP/COMMODITIES**

#### **Food Group**

During Apr-Jun, 2025 export of goods belonging to Food Group decreased by 29.51% over Jan-Mar, 2025 and decreased by 29.29% over Apr-Jun, 2024. Food Group contributed 12.42% of total exports.

The export of food group during Jul-Jun, 2025 decreased by 10.52% compared to the same period of last year. This Group contributed 14.69% of total export during Jul-Jun, 2025.

#### **Textile Group**

During Apr-Jun, 2025 export of Textile goods decreased by 4.35% over Jan-Mar, 2025 and increased by 3.04% over Apr-Jun, 2024. Textile Group contributed 55.98% of total exports.

The export of textile group increased by 6.30% for the period of Jul-Jun, 2025 compared to the same period of last year. Textile Group contributed 53.46% of total exports during Jul-Jun, 2025.

#### **Manufactures Group**

During Apr-Jun, 2025 export of manufactured goods decreased by 5.27% over Jan-Mar, 2025 and decreased by 5.86% over Apr-Jun, 2024. Manufactures Group contributed 7.66% of total exports.

Export for manufacture group during Jul-Jun, 2025 increased by 8.80% compared to the same period of last year. Manufacture Group contributed 7.22% of total exports during Jul-Jun, 2025.

## II– DIRECTION OF EXPORTS

During Apr-Jun, 2025 country-wise U. S. A. was at the top of the export list followed by United Kingdom, China, Afghanistan, Germany, United Arab Emirates, Netherlands, Spain, Italy & Bangladesh. The share of these ten countries in total exports for Apr-Jun, 2025 was 66.32% as against 62.02% in Apr-Jun, 2024.

During Jul-Jun, 2025 Country-wise, U.S.A. was at the top of the exports list followed by China, United Kingdom, United Arab Emirates, Germany, Afghanistan, Netherlands, Spain, Italy, and Bangladesh. The share of these ten countries in total exports for Jul-Jun, 2025 was 64.04% as against 61.62% in the same period of last year.

### **III- EXPORT BY ECONOMIC CATEGORIES**

Export of Primary Commodities during Apr-Jun, 2025 decreased by 28.72%, Semi- Manufactures decreased by 12.20% and Manufactured Goods increased by 2.97% over Apr-Jun, 2024. Whereas, their share in total export stands at 15.21%, 4.79% and 79.97% respectively for Apr-Jun, 2025.

Exports of Primary Commodities during Jul-Jun, 2025 decreased by 13.79%, Semi-Manufactures decreased by 1.14% and Manufactured Goods increased by 8.48%. Whereas, their respective share in total export for the period of Jul-Jun, 2025 stood at 18.29%, 6.17% and 75.52%.

## **CHAPTER-II**

### **I – IMPORTS BY GROUPS/COMMODITIES**

#### **Food Group**

During Apr-Jun, 2025 import of goods belonging to Food Group decreased by 20.01% over Jan-Mar, 2025 and increased by 26.64% over Apr-Jun, 2024. This group contributed 8.25% of total imports.

The import of food group during Jul-Jun, 2025 increased by 22.13% compared to the same period of last year. This group contributed 9.39% of total imports during Jul-Jun, 2025.

#### **Machinery & Transport Group**

During Apr-Jun, 2025 import of goods belonging to Machinery & Transport group increased by 24.50% over Jan-Mar, 2025 and increased by 19.49% over Apr-Jun, 2024. This group contributed 24.34% of total imports.

The import of goods belonging to Machinery & Transport group during Jul-Jun, 2025 increased by 15.63% compared to the same period of last year. This group contributed 20.59% of total import during Jul-Jun, 2025.

#### **Petroleum Group**

During Apr-Jun, 2025 import of goods belonging to Petroleum group increased by 6.44% over Jan-Mar, 2025 and decreased by 16.65% over Apr-Jun, 2024. This group contributed 18.81% of total imports.

The import of petroleum group during Jul-Jun, 2025 decreased by 7.47% compared to the same period of last year. This group contributed 19.54% of total imports during Jul-Jun, 2025.

#### **Textile Group**

During Apr-Jun, 2025 import of goods belonging to textile group decreased by 17.11% over Jan-Mar, 2025 and increased by 0.34% over Apr-Jun, 2024. This group contributed 1.81% of total imports.

The import of Textile group during Jul-Jun, 2025 increased by 7.88% compared to the same period of last year. This group contributed 2.04% of total imports during Jul-Jun, 2025.

## **Chemical Group**

During Apr-Jun, 2025 import of goods belonging to Chemical group increased by 5.99% over Jan-Mar, 2025 and increased by 4.15% over Apr-Jun, 2024. This group contributed 14.02% of total imports.

The import of chemical group during Jul-Jun, 2025 increased by 2.01% compared to the same period of last year. This group contributed 15.03% of total imports during Jul-Jun, 2025.

## **Metal Group**

During Apr-Jun, 2025 import of Metal products increased by 7.46% over Jan-Mar, 2025 and increased by 16.55% over Apr-Jun, 2024. This group contributed 6.37% of total imports.

The import of metal group during Jul-Jun, 2025 increased by 5.83% compared to the same period of last year. This group contributed 6.00% of total imports during Jul-Jun, 2025.

## **Miscellaneous Group**

During Apr-Jun, 2025 imports of miscellaneous commodities increased by 7.32% over Jan-Mar, 2025 and increased by 20.08% over Apr-Jun, 2024. This group contributed 0.96% of total imports.

The import of miscellaneous group during Jul-Jun, 2025 increased by 12.64% compared to the same period of last year. This group contributed 1.00% of total imports during Jul-Jun, 2025.

## II– DIRECTION OF IMPORTS

During Apr-Jun, 2025 Country-wise China was at the top of the import list followed by United Arab Emirates, Saudi Arabia, Indonesia, Qatar, U.S.A., Brazil, Japan, Kuwait & Korea Republic of. The share of these ten countries in total imports for Apr-Jun, 2025 was 76.14% as against 72.34% in Apr-Jun, 2024.

During Jul-Jun, 2025 Country-wise China was on the top of the import list followed by United Arab Emirates, Saudi Arabia, Indonesia, Qatar, U.S.A, Kuwait, Japan, Iran (Islamic R.) and Singapore. The combined share of these ten countries in total imports during this period was 72.60% as against their combined share of 70.49% during the corresponding period of last year.

### **III– IMPORTS BY BROAD ECONOMIC CATEGORIES**

Imports of Consumer Goods/Intermediate Goods during Apr-Jun, 2025 decreased by 20.88%, Consumer Goods decreased by 6.59%, Consumer Goods/Capital Goods increased by 68.54%, Intermediate Goods increased by 14.99%, Intermediate Goods/Capital Goods decreased by 4.97%, Intermediate Goods/Consumer Goods increased by 16.32%, Capital Goods increased by 38.64%, Capital Goods/Consumer Goods increased by 44.12% and Capital Goods/Intermediate Goods increased by 37.91% over Apr-Jun, 2024. Their respective share in total imports was 16.67%, 10.44%, 0.21%, 60.49%, 0.06%, 2.61%, 8.68%, 0.79% and 0.05% respectively for Apr-Jun, 2025.

Imports of Consumer Goods/Intermediate Goods during Jul-Jun, 2025 decreased by 8.48%, Consumer Goods increased by 6.57%, Consumer Goods/Capital Goods increased by 25.50%, Intermediate Goods decreased by 6.57%, Intermediate Goods/Capital Goods increased by 25.06%, Intermediate Goods/Consumer Goods increased by 16.00%, Capital Goods increased by 34.76%, Capital Goods/Consumer Goods increased by 8.28% and Capital Goods/Intermediate Goods increased by 25.93% over Jul-Jun, 2025. Their respective share in total imports was 18.57%, 10.86%, 0.19%, 59.22%, 0.08%, 2.72%, 7.60%, 0.70% and 0.05% respectively for FY2025.
