TRADE SUMMARY

January-March, 2022

EXPORTS

The total exports of Pakistan during Jan-Mar, 2022 amounted to Rs. 1,456,973.83 million showing an increase of 2.99% over Oct-Dec, 2021 & by 39.89% over Jan-Mar, 2021.

In terms of US dollar, the export during Jan-Mar, 2022 amounted to \$ 8,224.90 million showing an increase of 1.18% over Oct-Dec, 2021 and increased by 25.05% over Jan-Mar, 2021.

Export during Jul-Mar, 2022 totaled Rs. 4,018,757.72 million showing an increase of 33.06% over the corresponding period of last year. In terms of US dollars, exports stand at \$ 23,350.01 million showing an increase of 24.95% over the corresponding period of last year.

IMPORTS

The total imports of Pakistan during Jan-Mar, 2022 amounted to Rs. 3,242,091.88 million showing a decrease of 14.75% over Oct-Dec, 2021 & increased by 36.22% over Jan-Mar, 2021.

In terms of US dollar, the imports during Jan-Mar, 2022 amounted to \$ 18,295.86 million showing a decrease of 16.26% over Oct-Dec, 2021 & increased by 21.69% over Jan-Mar, 2021.

Import during Jul-Mar, 2022 totaled Rs. 10,117,304.06 million showing an increase of 58.67% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$58,858.54 million showing an increase of 49.05% over the corresponding period of last year.

TOTAL TRADE

The total trade of Pakistan during Jan-Mar, 2022 amounted to Rs. 4,699,065.71 million showing a decrease of 9.94% over Oct-Dec, 2021 & increased by 37.34% over Jan-Mar, 2021.

In terms of US dollars, the total trade during Jan-Mar, 2022 amounted to \$ 26,520.75 million showing a decrease of 11.53% over Oct-Dec, 2021 & increased by 22.71% over Jan-Mar, 2021.

Total trade during Jul-Mar, 2022 totaled Rs. 14,136,061.78 million showing an increase of 50.44% over the corresponding period of last year. In terms of US dollars, total trade stands at \$82,208.55 million showing an increase of 41.31%.

BALANCE OF TRADE

Balance of trade in Jan-Mar, 2022 was unfavorable to Pakistan to the tune of Rs. 1,785,118.05 million equivalents to US \$ 10,070.96 million, whereas during the period of Jul-Mar, 2022 it was unfavorable to the tune of 6,098,546.34 million rupees equivalent to US \$ 35,508.53 million.

I – EXPORTS BY GROUPS/COMMODITIES

Food Group

During Jan-Mar, 2022 export of goods belonging to Food Group increased by 9.70% over Oct-Dec, 2021 and by 23.60% over Jan-Mar, 2021. Food Group contributed 13.42 of total exports during Jan-Mar, 2022.

The export of food group during Jul-Mar, 2022 increased by 18.40% compared to the same period of last year. This Group contributed 11.96% of total export during Jul-Mar, 2022.

Textile Group

During Jan-Mar, 2022 export of Textile goods decreased by 0.02% over Oct-Dec, 2021 and increased by 41.45% over Jan-Mar, 2021. Textile Group contributed 56.63% of total exports during Jan-Mar, 2022.


The export of textile group increased by 33.38% for the period of Jul-Mar, 2022 compared to the same period of last year. Textile Group contributed 58.29% of total exports during Jul-Mar, 2022.

Manufacture Group


During Jan-Mar, 2022 export of manufacture goods increased by 8.00% over Oct-Dec, 2021 & increased by 1.33% over Jan-Mar, 2021. Manufactures Group contributed 6.15% of total exports during Jan-Mar, 2022.

Export for manufacture group during Jul-Mar, 2022 increased by 19.29% compared to the same period of last year. Manufacture Group contributed 6.08% of total exports during Jul-Mar, 2022.


QUARTERLY EXPORT FROM PAKISTAN

QUARTERLY BALANCE OF PAYMENTS OF PAKISTAN



II – DIRECTION OF EXPORTS

Country-wise U. S. A. was at the top of the export list for Jan-Mar, 2022 followed by China, United Kingdom, Netherlands, Germany, United Arab Emirates, Italy, Spain, Bangladesh and Afghanistan. The share of these ten countries in total exports for Jan-Mar, 2022 was 65.74% as against 64.84% in Jan-Mar, 2021.

Country-wise, U.S.A. was at the top of the exports list for Jul-Mar, 2022 followed by China, United Kingdom, Germany, Netherlands, United Arab Emirates, Spain, Italy, Bangladesh & Belgium. The share of these ten countries in total exports for Jul-Mar, 2022 was 66.70% as against 64.31% in the same period of last year.

III – EXPORTS BY ECONOMIC CATEGORIES

Export of Primary Commodities during Jan-Mar, 2022 decreased by 30.78%, Semi-Manufactures decreased by 18.82% and Manufactured Goods increased by 44.32% over Jan-Mar, 2022. Whereas, their share in total export stands at 16.77%, 6.66% and 76.57% respectively.

Exports of Primary Commodities during Jul-Mar, 2022 decreased by 32.64%, Semi-Manufactures by 30.53% and Manufactured Goods increased by 33.37%. Whereas, their respective share in total export for the period of Jul-Mar, 2022 stood at 15.80%, 6.70% and 77.50%.

I – IMPORTS BY GROUPS/COMMODITIES

Food Group

During Jan-Mar, 2022 import of goods belonging to Food Group decreased by 3.44% over Oct-Dec, 2021 and increased by 31.86% over Jan-Mar, 2021. This group contributed 7.12% of total imports during Jan-Mar, 2022.

The import of food group during Jul-Mar, 2022 increased by 41.96% compared to the same period of last year. This group contributed 6.62% of total imports during Jul-Mar, 2022.

Machinery & Transport Group

During Jan-Mar, 2022 import of goods belonging to Machinery & Transport group decreased by 9.52% over Oct-Dec, 2021 & increased by 12.91% over Jan-Mar, 2021. This group contributed 20.67% of total imports during Jan-Mar, 2022.

The import of goods belonging to Machinery & Transport group during Jul-Mar, 2022 increased by 40.23% compared to the same period of last year. This group contributed 20.32% of total import during Jul-Mar, 2022.

Petroleum Group

During Jan-Mar, 2022 import of goods belonging to Petroleum group decreased by 11.29% over Oct-Dec, 2021 but increased by 99.00% over Jan-Mar, 2021. This group contributed 19.21% of total imports during Jan-Mar, 2022.

The import of petroleum group during Jul-Mar, 2022 increased by 113.25% compared to the same period of last year. This group contributed 18.66% of total imports during Jul-Mar, 2022.

Textile Group

During Jan-Mar, 2022 import of goods belonging to Textile group increased by 7.23% over Oct-Dec, 2021 & by 26.15% over Jan-Mar, 2021. This group contributed 2.08% of total imports during Jan-Mar, 2022.

The import of Textile group during Jul-Mar, 2022 increased by 36.40% compared to the same period of last year. This group contributed 2.05% of total imports during Jul-Mar, 2022.

Chemical Group

During Jan-Mar, 2022 import of goods belonging to Chemical group decreased by 28.91% over Oct-Dec, 2021 and increased by 53.95% over Jan-Mar, 2021. This group contributed 15.32% of total imports during Jan-Mar, 2022.

The import of chemical group during Jul-Mar, 2022 increased by 85.90% compared to the same period of last year. This group contributed 18.90% of total imports during Jul-Mar, 2022.

Metal Group

During Jan-Mar, 2022 import of Metal products decreased by 16.98% over Oct-Dec, 2021 and increased by 37.04% over Jan-Mar, 2021. This group contributed 6.95% of total imports during Jan-Mar, 2022.

The import of metal group during Jul-Mar, 2022 increased by 51.19% compared to the same period of last year. This group contributed 6.87% of total imports during Jul-Mar, 2022.

Miscellaneous Group

During Jan-Mar, 2022 imports of miscellaneous commodities decreased by 10.69% over Oct-Dec, 2021 and by 2.55% over Jan-Mar, 2021. This group contributed 0.96% of total imports.

The import of miscellaneous group during Jul-Mar, 2022 decreased by 1.61% compared to the same period of last year. This group contributed 0.97% of total imports during Jul-Mar, 2022.

II – DIRECTION OF IMPORTS

Country-wise China was at the top of the import list for Jan-Mar, 2022 followed by United Arab Emirates, Indonesia, U. S. A., Saudi Arabia, Qatar, Kuwait, Japan, South Africa & Thailand. The share of these ten countries in total imports for Jan-Mar, 2022 was 70.43% as against 69.18% in Jan-Mar, 2021.

Country-wise China was on the top of the import list followed by United Arab Emirates, Indonesia, Saudi Arabia, U.S.A., Qatar, Kuwait, Japan, South Africa and Thailand during Jul-Mar, 2022. The combined share of these ten countries in total imports was 69.71% as against their combined share of 65.44% during the corresponding period of last year.

III – IMPORTS BY ECONOMIC CATEGORIES

Imports of Consumer Goods during Jan-Mar, 2022 increased by 49.10%, Raw Material for Consumer Goods increased by 41.66%, Capital Goods decreased by 15.55% and Raw Material for Capital Goods increased by 51.52% over Jan-Mar, 2021. Their respective share in total imports were 19.36%, 43.90%, 25.25% and 11.50% respectively for Jan-Mar, 2022.

Imports of Consumer Goods during Jul-Mar, 2022 increased by 81.37%, Raw Material for Consumer Goods increased by 61.04%, Capital Goods decreased by 41.36% and Raw Material for Capital Goods decreased by 53.90% over Jul-Mar, 2021. Their respective share in total imports were 21.79%, 43.00%, 24.77% and 10.43% respectively for Jul-Mar, 2022.
