TRADE SUMMARY

April-June, 2020

EXPORTS

The total exports of Pakistan during Apr-Jun, 2020 amounted to Rs. 644,571.54 million showing a decrease of 30.05% over Jan-Mar, 2020 and by 25.44% over Apr-Jun, 2019.

In terms of US dollar, the exports during Apr-Jun, 2020 amounted to \$ 3,950.41 million showing a decrease of 33.26% over Jan-Mar, 2020 and by 32.90% over Apr-Jun, 2019.

Exports during Jul-Jun, 2020 totaled Rs. 3,369,781.96 million showing an increase of 7.72% over the corresponding period of last year. In terms of US dollars, exports stand at \$ 21,393.69 million showing a decrease of 6.82% over the corresponding period of last year.

IMPORTS

The total imports of Pakistan during Apr-Jun, 2020 amounted to Rs. 1,595,291.01 million showing a decrease of 11.58% over Jan-Mar, 2020 and by 23.01% over Apr-Jun, 2019.

In terms of US dollar, the imports during Apr-Jun, 2020 amounted to \$ 6,429.30 million showing a decrease of 44.56% over Jan-Mar, 2020 and by 54.35% over Apr-Jun, 2019.

Imports during Jul-Jun, 2020 totaled Rs. 7,029,802.20 million showing a decrease of 5.55% over the corresponding period of last year. In terms of US dollars, Imports stand at stands at \$44,552.90 million showing a decrease of 18.64% over the corresponding period of last year.

TOTAL TRADE

The total trade of Pakistan during Apr-Jun, 2020 amounted to Rs. 2,239,862.55 million showing a decrease of 17.82% over Jan-Mar, 2020 and by 23.73% over Apr-Jun, 2019.

In terms of US dollars, the total trade during Apr-Jun, 2020 amounted to \$ 10,379.71 million showing a decrease of 40.74% over Jan-Mar, 2020 and by 48.03% over Apr-Jun, 2019.

Total trade during Jul-Jun, 2020 totaled Rs. 10,399,584.16 million showing a decrease of 1.63% over the corresponding period of last year. In terms of US dollars, total trade stands at \$65,946.59 million showing a decrease of 15.15%.

BALANCE OF TRADE

Balance of trade in Apr-Jun, 2020 was unfavorable to Pakistan to the tune of Rs. 950,719.47 million equivalents to US \$ 2,478.89 million, whereas during the period of Jul-Jun, 2020 it was unfavorable to the tune of 3,660,020.24 million rupees equivalent to US \$ 23,159.21 million.

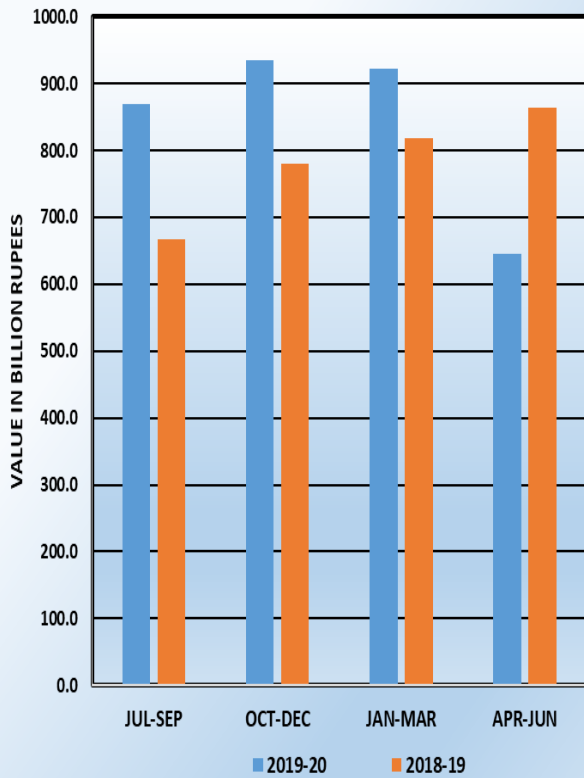

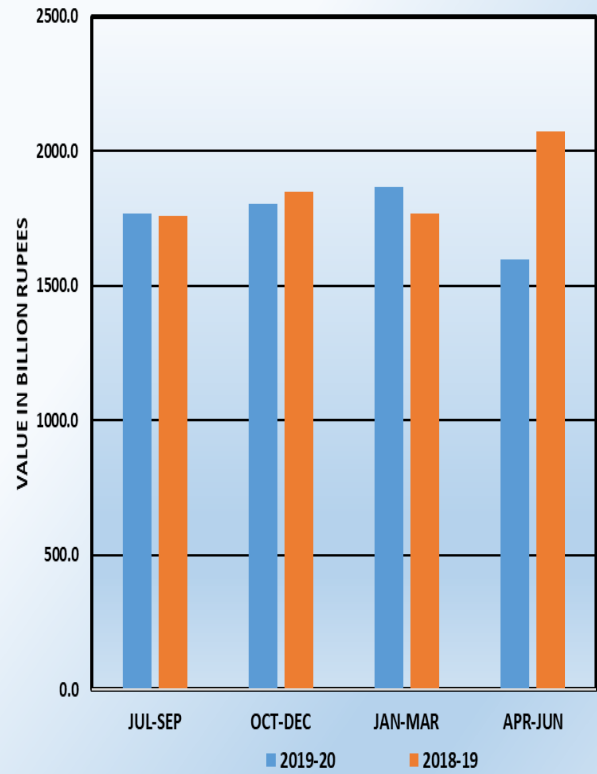

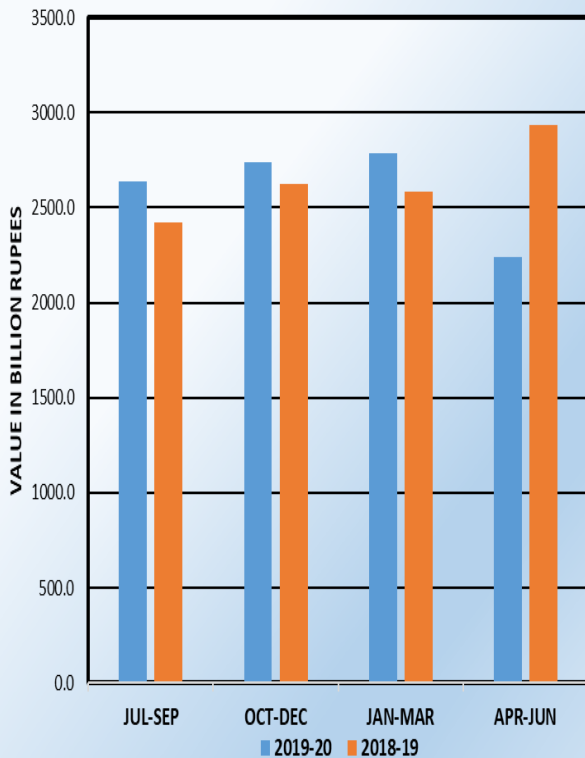
QUARTERLY EXPORT OF PAKISTAN



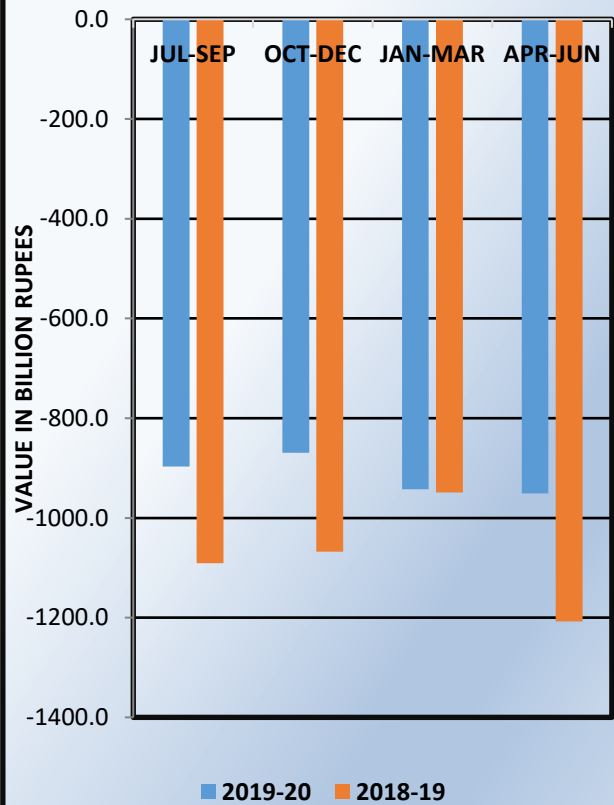
QUARTERLY IMPORTS OF PAKISTAN

I – EXPORTS BY GROUP/COMMODITIES

Food Group

During Apr-Jun, 2020 exports of goods belonging to Food Group decreased by 15.60% over Jan-Mar, 2020 but increased by 1.33% over Apr-Jun, 2019. Food Group contributed 19.56% of total exports during Apr-Jun, 2020.

The exports of food group during Jul-Jun, 2020 increased by 20.22% compared to the same period of last year. This Group contributed 15.68% of total exports during Jul-Jun, 2020.

Textile Group

During Apr-Jun, 2020 exports of Textile goods decreased by 37.17% over Jan-Mar, 2020 and by 31.05% over Apr-Jun, 2019. Textile Group contributed 50.90% of total exports during Jan-Mar, 2020.

The exports of textile group increased by 7.94% for the period of Jul-Jun, 2020 compared to the same period of last year. Textile Group contributed 56.27% of total exports during Jul-Jun, 2020.

Manufacture Group

During Apr-Jun, 2020 exports of manufacture goods decreased by 43.45% over Jan-Mar, 2020 and by 46.62% over Apr-Jun, 2019. Manufactures Group contributed 5.73% of total exports during Apr-Jun, 2020.

Exports for manufacture group during Jul-Jun, 2020 decreased by 1.62% compared to the same period of last year. Manufacture Group contributed 7.21% of total exports during Jul-Jun, 2020.

II – DIRECTION OF EXPORTS

During the quarter of Apr-Jun, 2020, the share of European Union in total exports was 33.79% as against 33.80% in Apr-Jun, 2019. The share of Other Asia in total exports was 21.61% as against 26.73% in Apr-Jun, 2019. The share of North America during Apr-Jun, 2020 was 19.24% as against 18.30% in Apr-Jun, 2019. The share of Middle East during Apr-Jun, 2020 was 14.66% as against 12.69% in Apr-Jun, 2019. The share of Other Africa during Apr-Jun, 2020 was 6.71% as against 4.42% in Apr-Jun, 2019. Country-wise U. S. A. was at the top of the exports list for Apr-Jun, 2020 followed by China, United Kingdom, United Arab Emirates, Germany and Netherlands. The share of these six countries in total exports for Jan-Ma, 2020 was 49.28% as against 48.41% in Apr-Jun, 2019.

During Jul-Jun, 2020 the share of European Union in total exports increased to 34.59% from 34.02% during the same period of last year. The share of Other Asia in total exports decreased to 23.73% from 27.89% during the same period of last year. The share of North America increased to 18.65% from 18.21% during the same period of last year. The share of Middle East increased to 12.79% from 10.15% during the same period of last year. The share of Other Africa increased to 5.80% from 5.12% during the same period of last year.

Country-wise, U.S.A. was at the top of the exports list for Jul-Jun, 2020 followed by China, United Kingdom, Germany, United Arab Emirates and Netherlands. The share of these six countries in total exports for Jul-Jun, 2020 was 48.57% as against 46.37% in the same period of last year.

III – EXPORTS BY ECONOMIC CATEGORIES

Exports of Primary Commodities during Apr-Jun, 2020 decreased by 7.39%, Semi-Manufactures by 43.11% and Manufactured Goods by 27.32% over Jan-Mar, 2020. Whereas, their share in total exports stands at 22.51%, 8.40% and 69.09% respectively.

Exports of Primary Commodities during Jul-Jun, 2020 increased by 10.78%, Semi-Manufactures decreased by 7.85% and Manufactured Goods increased by 9.07%. Whereas, their respective share in total exports for the period of Jul-Jun, 2020 stood at 18.67%, 8.40% and 72.02%.

I – IMPORTS BY GROUPS/COMMODITIES

Food Group

During Apr-Jun, 2020 imports of goods belonging to Food Group decreased by 2.17% over Jan-Mar, 2020 but increased by 21.87% over Apr-Jun, 2019. This group contributed 8.71% of total imports during Apr-Jun, 2020.

The imports of food group during Jul-Jun, 2020 increased by 14.76% compared to the same period of last year. This contributed 7.16% of total imports during Jul-Jun, 2020.

Machinery & Transport Group

During Apr-Jun, 2020 imports of goods belonging to Machinery & Transport group increased by 2.36% over Jan-Mar, 2020 but decreased by 13.32% over Apr-Jun, 2019. This group contributed 25.43% of total imports during Apr-Jun, 2020.

The imports of goods belonging to Machinery & Transport group during Jul-Jun, 2020 increased by 0.03% compared to the same period of last year. This group contributed 23.08% of total imports during Jul-Jun, 2020.

Petroleum Group

During Apr-Jun, 2020 imports of goods belonging to Petroleum group decreased by 46.74% over Jan-Mar, 2020 and by 59.62% over Apr-Jun, 2019. This group contributed 10.66% of total imports during Apr-Jun, 2020.

The imports of petroleum group during Jul-Jun, 2020 decreased by 20.55% compared to the same period of last year. This group contributed 16.67% of total imports during Jul-Jun, 2020.

Textile Group

During Apr-Jun, 2020 imports of goods belonging to Textile group decreased by 37.28% over Jan-Mar, 2020 and by 50.49% over Apr-Jun, 2019. This group contributed 1.66% of total imports during Apr-Jun, 2020.

The imports of Textile group during Jul-Jun, 2020 decreased by 15.98% compared to the same period of last year. This group contributed 2.09% of total imports during Jul-Jun, 2020.

Chemical Group

During Apr-Jun, 2020 imports of goods belonging to Chemical group increased by 6.13% over Jan-Mar, 2020 but decreased by 9.37% over Apr-Jun, 2019. This group contributed 18.23% of total imports during Apr-Jun, 2020.

The imports of chemical group during Jul-Jun, 2020 decreased by 2.22% compared to the same period of last year. This group contributed 16.57% of total imports during Jul-Jun, 2020.

Metal Group

During Apr-Jun, 2020 imports of Metal products decreased by 4.10% over Jan-Mar, 2020 and by 14.85% over Apr-Jun, 2019. This group contributed 7.28% of total imports during Apr-Jun, 2020.

The imports of metal group during Jul-Jun, 2020 decreased by 3.65% compared to the same period of last year. This group contributed 6.87% of total imports during Jul-Jun, 2020.

Miscellaneous Group

During Apr-Jun, 2020 imports of miscellaneous commodities decreased by 0.53% over Jan-Mar, 2020 and by 9.45% over Apr-Jun, 2019. This group contributed 1.18% of total imports.

The imports of miscellaneous group during Jul-Jun, 2020 decreased by 13.27% compared to the same period of last year. This group contributed 1.12% of total imports during Jul-Jun, 2020.

II – DIRECTION OF IMPORTS

During Apr-Jun, 2020, the share of Other Asia in total imports was 50.82% as against 42.28% in Apr-Jun, 2019. The share of Middle East during Apr-Jun, 2020 was 18.95% as against 29.19% in Apr-Jun, 2019. The share of European Union during Apr-Jun, 2020 was 9.63% as against 13.56% in Apr-Jun, 2019. Country-wise China was at the top of the imports list for Apr-Jun, 2020 followed by United Arab Emirates, U. S. A., Indonesia, Brazil and Qatar. The share of these six countries in total imports for Apr-Jun, 2020 was 57.67% as against 50.81% in Apr-Jun, 2019.

During Jul-Jun, 2020 the share of Other Asia in total imports increased to 46.60% from 44.55% during the same period of last year. The share of Middle East decreased to 25.88% from 29.52% during the same period of last year. The share of European Union increased to 10.40% from 11.24% during the same period of last year.

Country-wise China was on the top of the imports list followed by United Arab Emirates, U.S.A., Indonesia, Saudi Arabia and Qatar during Jul-Jun, 2020. The combined share of these six countries in total imports during this period was 56.87% as against their combined share of 56.33% during the corresponding period of last year.

III – IMPORTS BY ECONOMIC CATEGORIES

Imports of Consumer Goods during Apr-Jun, 2020 decreased by 24.85%, Raw Material for Consumer Goods by 31.29%, Capital Goods by 14.21% and Raw Material for Capital Goods by 5.58% over Apr-Jun, 2019. Their respective share in total imports were 16.86%, 40.40%, 31.85% and 10.89% respectively for Apr-Jun, 2020.

Imports of Consumer Goods during Jul-Jun, 2020 decreased by 4.08%, Raw Material for Consumer Goods by 9.78%, Capital Goods by 2.21% and Raw Material for Capital Goods increased by 1.28% over Jul-Jun, 2019. Their respective share in total imports were 18.17%, 42.37%, 28.69% and 10.77% respectively for Jul-Jun, 2020.
