UALIFICATIONS, EXPERIENCE AND AGE-LIMITS FOR INITIAL APPOINTMENT

- 4. A candidate must possess the educational qualifications and experience and must be within the age limi's mentioned against the post concerned in the Schedule to the Notification, provided that:—
 - (i) "Experience" means, the experience gained in a regular full time paid job after attaining the prescribed basic qualifications.
 - (ii) The period spent by a candidate in obtaining Degree of M. Phil or Ph. D in the relevant field shall be treated as practical experience upto a maximum period of two and four years, respectively, for the purpose of initial appointment, provided that:—
 - (a) a candidate who has obtained the degree of M. Phil or Ph. D during service shall not be entitled to a double benefit of counting the said period as service towards experience prescribed for the post; and
 - (b) this concession shall not be available for the posts for which the prescribed qualification is M. Phil|Ph. D.
 - (iii) The maximum age limits will be relaxed upto the age of 55 years, wherever applicable, for appointment to all posts in the Federal Government as follows:—
 - (a) by three years in the case of candidates belonging to the Schedule Castes, Budhist Community, recognized tribes of the Tribal Areas, Azad Kashmir, and Northern Areas.
 - (b) by not more than ten years in case of Government Servants who have completed atleast 2 years continuous Government service on the closing date for submission of application.
 - (c) by ten years or the number of years served in the Armed Forces, whichever is less, in the case of released or retired officer personnel of the Armed Forces of Pakistan.
 - Only one of the relaxations mentioned at (a), (b) and (c) above shall be allowed.
 - (iv) Eligibility of candidates shall be reckoned as on the closing date fixed for the submission of the applications, in accordance with the Recruitment Rules and the instructions issued by the Government and Federal Public Service Commission.

APPOINTMENT BY TRANSFER

5. Appointment by transfer shall be made by selection from amongst the persons holding appointment on a regular basis under the Federal Government in the same basic pay scale in which the post to be filled exists, provided that the person concerned possesses the qualifications and experience prescribed for initial appointment or promotion to the post concerned.

PROBATION

- f. Persons appointed by promotion, initial appointment or transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded or if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of the Civil Servants Act, 1973.
