FOREIGN TRADE STATISTICS

Exports during March, 2012:

Exports from Pakistan during March, 2012 amounting to Rs. 181,507 million (Provisional) as against Rs. 184,343 million (Provisional) in February, 2012 showing a decrease of 1.54%.

In terms of US dollars, the exports from Pakistan during March, 2012 amounting to 2,001 million US \$ (Provisional) as against 2,034 million US \$ (Provisional) in February, 2012 showing a decrease of 1.62%.

Main commodities of exports during March, 2012 were:

Food Group: Rice others (Rs.11,493 million or 126,696 thousand US \$) and rice basmati (Rs. 5,478 million or 60,388 thousand US \$).

Textile Group: Cotton cloth (Rs. 19,006 million or 209,517 thousand US \$), cotton yarn (Rs.15,840

Million or 174,616 thousand US \$), knitwear (Rs.12,388 million or 136,562 thousand US \$), readymade garments (Rs.11,369 million or 125,329 thousand US \$), bed wear (Rs. 11,213 million or 123,609 thousand US \$) and raw cotton (Rs.6,202 million or 68,369 thousand US \$).

Petroleum & Coal Group: Petroleum top naphta (Rs. 5,199 million or 57,312 thousand US \$).

Other Manufactures Group: Jewellary (Rs. 6,593 million or 72,679 thousand US \$).

Exports during July - March , 2011-2012:

Exports during July-March, 2011-2012 totalled Rs. 1,518,592 million (Provisional) as against Rs. 1,517,216 million during the corresponding period of last year showing an increase of 0.09%.

In terms of US dollars, the exports during July-March, 2011-2012 totalled \$ 17,190 million (Provisional) as against \$ 17,727 million during the corresponding period of last year showing a decrease of 3.03%.

Imports during March ,2012:

Imports into Pakistan during March, 2012 amounting to Rs. 317,229 million (Provisional) as against Rs. 313,708 million (Provisional) in February, 2012, showing an increase of 1.12%.

In terms of US dollars, the imports into Pakistan during March, 2012 amounting to 3,497 million US \$ (Provisional) as against 3,462 million US \$ (Provisional) in February, 2012, showing an increase of 1.01%.

Main commodities of imports during March, 2012 were:

Food Group: Palm oil (Rs. 9,643 million or 106,302 thousand US \$).

Machinery Group: Power generating machinery (Rs. 8,131 million or 89,634 thousand US \$), telecom (mobile phone) (Rs.5,660 million or 62,394 thousand US \$) and other apparatus (Rs.5,547 million or 61,149 thousand US \$).

Petroleum Group: Petroleum products (Rs.81,954 million or 903,438 thousand US \$) and petroleum crude (Rs.26,981 million or 297,431 thousand US \$).

Textile Group: synthetic & artificial silk yarn (Rs. 4,771 million or 52,594 thousand US \$).

Agricultural and Other Chemicals Group: Plastic materials (Rs. 11,223 million or 123,719 thousand US \$) and medicinal products (Rs.4,657 million or 51,337 thousand US \$).

Metal Group: Iron and steel (Rs. 9,344 million or 103,006 thousand US \$).

Imports during July - March , 2011-2012 :

Imports during July-March, 2011-2012 totalled Rs.2,939,046 million (Provisional) as against Rs.2,483,769 million during the corresponding period of last year showing an increase of 18.33%.

In terms of US dollars, the imports during July-March, 2011-2012 totalled US \$ 33,285 million (Provisional) as against \$ 29,016 million during the corresponding period of last year showing an increase of 14.71%.

Balance of Trade:

Based on the provisional figures of imports and exports, the balance of trade in March, 2012 was (-)135,722 million in terms of Rupees and (-)1,496 million in US dollars. The balance of trade figures cumulative from July-March, 2011-2012 were (-)1,420,454 million in terms of Rupees and (-)16,095 million in US dollars.



PRICE INDICES AND ANALYSIS

Consumer Price Index, April, 2012:

The Consumer Price Index for April, 2012 with 2007-08 base stood at 168.00 showing an increase of 1.83% over the Index for March, 2012 which showed an increase of 11.27% as compared to April, 2011.

The main contributors to month-on-month and year-on-year percentage changes are given below:

Month-on-month: Top few commodities which varied from previous month i.e. April, 2012 are given below:

Food Items:

Increased: Tomatoes (77.01%), Potatoes (21.97%), chicken (12.15%), fresh fruits (10.92%), besan (4.81%), fresh vegetable (4.35%), cigarettes (3.22%), cooking oil (2.79%), milk powder (2.50%), rice (2.20%), vegetable ghee (1.95%), milk fresh (1.39%), beverages and tea (1.32% each), milk product (1.26%), honey (1.20%), betel leaves & nuts (1.14%) and nimco (1.11%).

Decreased: Onion (27.94%), egg (22.27%), pulse mash washed (1.72%), spices (1.25%), pulse masoor (0.61%) and pulse moong (0.56%).

Non-food Items:

Increased: Motor fuel (7.42%), education (4.31%), text books (4.09%), kerosene oil (3.45%), fire wood whole (3.04%), cleaning & laundering (2.88%), marriage hall charges (2.54%), transport services (2.50%), cotton cloth (2.35%), utensils (2.25%), readymade garment (2.03%), washing soap & detergent (1.68%), dopatta (1.58%) and sewing needle & dry cell (1.49%).

Decreased: Personal equipment (1.18%).

Year-on-year: Top ten commodities which varied from previous year i.e. April, 2011 are given below:

Food Items:

Increased: Tomatoes (62.31%), pulse gram (35.55%), gram whole (32.55%), besan (30.78%), condiments (25.56%), chicken (22.58%), milk powder (18.69%), milk product (18.18%), spices (17.99%) and onion (17.96%).

Decreased: Sugar (15.88%), pulse masoor (13.35%), gur (11.62%), pulse moong (11.44%) and pulse mash washed (11.15%).

Non-food Items:

Increased: Motor vehicle tax (52.02%), household servant (32.68%), firewood whole (29.50%), gas (29.42%), motor fuel (28.88%), woolen cloth (23.62%), dopatta (22.06%), mechanical service (21.23%), motor vehicle accessories (20.75%) and washing soap & detergent (20.13%).

Decreased: None.

Wholesale Price Index, April, 2012:

The Wholesale Price Index for April, 2012 with 2007-08 base stood at 185.48 showing an increase of 1.80% over the Index for March, 2012 which showed an increase of 3.81% as compared to April, 2011.

The main contributors to month-on-month and year-on-year percentage changes are given below:

Month-on-month: Top few commodities which varied from previous month i.e. April, 2012 are given below:

Increased: Fresh fruit (37.70%), vegetable (13.13%), poultry (9.54%), edible roots/potatoes (9.48%), motor sprit (5.84%), cement (5.51%), diesel oil (4.76%), coal no agglomerated (4.54%), ice cream (4.38%), paint and varnish (4.27%) and cotton yarn (4.06%).

Decreased: Egg (29.08%), stimulant and spice crops (2.12%), cotton sheets (1.61%), oil cakes (1.34%), dried fruits and nuts (1.24%), chemicals (1.23%) and dry fruits (0.77%).

<u>Year-on-year</u>: Top ten commodities which varied from previous year i.e. April, 2011 are given below:

Increased: Spices (52.14%), coal no agglomerated (43.75%), fresh fruits (43.73%), hard board (38.18%), vegetables (35.12%), fish live (33.82%), other cereal flour (33.00%), natural gas liquid (32.50%), fertilizers (29.90%), dairy products (27.99%), footwear (26.63%), paint and varnish (25.20%), towels (25.15%), and mineral water (25.02%).

Decreased: Fiber crops (50.90%), cotton yarn (29.26%), stimulant and spice crops (20.39%), oil cakes (16.77%), sugar refined (16.43%), blended yarn (15.23%), edible roots and potatoes (11.91%), milk & cream in solid form (10.02%), sugar crops (9.67%) and insecticides (7.57%).



BRIEF ONGOING ACTIVITIES OF POPULATION CENSUS ORGANIZATION

- Preparatory work for conduct of 6th Population and Housing Census including appointment of field staff, formation of Coordination Committees/Vigilance Teams establishment of Control Rooms as well as requirements of logistic material for training of field staff and for conduct of main Population and Housing Census is in progress.
- The 3rd Round Table Meeting of SAARC Gender InfoBase in collaboration with UN-Women was successfully conducted on 4th April, 2012 at Marriott Hotel Islamabad.
- Benazir Income Support Program Survey in Khuzdar and Punjgur District of Balochistan Province has been completed where as the BISP work in Awaran district is in progress.
- The Benazir Income Support Program was conducted in 24 districts, discrepancies found have been rectified in all the district of Balochistan province.
- Computer printout of Karachi city district with summary of the changes occurred during House Listing Operation has been rechecked.
- The work regarding digitization 154 urban circle maps of the Punjab Province have been prepared and submitted to PBS for physical verification.
- A set of mauza maps and delimitation forms having rural blocks of Rawalpindi and Islamabad districts have been prepared. The field work regarding splitting of such blocks is in progress.


