Subject: - SPEAKING ORDER IN PURSUANCE OF HONRABLE ISLAMABAD HIGH COURT ORDER DATED 04-01-2019 IN WRIT PETITION NO. 1103/2017, FILED BY MR. MUHAMMAD AKHLAQ & OTHERS V/S FOP IN THE ISLAMABAD HIGH COURT, ISLAMABAD.

Reference Islamabad High Court Order dated 04-01-2019 regarding the subject noted above, which is reproduced as under:-

"In order to meet the ends of justice, this petition is disposed of by directing respondent No. 04 i.e the Director General, Pakistan Bureau of Statistics, Government of Pakistan to consider the cases of the petitioners in the light of principles and law highlighted by this court in the aforementioned judgments and thereafter pass speaking orders after affording an opportunity of hearing to the petitioners or their authorized representative".

- 2. In compliance with the court orders, a Committee under the Chairmanship of Member (RM) comprising other Senior Officers of PBS was constituted to consider the case. The Committee has held a meeting with the Petitioners on 23-04-2019. After personnel hearing and examination of the case, Committee has found that:
 - You were appointed according to the Recruitment Rules of the time being and other government policy, on contract basis against the gazetted posts in the year 2011.
 - ii. Your appointment was made initially for a period of one year which was later on extended for six months. On expiry of extended contract period, your appointment was automatically terminated, as it was mentioned in the appointment letter that after the expiry of tenure their services will automatically be terminated without any notice of termination order for lay off. On the acceptance of the term and conditions of the offer of appointment, you assumed the duties.
 - iii. Your Writ Petition in the Islamabad High Court for regularization of your service was submitted to Cabinet Sub-Committee, which was turned down by the Committee on 08-01-2017 with the remarks that the instant case does not cover under the policy framed for regularization and its beyod the mandate of the Committee.
- 3. The Departmental Committee after personnel hearing and examining the case in light of the principles set by the court, has come to the conclusion that there is no sufficient proof / documents/evidence in your favour, therefore, your request for regularization of contract service can not be entertained.

You are therefore informed that your request is hereby regretted.
