## **Analysis of Consumer Price Index (CPI) Base Year (2015-16)**

1. The CPI on new base (2015-16) comprises of urban CPI and Rural CPI. The Urban CPI covers 35 cities and 356 consumer items. The Rural CPI covers 27 Rural Centers and 244 consumer items. In the new base year (2015-16) National CPI for 12 major groups is also computed by taking weighted average of Urban CPI and Rural CPI.

## MONTHLY ANALYSIS [June, 2021 over May, 2021]

**2. CPI National** for the month of **June**, **2021** decreased by 0.24% over May, 2021. The Urban CPI recorded a decrease of 0.37% while Rural CPI recorded a decrease of 0.06%.

*Increased:* Tomatoes (28.94%), Onions (14.97%), Eggs (4.37%), Vegetables (3.11%), Meat (2.85%), Gur (1.85%), Wheat (1.52%), Vegetable ghee (1.36%), Pulse masoor (1.26%) and Mustard oil (1.21%)

**Decreased:** Chicken (36.86%), Fruits (20.07%), Pulse moong (6.10%), Fish (1.91%), Pulse gram (1.82%) and Pulse mash (1.24%).

#### **NON-FOOD**

*Increased:* Liquefied Hydrocarbons (26.26%), Motor fuel (3.84%), Personal Effects (2.47%) and Construction items (0.73%)

**Decreased**: Electricity charges (0.57%).

## RURAL:

#### FOOD

*Increased*: Tomatoes (26.76%), Vegetables (9.09%), Eggs (4.27%), Mustard oil (3.11%), Wheat (3.11%), Gur (2.49%), Milk (2.20%) and Cooking oil (1.23%).

**Decreased:** Chicken (32.50%), Fruits (12.58%), Pulse Moong (7.92%), Pulse Mash (2.12%), Potatoes (1.16%) and Sugar (0.93%).

#### **NON-FOOD**

*Increased*: Liquefied Hydrocarbons (13.53%), Personal Effects (2.66%), Furniture and Furnishing (2.22%), Motor Vehicles Accessories (1.47%), Hosiery (1.32%) and Motor Fuels (0.93%)

**Decreased:** Electricity Charges(0.57%).

## YEARLY ANALYSIS [June, 2021 over June, 2020]

**4.** CPI National for the month of June, 2021 increased by **9.70**% over June, 2020. The Urban CPI recorded an increase of **9.68**% while Rural CPI recorded an increase of **9.73**%.

**Decreased:** Pulse moong (20.17%), Potatoes (16.42%), Fruits (12.75%), Onions (5.07%) and Pulse masoor (2.43%).

### **NON-FOOD**

*Increased:* Motor fuel (40.48%), Liquefied Hydrocarbons (30.92%), Electricity charges (21.13%), Footwear (16.29%), Cleaning and laundering (13.36%), clinic fee (13.15%), Hosiery (12.6%) and Woollen garments (12.08%).

## RURAL:

**FOOD** 

*Increased:* Eggs (37.97%), Mustard oil (31.75%), Cooking oil (30.81%), Vegetable ghee (26.84%), Tomatoes (23.86%), Sugar (20.69%), Wheat (20.09%), Meat (16.2%), Butter (12.64%) and Rice (9.98%).

**Decreased**: Pulse Moong (25.23%), Potatoes (19.38%), Onions (12.73%), Fruits (11.77%), Pulse Masoor (2.59%) and Condiments and Spices (1.92%)

#### NON-FOOD

*Increased*: Motor Fuels (38.71%), Water Supply (36.99%), Liquefied Hydrocarbons (27.27%), Electricity Charges (21.13%), Hosiery (16.68%), Clinic Fee (16.25%), Plastic Products (13.32%) and Woolen Cloth (13.2%).

Decreased: Transport Services (2.81%).

## PERIOD - AVERAGE INFLATION RATE [JULY, 2020 to June, 2021]

**6.** CPI National for the period **July-June (2020-21)** increased by **8.90%** over July- June (2019-20). The Urban CPI recorded an increase of **8.15%** while Rural CPI recorded an increase of **10.04%**.

**Decreased**: Onions (27.50%), Cauliflower (26.22%), Garlic (22.98%), Apples (11.54%), Peas (9.57%), Reddish (8.60%) and Cucumber (5.39%).

Increased: Silver (30.34%), Shoes (29.57%) and Gold (23.46%).

Decreased: Diesel (6.05%), CNG (3.38%) and LPG (1.22%).

Increased: Chillies Powder (62.47%), Eggs (42.09%), Ginger (33.85%), Wheat (29.69%), Mango (25.73%), Chicken (24.20%), Potatoes (23.23%), Sugar (22.80%), Beans (22.41), Wheat Flour Bag (22.15%), Vegetable Ghee (21.82%), Pulse Mash (19.49%) and Pulse Masoor (15.94%).

**Decreased**: Onions (29.04%), Cauliflower (24.06%), Turnip (22.33%), Garlic (21.15%), Apple (14.49%), Peas (8.77%), Chillies (4.56%) and Fish (1.24%).

#### NON-FOOD:

Increased: Gold (23.66%) and Clinic Fee (17.76%).

**Decreased**: Diesel (6.12%), Kerosene Oil (3.27%), LPG (1.69%), CNG (1.55%) and Petrol (0.36%).
