

Inflation in Brief

1. **CPI inflation General**, decreased to 3.2% on year-on-year basis in June 2025 as compared to 3.5% of the previous month and 12.6% in June 2024. On month-on-month basis, it increased by 0.2% in June 2025 as compared to a decrease of 0.2% in the previous month and an increase of 0.5% in June 2024.
2. **CPI inflation Urban**, decreased to 3.0% on year-on-year basis in June 2025 as compared to 3.5% of the previous month and 14.9% in June 2024. On month-on-month basis, it remained stable at 0.1% in June 2025 as compared to 0.1% in the previous month and 0.6% in June 2024.
3. **CPI inflation Rural**, increased by 3.6% on year-on-year basis in June 2025 as compared to an increase of 3.4% in the previous month and 9.3% in June 2024. On month-on-month basis, it increased by 0.5% in June 2025 as compared to a decrease of 0.5% in the previous month and an increase of 0.3% in June 2024.
4. **SPI inflation** on YoY decreased by 1.9% in June 2025 as compared to a decrease of 0.6% a month earlier and an increase of 16.6% in June 2024. On MoM basis, no change measured in June 2025 as compared to a decrease of 1.0% a month earlier and an increase of 1.3% in June 2024.
5. **WPI inflation** on YoY basis increased by 0.6% in June 2025 as compared to an increase of 0.4% in the previous month and 10.6% in June 2024. On month-on-month basis, it increased to 0.6% in June, 2025 as compared to no change in the previous month and an increase of 0.4% in June 2024.




Figure 2: Rural Inflation - YoY, Special Indices

6. Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percentage changes in indices of last twenty-two months.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** decreased to 6.9% on (YoY) basis in June 2025 as compared to 7.3% of the previous month and 12.2% in June 2024. On (MoM) basis, it increased by 0.2% in June 2025 as compared to an increase of 0.4% measured in the previous month and an increase of 0.6% in the corresponding month of last year i.e. June, 2024.
8. Measured by **non-food non-energy Rural** decreased to 8.6% on (YoY) basis in June 2025 as compared to 8.8% of the previous month and 17.0% in June 2024. On (MoM) basis, it increased by 0.7% in June 2025 as compared to an increase of 0.4% measured in the previous month and an increase of 0.9% in corresponding month of last year i.e. June 2024.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** decreased to 4.7% on (YoY) basis in June 2025 as compared to 4.9% of the previous month and 10.3% in June 2024. On (MoM) basis, it increased by 0.3% in June 2025 as compared to an increase of 0.1% in the previous month and an increase of 0.6% in corresponding month of last year i.e. June 2024.
10. Measured by 20% **weighted trimmed mean Rural** increased by 5.2% on (YoY) basis in June 2025 as compared to an increase of 4.7% of the previous month and 11.0% in June 2024. On (MoM) basis, it increased by 0.5% in June 2025 as to compared a decrease of 0.2% in the previous month and an increase of 0.5% in corresponding month of last year i.e. June 2024.

Figure 1: Urban Inflation - YoY, Special Indices




Figure 3: Urban Inflation - MoM, Special Indices




Figure 4: Rural Inflation - MoM, Special Indices




Figure 5: CPI YoY (National, Urban, Rural)





Figure 6: CPI MoM (National, Urban, Rural)

Increased: Tomatoes (57.33%), Potatoes (25.74%), Onions (15.26%), Eggs (8.82%), Gur (2.75%), Rice (1.67%), Wheat Flour (1.53%), Sugar (1.52%), Fresh Fruits (1.38%), Milk Powder (0.78%), Milk Fresh (0.40%), Milk Products (0.35%), Pulse Moong (0.21%), Besan (0.21%), Meat (0.20%) and Pulse Gram (0.18%).

Decreased: Chicken (34.97%), Wheat Products (2.01%), Fresh Vegetables (1.62%), Mustard Oil (0.49%), Pulse Mash (0.31%), Cooking Oil (0.21%), Vegetable Ghee (0.19%) and Condiments & Spices (0.10%).

NON-FOOD:

Increased: Electricity Charges (5.52%), Major Tools & Equipments (1.61%), Transport Services (1.43%), Drugs & Medicines (1.28%), Motor Fuel (1.13%), Dental Services (1.11%), Construction Wage Rates (1.00%), Marriage Hall Charges (0.83%) and Plastic products (0.77%).

Decreased: Liquified Hydrocarbons (5.27%), Solid Fuel (0.58%), Text Books (0.11%), Construction Input Items (0.05%) and Stationery (0.05%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. June, 2024 are given below:

FOOD

Increased: Pulse Moong (30.71%), Fresh Fruits (25.48%), Eggs (25.20%), Sugar (24.07%), Milk Powder (22.51%), Honey (21.37%), Butter (18.74%), Condiments & Spices (16.94%), Vegetable Ghee (12.59%), Gur (11.42%), Meat (11.09%) and Besan (10.98%).

Decreased: Onions (56.53%), Tomatoes (23.19%), Pulse Mash (21.48%), Tea (17.75%), Wheat (17.11%), Wheat Flour (14.17%), Potatoes (10.31%), Fresh Vegetables (9.42%), Chicken (8.77%), Pulse Masoor (7.59%) and Wheat Products (6.80%).

NON-FOOD:

Increased: Motor Vehicle Tax (168.79%), Water Supply (14.84%), Liquified Hydrocarbons (14.19%), Household Textiles (13.96%) and Drugs & Medicines (13.05%).

Decreased: Electricity Charges (30.22%), Text Books (7.76%) and Motor Fuel (1.86%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for June 2025 is increased by **0.47%** over **May 2025** and increased by **3.58%** over corresponding month of the last year i.e. **June 2024**.

Increased: Tomatoes (53.15%), Potatoes (27.79%), Eggs (14.04%), Onions (9.16%), Gur (5.60%), Sugar (2.16%), Pulse Masoor, Rice and Wheat Flour (1.70%) each, Wheat (1.69%), Milk Powder (1.62%), Beverages (0.62%), Pulse Mash (0.56%).

Decreased: Chicken (26.45%), Condiments and Spices (1.84%), Fresh Vegetables (1.66%), Fresh Fruits (1.21%), Vegetable Ghee (1.11%), Cooking Oil (0.80%), Wheat Products (0.59%), Tea (0.54%), Besan (0.40%), Mustard Oil (0.29%) and Gram Whole (0.17%).

NON-FOOD

Increased: Electricity Charges (5.52%), Marriage Hall Charges (3.18%), Dental Services (1.54%), Medical Tests (1.52%), Doctor Clinic Fee (1.32%), Text Books (1.30%), Hospitals Services (1.27%), Motor Fuels (1.22%), Footware (1.09%), Major Tools and Equipments (1.04%), Transport Services (0.83%) and Education (0.77%).

Decreased: Liquified Hydrocarbons (3.43%) and Construction Input Items (0.33%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. June, 2024 are given below:

FOOD

Increased: Pulse Moong (30.49%), Eggs (27.80%), Fresh Fruits (26.95%), Milk Powder (25.94%), Sugar (24.26%), Honey (20.01%), Meat (16.5%), Besan (16.12%), Dry Fruits (13.69%), Vegetable Ghee (13.45%) and Cooking Oil (12.78%).

Decreased: Onions (63.08%), Potatoes (20.89%), Tomatoes (19.11%), Tea (17.39%), Fresh Vegetables (16.52%), Pulse Mash (15.43%), Wheat Flour (14.35%), Wheat (12.76%), Wheat Products (9.23%), Chicken (4.28%) and Pulse Masoor (3.14%).

NON-FOOD

Increased: Motor Vehicle Tax (126.61%), Dental Services (26.66%), Drugs and Medicines (15.30%), Recreation and Culture (13.21%), Doctor Clinic Fee (12.80%) and Education (12.77%).


Decreased: Electricity Charges (30.22%), Text Books (11.00%) and Motor Fuels (2.16%).

V. Wholesale Price Index

The Wholesale Price Index for **June 2025** increased by 0.59% over **May 2025** and increased by **0.58%** over the corresponding month of the last year i.e. **June, 2024**. YoY and MoM movements, from June, 2024 to June, 2025 are also graphed below in Figure 8.


