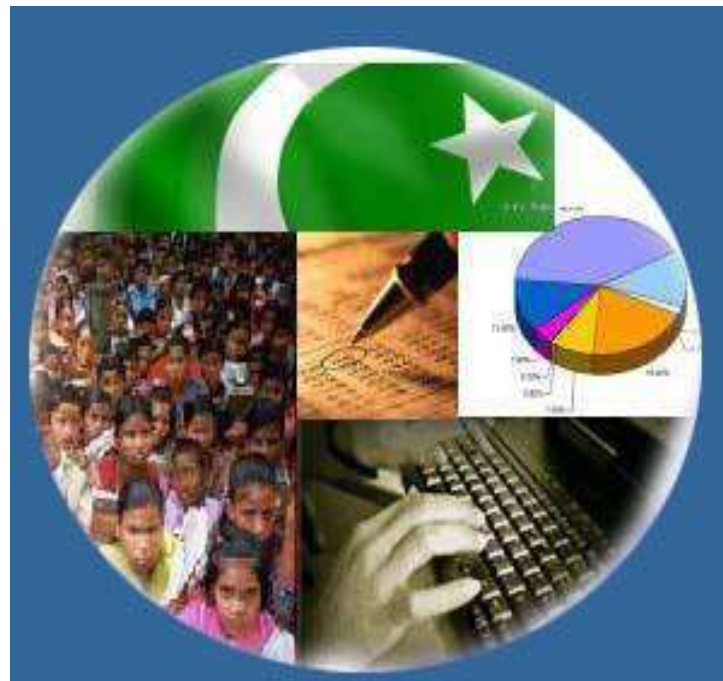

Inflation in Brief

- CPI inflation General**, increased to 4.1% on year-on-year basis in July 2025 as compared to 3.2% of the previous month and 11.1% in July 2024. On month-on-month basis, it increased by 2.9% in July 2025 as compared to an increase of 0.2% in the previous month and an increase of 2.1% in July 2024.
- CPI inflation Urban**, increased to 4.4% on year-on-year basis in July 2025 as compared to 3.0% of the previous month and 13.2% in July 2024. On month-on-month basis, it increased by 3.4% in July 2025 as compared to 0.1% in the previous month and an increase of 2.0% in July 2024.
- CPI inflation Rural**, increased by 3.5% on year-on-year basis in July 2025 as compared to an increase of 3.6% in the previous month and 8.1% in July 2024. On month-on-month basis, it increased by 2.2% in July 2025 as compared to an increase of 0.5% in the previous month and an increase of 2.2% in July 2024.
- SPI inflation** on YoY basis decreased by 0.9% in July 2025 as compared to a decrease of 1.9% a month earlier and an increase of 15.7% in July 2024. On MoM basis, it increased to 3.1% in July 2025 as compared to no change in a month earlier and an increase of 2.0% in July 2024.
- WPI inflation** on YoY basis decreased by 0.5% in July 2025 as compared to an increase of 0.6% in the previous month and 10.4% in July 2024. On month-on-month basis, it increased to 1.2% in July 2025 as compared to 0.6% in the previous month and an increase of 2.3% in July 2024.

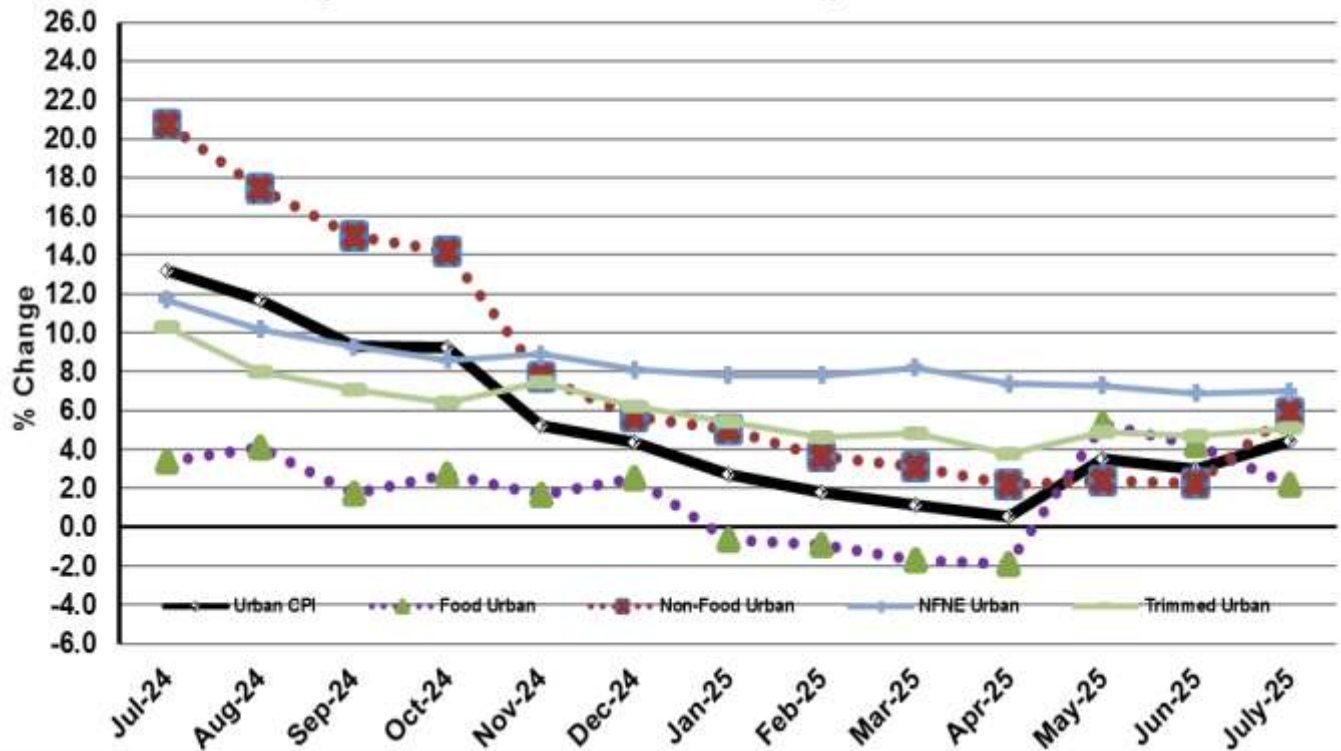


Figure 2: Rural Inflation - YoY, Special Indices

- Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows “YoY” percentage changes in indices.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** increased to 7.0% on (YoY) basis in July 2025 as compared to 6.9% of the previous month and 11.7% in July 2024. On (MoM) basis, it increased by 0.8% in July 2025 as compared to an increase of 0.2% measured in the previous month and an increase of 0.7% in the corresponding month of last year i.e. July 2024.
8. Measured by **non-food non-energy Rural** increased by 8.1% on (YoY) basis in July 2025 as compared to 8.6% of the previous month and 16.9% in July 2024. On (MoM) basis, it remained stable at 0.7% in July 2025 as compared to the previous month and an increase of 1.1% in corresponding month of last year i.e. July 2024.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** increased to 5.1% on (YoY) basis in July 2025 as compared to 4.7% of the previous month and 10.3% in July 2024. On (MoM) basis, it increased by 1.0% in July 2025 as compared to an increase of 0.3% in the previous month and an increase of 1.2% in corresponding month of last year i.e. July 2024.
10. Measured by 20% **weighted trimmed mean Rural** increased by 4.9% on (YoY) basis in July 2025 as compared to an increase of 5.2% of the previous month and 11.3% in July 2024. On (MoM) basis, it increased by 0.7% in July 2025 as compared to an increase of 0.5% in the previous month and an increase of 1.7% in corresponding month of last year i.e. July 2024.

Figure 1: Urban Inflation - YoY, Special Indices

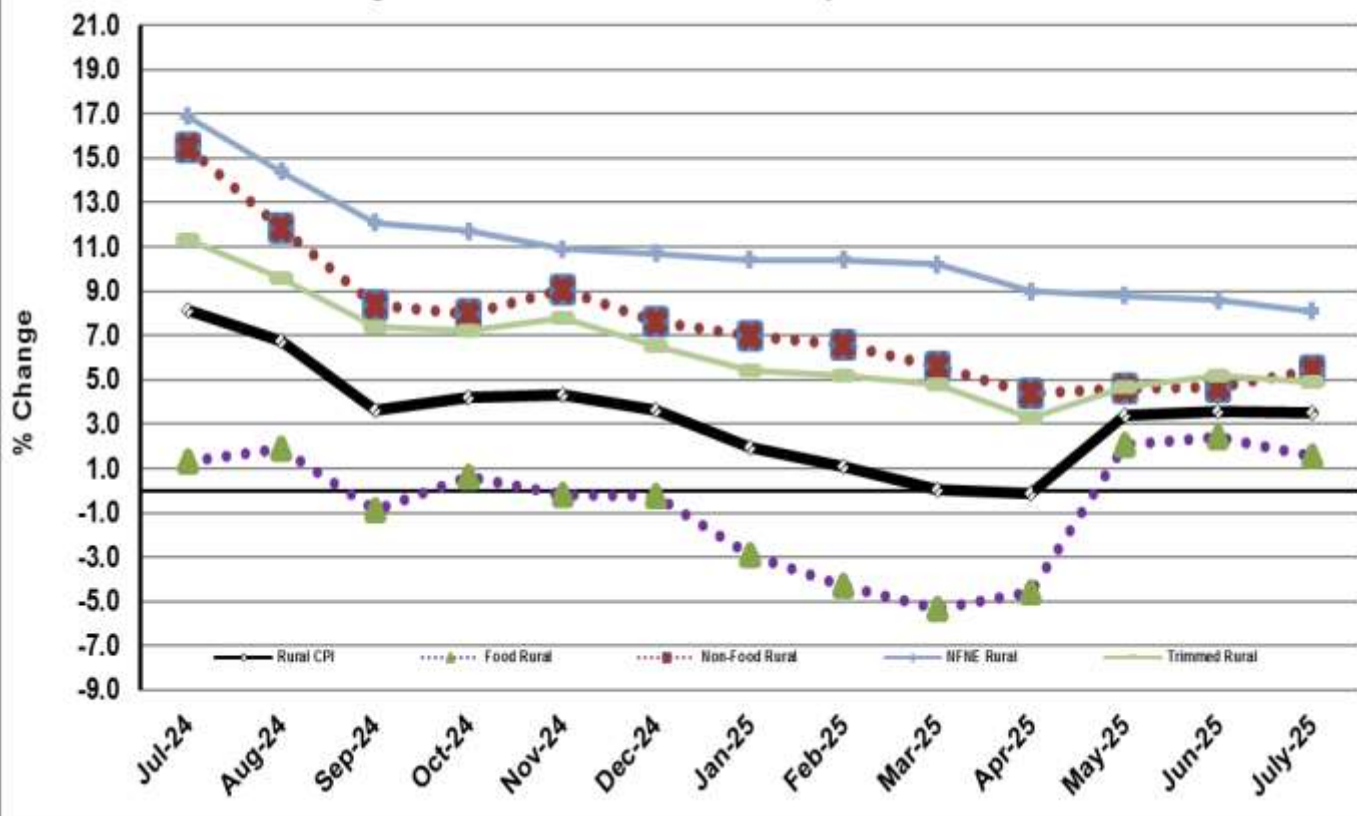


Figure 3: Urban Inflation - MoM, Special Indices

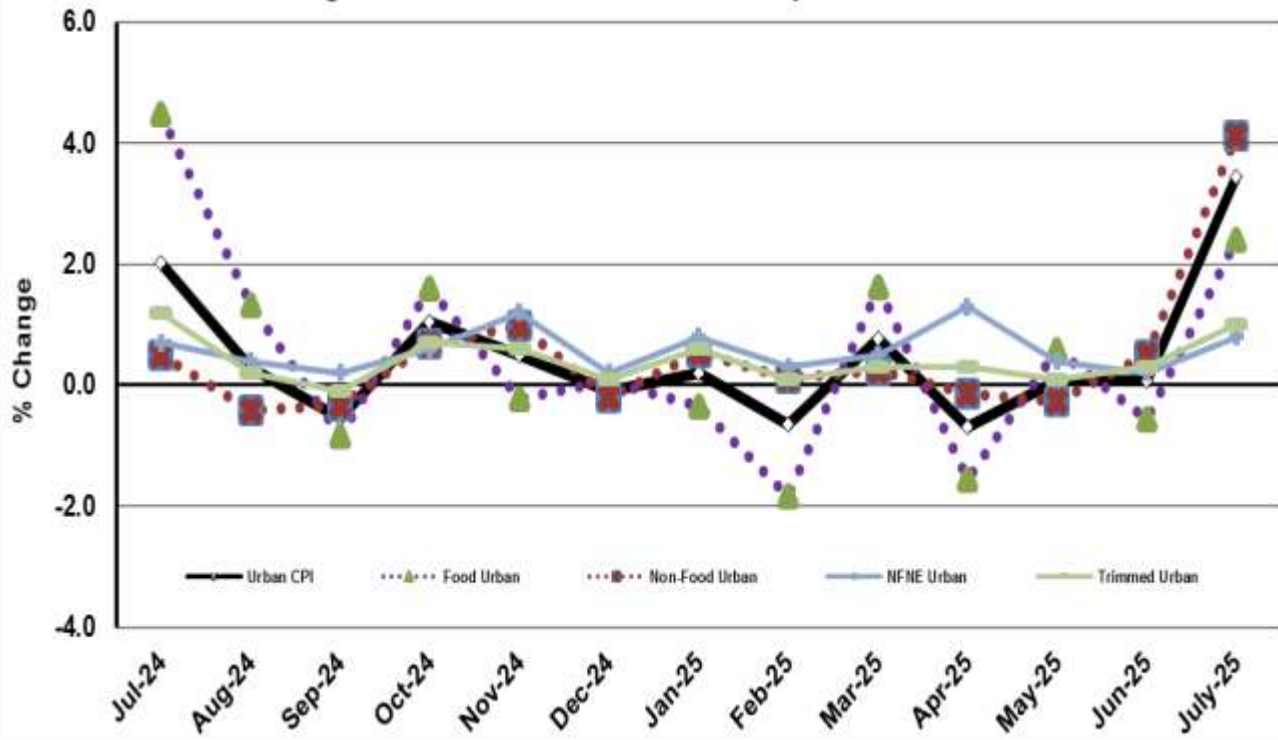


Figure 4: Rural Inflation - MoM, Special Indices

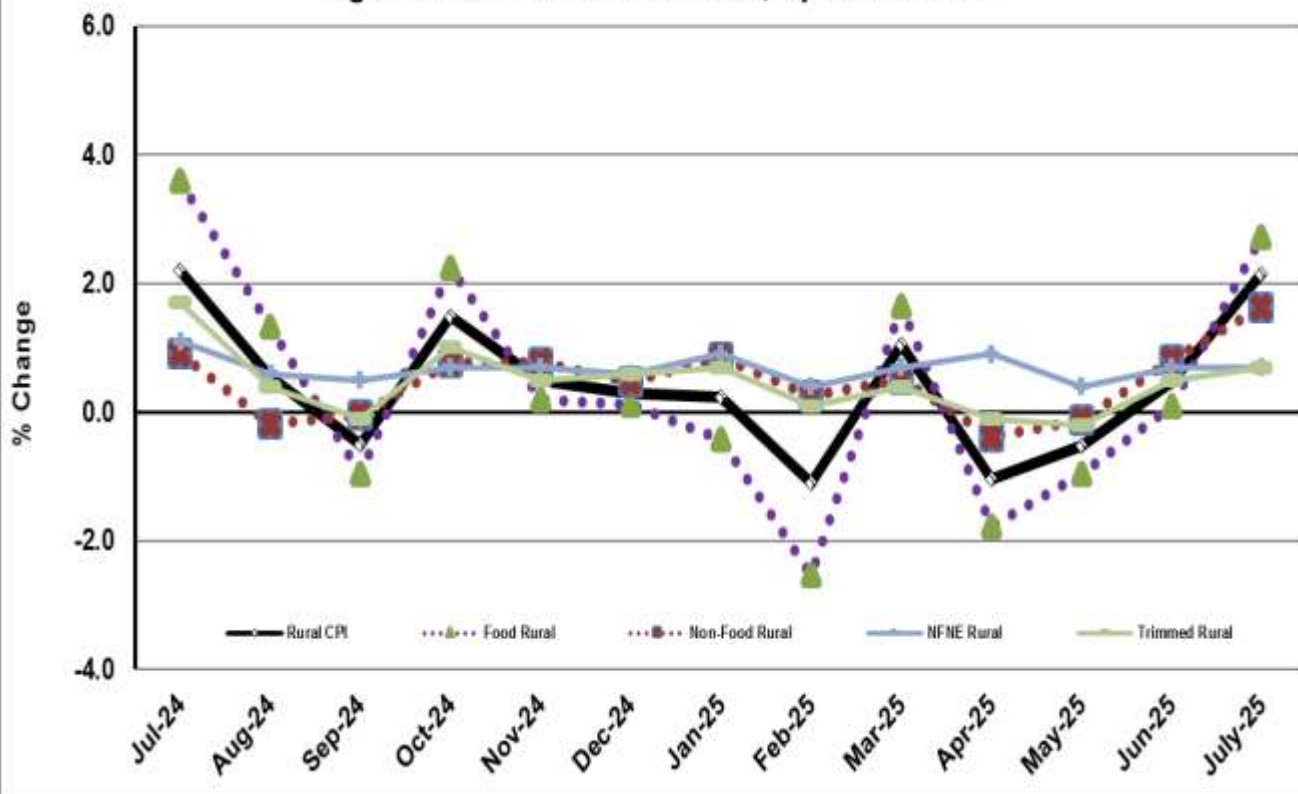


Figure 5: CPI YoY (National, Urban, Rural)

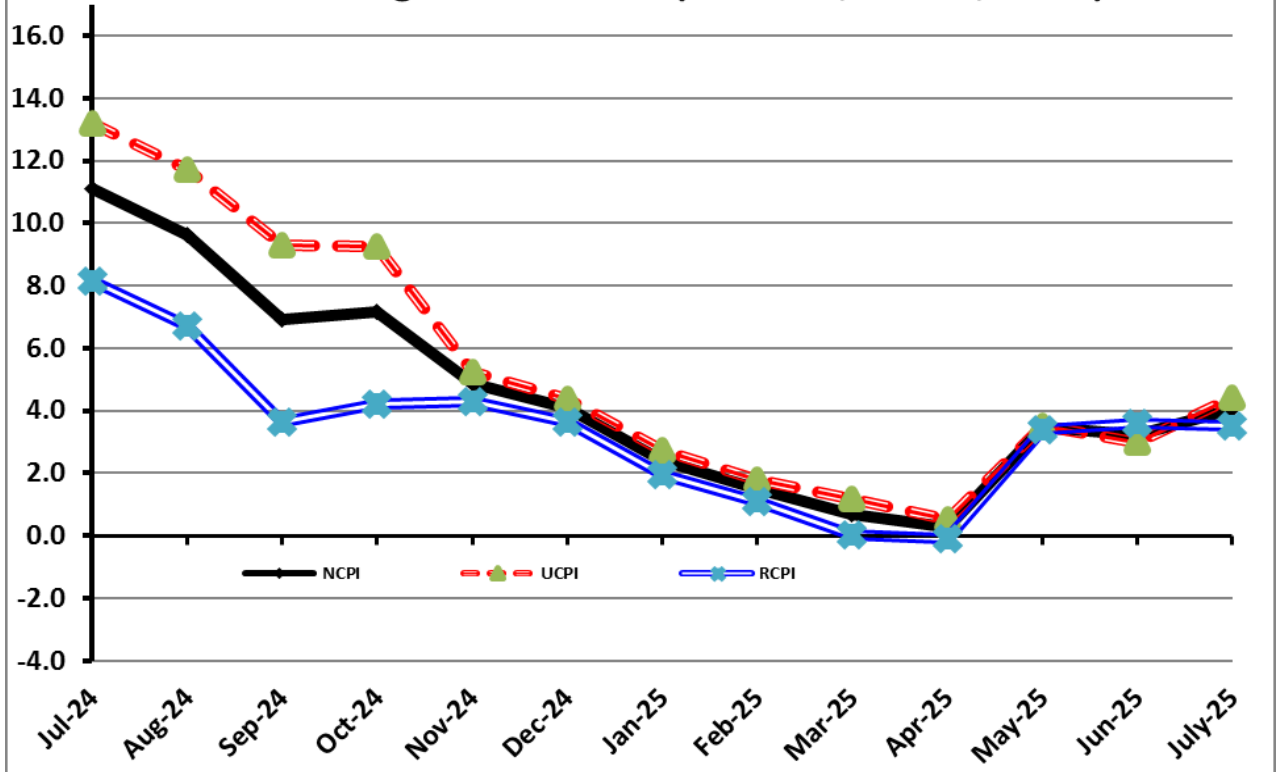
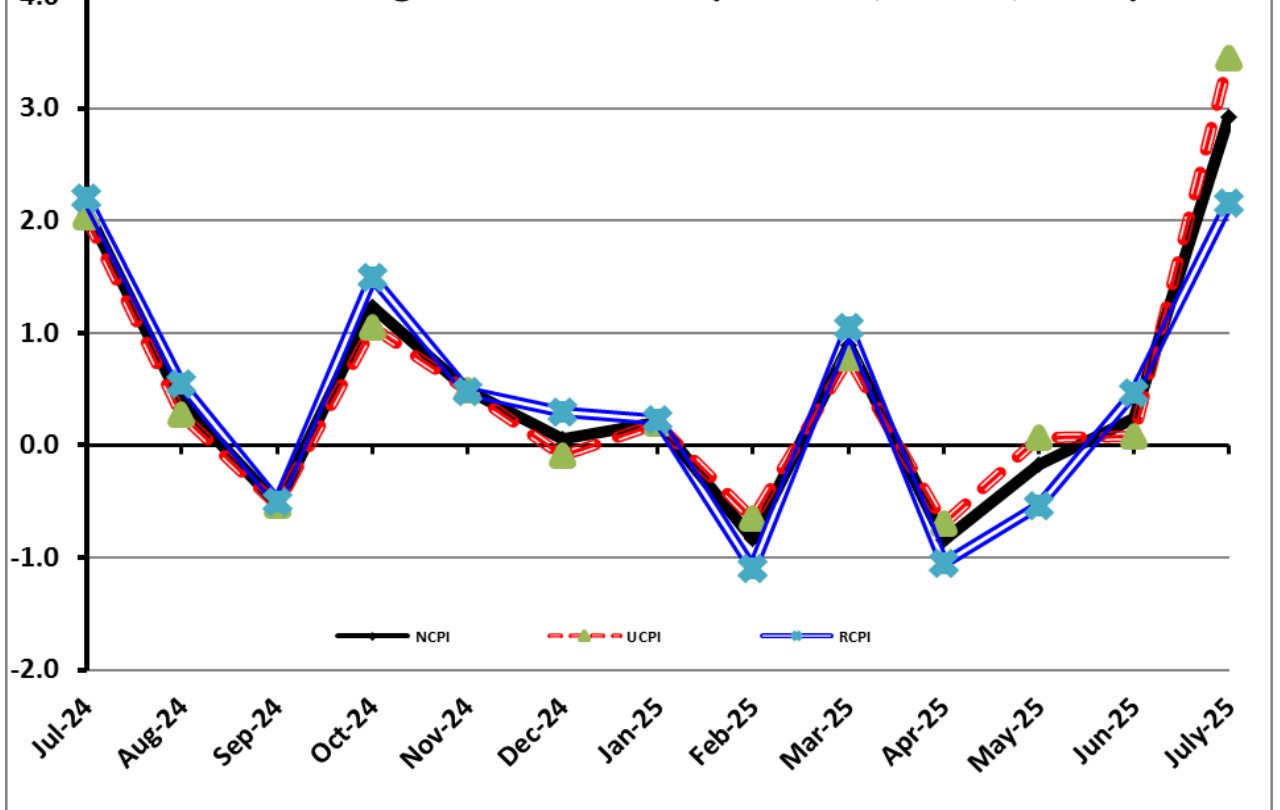


Figure 6: CPI MoM (National, Urban, Rural)



I. National Consumer Price Index (N-CPI)

The **National Consumer Price Index** for **July 2025** is increased by **2.92%** over **June 2025** and increased by **4.07%** over corresponding month of the last year i.e. **July 2024**.

Increased: Fresh Vegetables (45.76%), Chicken (29.73%), Tomatoes (19.92%), Potatoes (10.97%), Onions (9.36%), Sugar (6.11%), Gur (3.48%), Rice (1.46%), Meat (0.61%), Butter (0.55%), Milk Powder (0.48%), Pulse Masoor (0.46%), Milk Products (0.33%), Milk Fresh (0.28%) and Pulse Gram (0.26%).

Decreased: Eggs (14.85%), Fresh Fruits (7.17%), Wheat Flour (1.03%), Condiments and Spices (0.97%), Besan (0.93%), Beans (0.83%), Cooking Oil (0.66%), Pulse Moong (0.59%), Wheat Products (0.56%), Wheat (0.45%), Gram Whole (0.06%), Vegetable Ghee (0.03%) and Fish (0.02%).

NON-FOOD:

Increased: Gas Charges (22.91%), Electricity Charges (14.18%), Transport Services (4.77%), Motor Fuel (4.45%), Plastic Products (3.74%), Household Servant (2.57%), Cleaning and Laundering (1.50%), House Rent (1.45%), Liquified Hydrocarbons (1.26%), Motor Vehicles (1.14%) and Construcion Input Items (0.77%).

Decreased: Washing Soap/Detergents/Match Box (0.73%).

YEAR-ON-YEAR: Top few commodities, which varied from corresponding month of previous year i.e. July 2024, are given below:

FOOD

Increased: Sugar (29.43%), Pulse Moong (19.49%), Butter (18.9%), Honey (18.68%), Condiments and Spices (14.95%), Gur (14.11%), Vegetable Ghee (12.29%), Fresh Fruits (11.56%), Meat (11.14%), Sweetmeat (10.29%), Mustard Oil (8.98%), Chicken (7.7%), Readymade Food (7.64%), Fish (7.25%) and Cooking Oil (7.05%).

Decreased: Tomatoes (47.61%), Onions (47.36%), Pulse Mash (23.20%), Wheat Flour (21.52%), Wheat (21.29%), Tea (17.75%), Wheat Products (9.98%), Pulse Masoor (9.22%), Potatoes (7.76%), Pulse Gram (6.53%), Gram Whole (4.82%), Besan (2.97%) and Beans (1.60%).

NON-FOOD:

Increased: Motor Vehicle Tax (168.79%), Gas Charges (22.91%), Water Supply (13.86%), Household Textiles (13.45%), Footwear (12.71%) and Drugs & Medicines (12.27%).

Decreased: Electricity Charges (16.85%), Text Books (7.75%), Liquified Hydrocarbons (2.24%), Washing Soap, Detergents & Match Box (2.19%) and Motor Fuel (0.14%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for July 2025 is increased by 2.15% over June 2025 and increased by 3.53% over corresponding month of the last year i.e. July 2024.

Increased: Fresh Vegetables (56.29%), Tomatoes (25.59%), Chicken (23.03%), Onions (11.28%), Potatoes (10.95%), Sugar (6.02%), Gur (4.40%), Milk Powder (1.20%), Readymade Food (1.17%), Besan (0.83%), Meat (0.78%), Butter (0.58%) and Beverages (0.42%).

Decreased: Eggs (15.07%), Fresh Fruits (7.09%), Wheat Products (2.07%), Wheat Flour (1.49%), Wheat and Pulse Mash (1.04%) each, Condiments and Spices (1.02%), Fish (0.83%), Pulse Gram (0.82%), Mustard Oil (0.71%), Tea (0.69%), Beans (0.61%), Pulse Moong (0.60%), Gram Whole (0.53%), Pulse Masoor (0.32%), Rice (0.03%) and Dry Fruits (0.03%).

NON-FOOD

Increased: Electricity Charges (14.18%), Motor Fuels (4.78%), Doctor Clinic Fee (2.75%), Transport Services (2.11%), House Rent (1.57%), Readymade Garments (1.45%), Plastic Products (1.29%), Communication Apparatus (0.81%), Cotton Cloth (0.79%) and Motor Vehicles (0.77%).

Decreased: Washing Soaps, Detergents and Match Box (0.08%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. July, 2024 are given below:

FOOD

Increased: Sugar (29.53%), Honey (20.19%), Pulse Moong (19.49%), Fresh Vegetables (17.16%), Meat (16.41%), Chicken (13.06%), Vegetable Ghee (13.02%), Butter (12.09%), Fresh Fruits (12.02%), Gur (11.38%), Cooking Oil (10.96%) and Eggs (9.68%).

Decreased: Onions (53.93%), Tomatoes (50.15%), Wheat Flour (22.24%), Wheat (19.10%), Pulse Mash (18.39%), Tea (17.95%), Potatoes (17.44%), Wheat Products (11.41%), Pulse Masoor (5.76%) and Pulse Gram (3.33%).

NON-FOOD

Increased: Motor Vehicle Tax (126.61%), Readymade Garments (13.90%), Drugs and Medicines (13.64%), Doctor Clinic Fee (13.42%) and Education (12.98%).

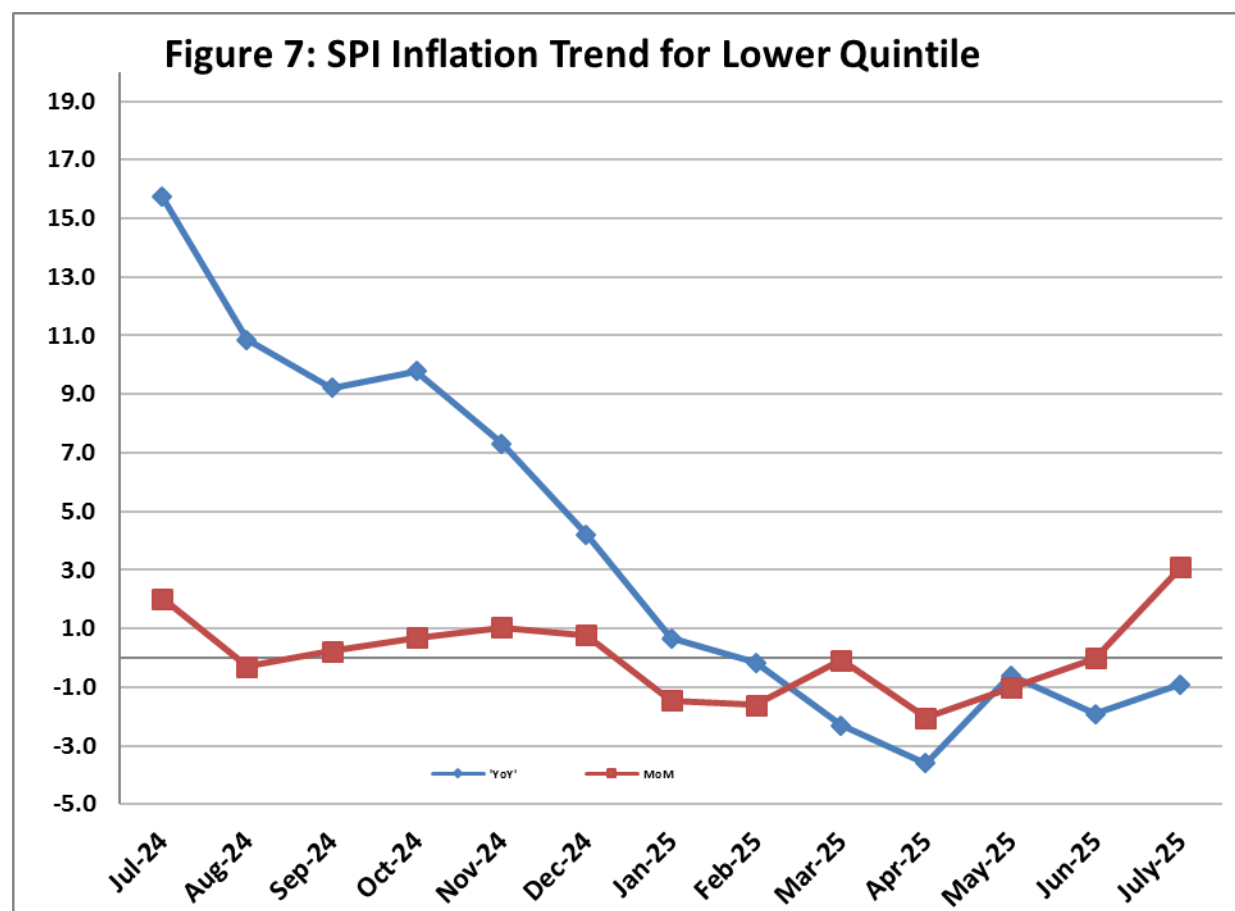
Decreased: Electricity Charges (16.85%), Text Books (10.98%), Liquified Hydrocarbons (1.94%) and Motor Fuels (0.2%).

V. Wholesale Price Index

The Wholesale Price Index for **July 2025** increased by 1.19% over **June 2025** and decreased by **-0.49%** over the corresponding month of the last year i.e. **July, 2024**. YoY and MoM movements, from July, 2024 to July, 2025 are also graphed below in Figure 8.

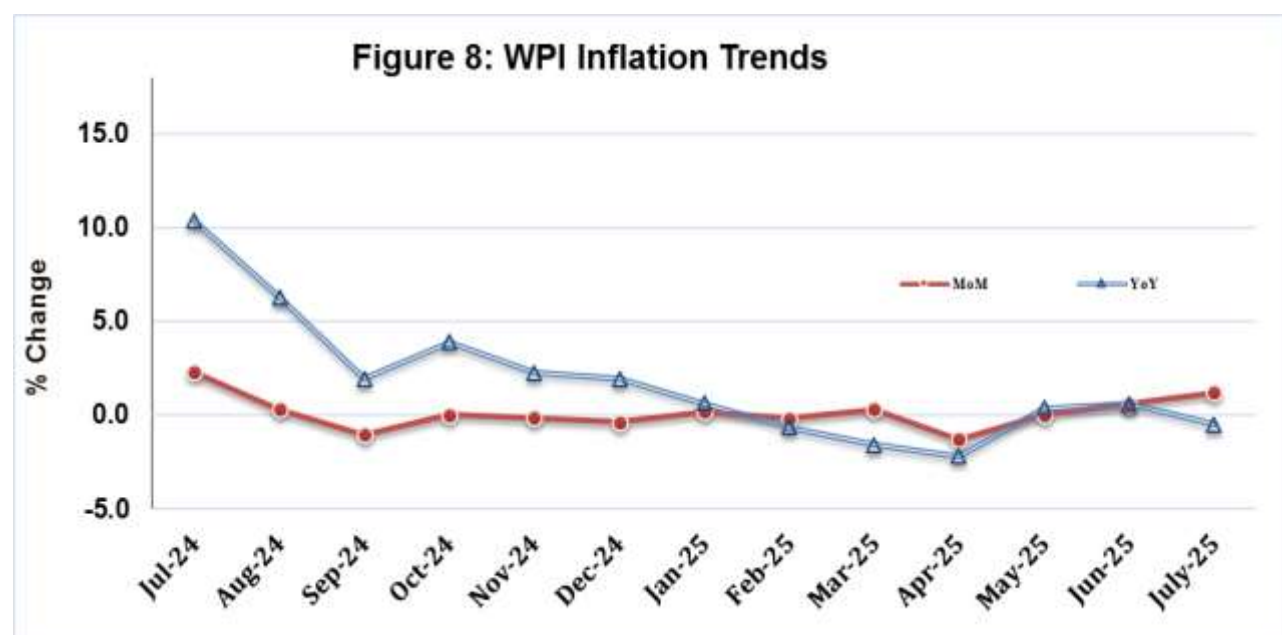
