

Inflation in Brief

1. **CPI inflation General**, increased to 3.5% on year-on-year basis in May 2025 as compared to 0.3% of the previous month and 11.8% in May 2024. On month-on-month basis, it decreased by 0.2% in May 2025 as compared to a decrease of 0.8% in the previous month and a decrease of 3.2% in May 2024.
2. **CPI inflation Urban**, increased to 3.5% on year-on-year basis in May 2025 as compared to 0.5% of the previous month and 14.3% in May 2024. On month-on-month basis, it increased to 0.1% in May 2025 as compared to a decrease of 0.7% in the previous and a decrease of 2.8% in May 2024.
3. **CPI inflation Rural**, increased to 3.4% on year-on-year basis in May 2025 as compared to a decrease of 0.1 in the previous month and 8.2% in May 2024. On month-on-month basis, it decreased by 0.5% in May 2025 as compared to a decrease of 1.0% in the previous month and a decrease of 3.9% in May 2024.
4. **SPI inflation** on YoY decreased by 0.6% in May 2025 as compared to a decrease of 3.6% a month earlier and 15.3% in May 2024. On MoM basis, it decreased by 1.0% in May 2025 as compared to a decrease of 2.1% a month earlier and a decrease of 4.0% in May 2024.
5. **WPI inflation** on YoY basis increased to 0.4% in May 2025 as compared to a decrease of 2.2% in the previous month and 9.9% in May 2024. On Month-on-Month basis no change measured in May, 2025 as compared to a decrease of 1.3% in the previous month and a decrease of 2.5% of the corresponding month of last year i.e. May 2024.




Figure 2: Rural Inflation - YoY, Special Indices

6. Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percentage changes in indices of last twenty-two months.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** slightly decreased to 7.3% on (YoY) basis in May 2025 as compared to 7.4% of the previous month and an increase of 12.3% in May 2024. On (MoM) basis, it decreased by 0.4% in May 2025 as compared to 1.3% measured in the previous month and an increase of 0.4% in corresponding month of last year i.e. May, 2024.
 8. Measured by **non-food non-energy Rural** decreased to 8.8% on (YoY) basis in May 2025 as compared to 9.0% of the previous month and an increase of 17.0% in May 2024. On (MoM) basis, it decreased to 0.4% in May 2025 as compared to an increase of 0.9% measured in the previous month and an increase of 0.5% in corresponding month of last year i.e. May 2024.
- Core inflation (Trimmed)**
9. Measured by 20% **weighted trimmed mean Urban** increased by 4.9% on (YoY) basis in May 2025 as compared to 3.8% of the previous month and 11.0% in May 2024. On (MoM) basis, it increased by 0.1% in May 2025 as compared to an increase of 0.3% in the previous month and a decrease of 0.5% in corresponding month of last year i.e. May 2024.
 10. Measured by 20% **weighted trimmed mean Rural** increased by 4.7% on (YoY) basis in May 2025 as compared to 3.3% of the previous month and 10.6% in May 2024. On (MoM) basis, it decreased by 0.2% in May 2025 as to compared a decrease of 0.1% in the previous month and a decrease of 0.9% in corresponding month of last year i.e. May 2024.

Figure 1: Urban Inflation - YoY, Special Indices




Figure 3: Urban Inflation - MoM, Special Indices




Figure 4: Rural Inflation - MoM, Special Indices




Figure 5: CPI YoY (National, Urban, Rural)





Figure 6: CPI MoM (National, Urban, Rural)

The **National Consumer Price Index** for **May 2025** is decreased by **0.17%** over **April 2025** and increased by **3.46%** over corresponding month of the last year i.e. **May 2024**.

FOOD

Increased: Eggs (24.38%), Chicken (8.63%), Condiments and Spices (5.50%), Sugar (4.07%), Gur (3.66%), Milk Powder (2.80%), Potatoes (1.64%), Butter (1.31%), Fresh Fruits (1.21%), Pulse Gram (1.09%), Beverages (0.87%), Meat (0.82%), Sweetmeat (0.79%) and Pulse Moong (0.53%).

Decreased: Tomatoes (20.80%), Onions (12.05%), Wheat (7.32%), Wheat Flour (5.94%), Vegetable Ghee (1.41%), Wheat Products (1.27%), Pulse Mash (0.92%), Cooking Oil (0.89%), Beans (0.85%), Tea (0.77%), Mustard Oil (0.67%), Fish (0.42%), Gram Whole (0.31%) and Rice (0.21%).

NON-FOOD:

Increased: Cotton Cloth (3.20%), Motor Vehicles (1.86%), Postal Services (1.74%), Major Tools & Equipments (1.23%), Readymade Garments (1.02%), Tailoring (0.95%) and Cleaning & Laundry (0.65%).

Decreased: Text Books (8.59%), Electricity Charges (7.03%), Liquified Hydrocarbons (3.81%), Motor Fuel (0.67%) and Solid Fuel (0.50%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. May, 2024 are given below:

FOOD

Increased: Chicken (51.96%), Pulse Moong (31.13%), Fresh Fruits (29.5%), Butter (26.15%), Milk Powder (21.80%), Sugar (21.71%), Honey (21.23%), Condiments & Spices (19.98%), Pulse Gram (18.25%), Besan (17.84%), Vegetable Ghee (12.75%), Meat (11.77%) and Milk Fresh (10.68%).

Decreased: Onions (54.46%), Tomatoes (32.16%), Potatoes (23.9%), Wheat (23.79%), Wheat Flour (23.01%), Pulse Mash (18.69%), Tea (17.75%), Wheat Products (12.26%), Fresh Vegetables (9.89%), Pulse Masoor (9.75%) and Rice (3.83%).

NON-FOOD:

Increased: Motor Vehicle Tax (168.79%), Personal Effects (33.24%), Electrical Appliances (17.63%), Water Supply (14.84%), Hosiery (14.41%), Household Textiles (14.30%), Drugs & Medicines (14.04%) and Medical Tests (13.56%).

Decreased: Electricity Charges (28.51%), Motor Fuel (8.24%), Text Books (5.12%) and Washing Soap/Detergents/Match Box (0.55%).

III. Rural Consumer Price Index (RCPI)

The Rural Consumer Price Index for May 2025 is decreased by 0.53% over April 2025 and increased to 3.39% over corresponding month of the last year i.e. May 2024.

FOOD

Increased: Eggs (19.27%), Fresh Fruits (5.07%), Condiments and Spices (4.91%), Sugar (2.90%), Gur (2.42%), Pulse Gram (1.36%), Pulse Moong (0.77%), Milk Fresh (0.61%), Dry Fruits (0.59%), Meat (0.59%), Milk Powder (0.58%), Readymade Food (0.43%), Honey (0.40%) and Milk Products (0.18%).

Decreased: Tomatoes (32.99%), Onions (18.37%), Wheat Flour (10.52%), Fresh Vegetables (7.26%), Wheat (6.73%), Potatoes (5.47%), Wheat Products (3.25%), Mustard Oil (2.66%), Chicken (1.49%), Cooking Oil (1.25%), Pulse Mash (1.07%) and Vegetable Ghee (0.99%).

NON-FOOD

Increased: Dental Services (5.97%), Personal Effects (4.16%), Doctor Clinic Fee (3.15%), Education (1.59%), Furniture and Furnishing (1.46%), Water Supply (1.20%), Footwear (1.12%), Readymade Garments (0.84%), Plastic Products (0.74%) and Solid Fuel (0.69%).

Decreased: Text Books (13.20%), Electricity Charges (7.03%), Liquified Hydrocarbons (1.51%), Motor Fuels (0.72%) and Construction Input Items (0.05%).

YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. May, 2024 are given below:

FOOD

Increased: Chicken (46.05%), Pulse Moong (31.39%), Fresh Fruits (31.13%), Milk Powder (25.13%), Besan (22.56%), Sugar (21.44%), Pulse Gram (20.80%), Honey (20.01%), Meat (18.38%), Vegetable Ghee (14.57%), Dry Fruits (14.44%) and Cooking Oil (12.64%).

Decreased: Onions (59.18%), Potatoes (34.28%), Tomatoes (33.97%), Wheat (25.01%), Wheat Flour (23.87%), Tea (16.94%), Wheat Products (14.16%), Pulse Mash (13.43%), Fresh Vegetables (12.68%), Pulse Masoor (5.05%), Rice (4.00%) and Bakery & Confectionary (0.17%).

NON-FOOD

Increased: Motor Vehicle Tax (126.61%), Personal Effects (37.47%), Dental Services (24.74%), Drugs and Medicines (16.33%), Recreation and Culture (15.87%), Woolen Readymade Garments (15.39%), Education (13.05%) and Construction Input Items (12.28%).

Decreased: Electricity Charges (28.51%), Motor Fuels (8.98%) and Text Books (5.13%).

Quintile-wise percentage changes YoY and MoM are given below in Table 4. The series from May 2024 to May 2025 is also graphed below in Figure 7.




