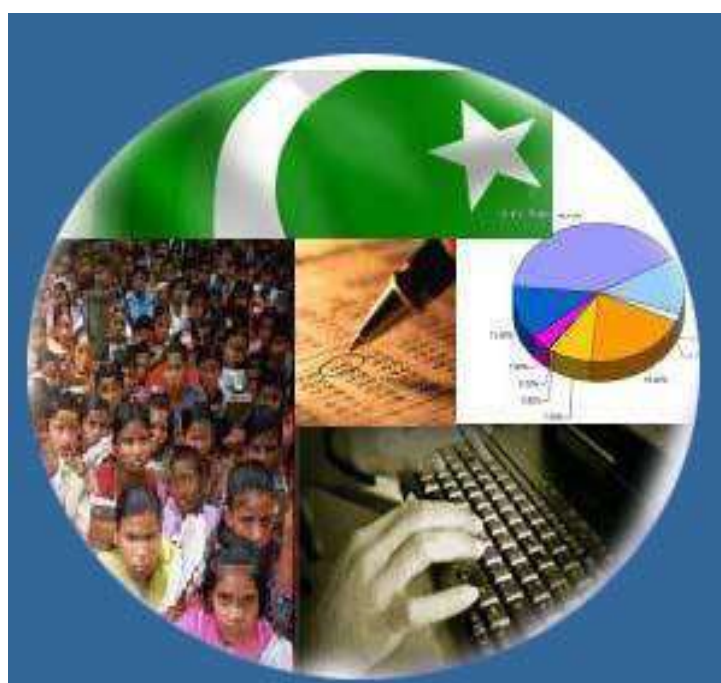

Inflation in Brief

- CPI inflation General**, increased by 12.3% on year-on-year basis in December 2021 as compared to an increase of 11.5% in the previous month and 8.0% in December 2020. On month-on-month basis, it decreased by -0.02% in December 2021 as compared to increase of 3.0% in the previous month and a decrease of -0.7% in December 2020.
- CPI inflation Urban**, increased by 12.7% on year-on-year basis in December 2021 as compared to an increase of 12.0% in the previous month and 7.0% in December 2020. On month-on-month basis, it increased by 0.3% in December 2021 as compared to increase of 2.9% in the previous month and a decrease of -0.3% in December 2020.
- CPI inflation Rural**, increased by 11.6% on year-on-year basis in December 2021 as compared to an increase of 10.9% in the previous month and 9.5% in December 2020. On month-on-month basis, it decreased by -0.5% in December 2021 as compared to increase of 3.1% in the previous month and a decrease of -1.2% in December 2020.
- SPI inflation** on YoY increased by 20.9% in December 2021 as compared to an increase of 18.1% a month earlier and an increase of 9.1% in December 2020. On MoM basis, it decreased by -0.4% in December 2021 as compared to increase of 3.6% a month earlier and a decrease of -2.7% in December 2020.
- WPI inflation** on YoY basis increased by 26.2% in December 2021 as compared to an increase of 27.0% a month earlier and an increase of 5.7% in December 2020. WPI inflation on MoM basis decreased by -0.2% in December 2021 as compared to an increase of 3.8% a month earlier and an increase of 0.3% in corresponding month i.e. December 2020.

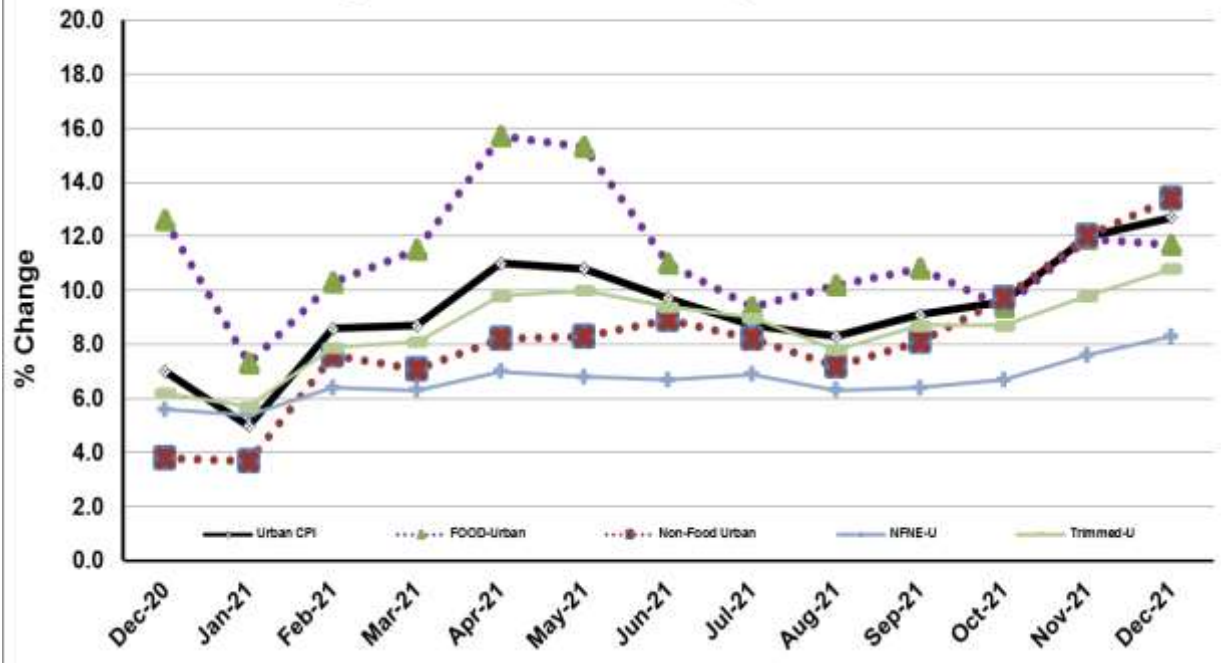
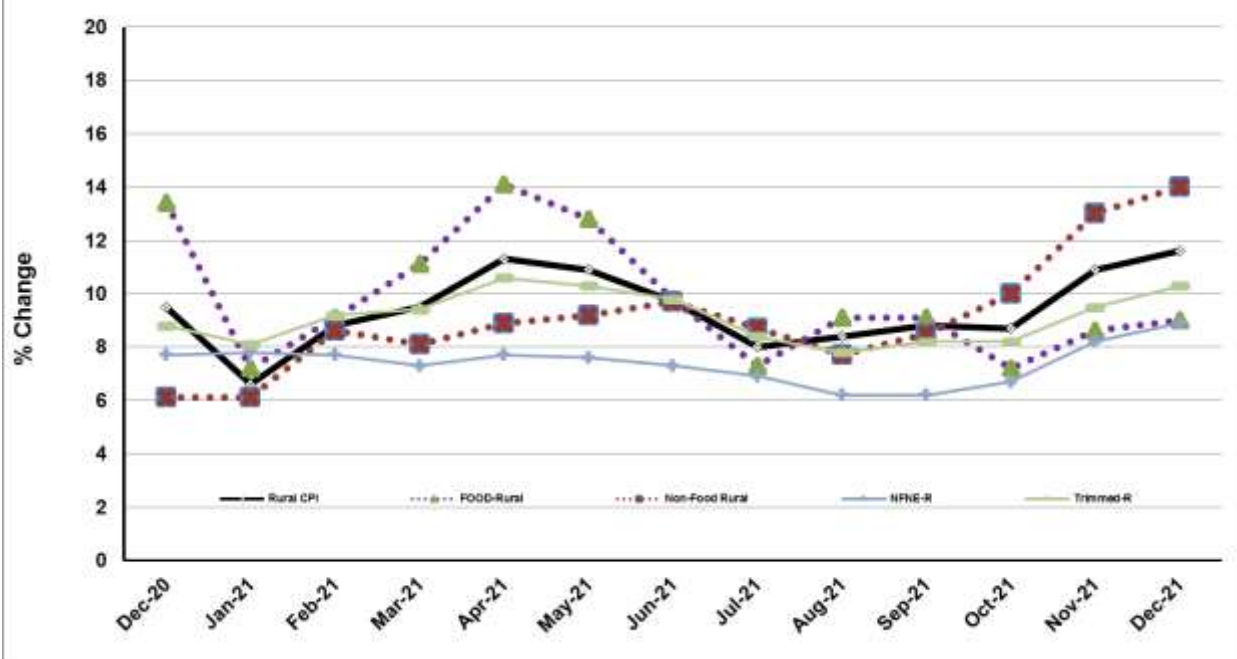


Figure 2: Rural Inflation - YoY, Special Indices

- Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percent changes in indices of three years.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban** increased by 8.3% on (YoY) basis in December, 2021 as compared to an increase of 7.6% in the previous month and 5.6% in December, 2020. On (MoM) basis, it increased by 1.1% in December, 2021 as compared to increase of 1.1% in previous month, and an increase of 0.4% in corresponding month of last year i.e. December, 2020.
8. Measured by **non-food non-energy Rural** increased by 8.9% on (YoY) basis in December, 2021 as compared to an increase of 8.2% in the previous month and 7.7% in December, 2020. On (MoM) basis, it increased by 1.1% in December, 2021 as compared to an increase of 1.8% in previous month, and an increase of 0.5% in corresponding month of last year i.e. December, 2020.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban** increased by 10.8% on (YoY) basis in December, 2021 as compared to 9.8% in the previous month and 6.2% in December, 2020. On (MoM) basis, it increased by 1.1% in December, 2021 as compared to an increase of 1.7% in the previous month and an increase of 0.4% in corresponding month of last year i.e. December, 2020.
10. Measured by 20% **weighted trimmed mean Rural** increased by 10.3% on (YoY) basis in December, 2021 as compared to 9.5% in the previous month and by 8.8% in December, 2020. On (MoM) basis, it increased by 1.0% in December, 2021 as compared to an increase of 2.2% in the previous month and an increase of 0.6% in corresponding month of last year i.e. December, 2020.

Figure 1: Urban Inflation - YoY, Special Indices

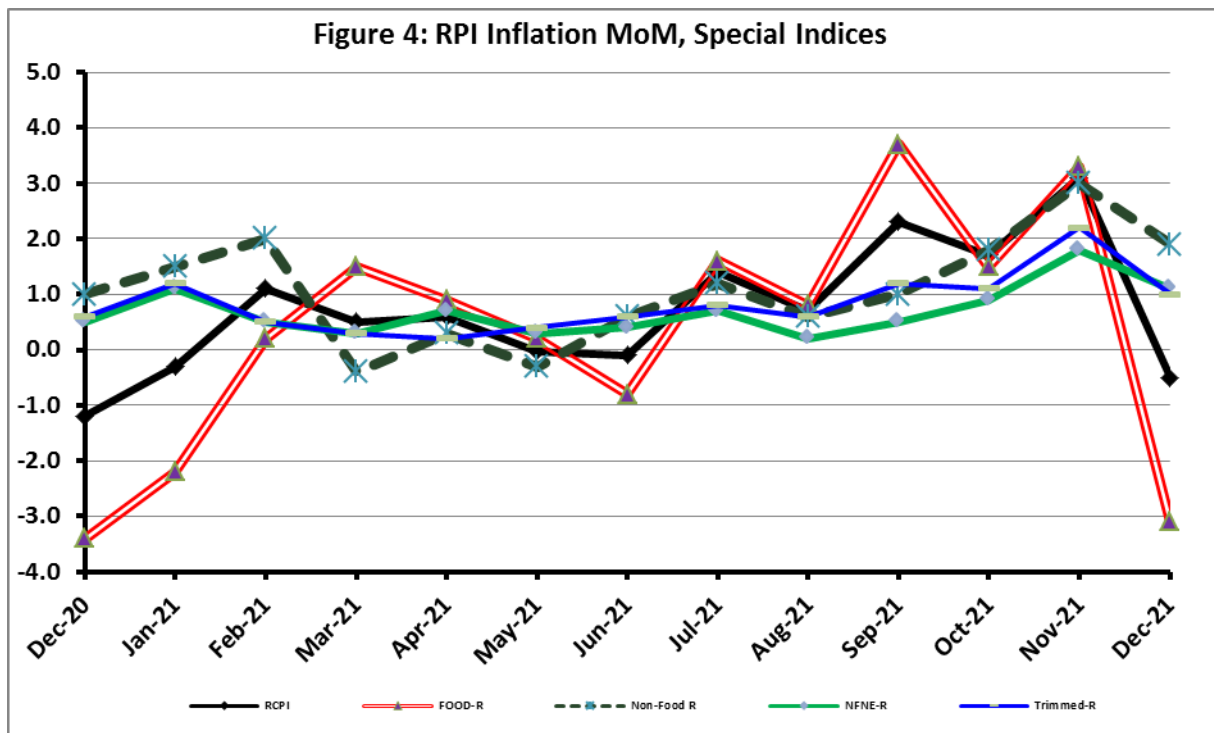
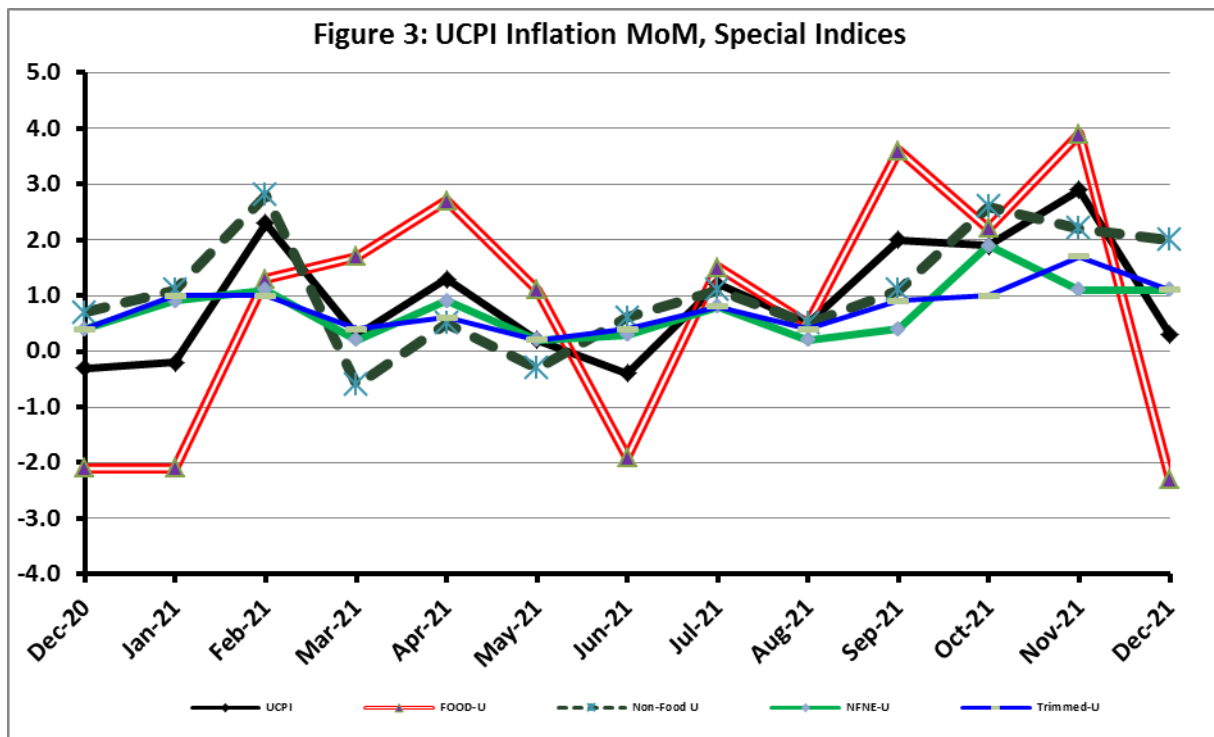


Figure 5: CPI Y.o.Y (National, Urban, Rural)

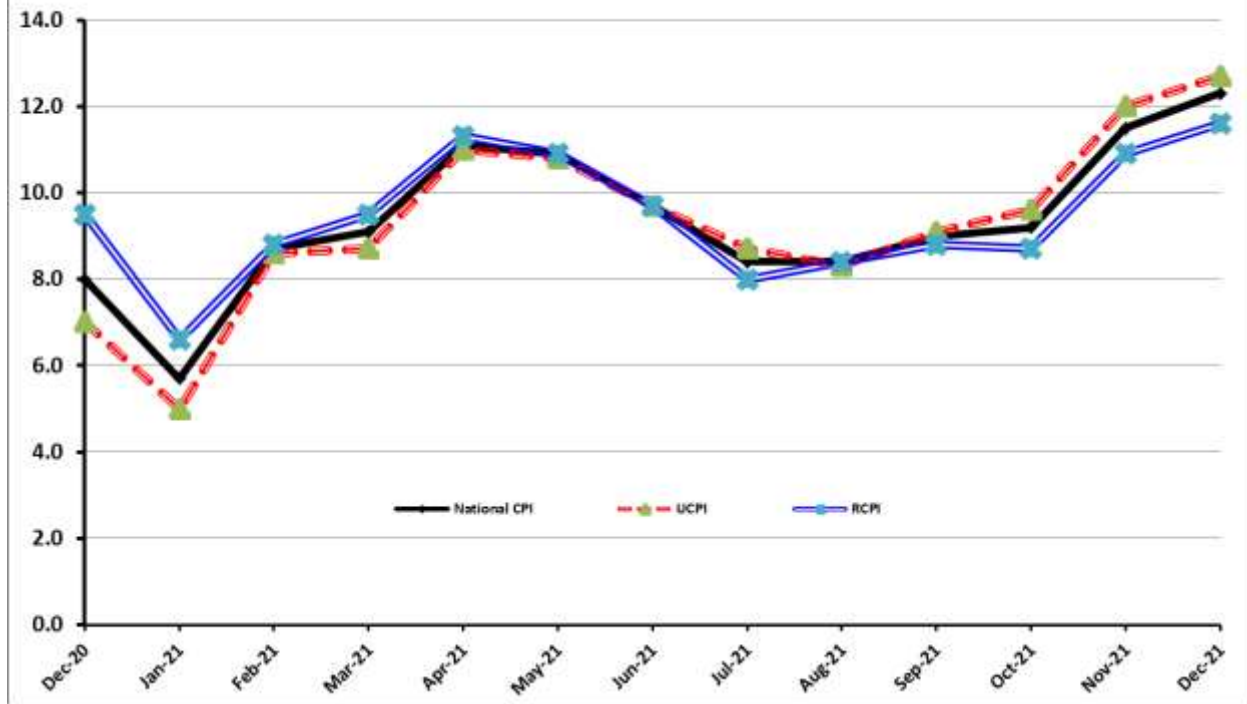
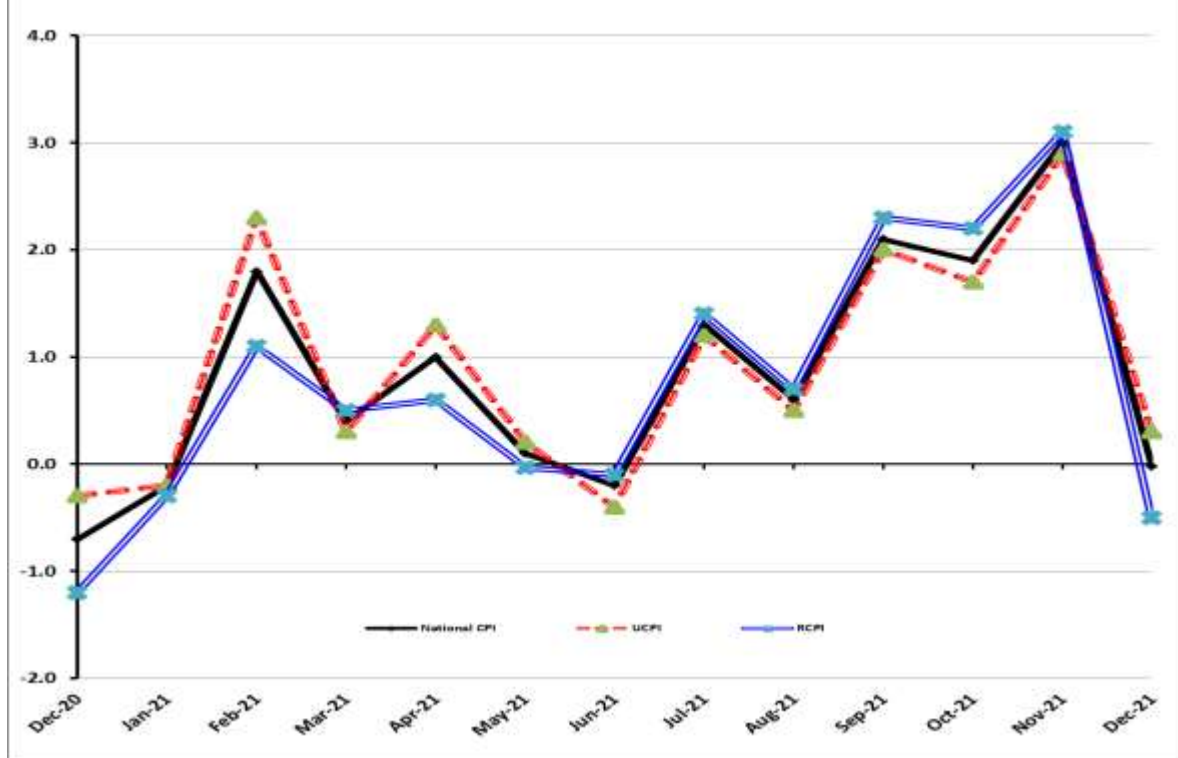


Figure 6: CPI M.o.M (National, Urban, Rural)



I. National Consumer Price Index (N-CPI)

The **National Consumer Price Index** for **December 2021** is **decreased** by -0.02% over **November 2021** and increased by 12.28% over corresponding month of the last year i.e. **December 2020**.

Decreased: Tomatoes (28.90%), Onions (27.73%), Pulse Moong (24.59%), Potatoes (23.96%), Chicken (14.34%), Eggs (8.19%) and Condiments & Spices (2.63%)

NON-FOOD

Increased: Liquefied Hydrocarbons (72.38%), Electricity Charges (59.38%), Motor Fuel (39.68%), Footwear (26.87%), Cleaning & Laundering (20.37%), Washing Soap/Detergents/Match Box (16.57%), Motor Vehicle Accessories (13.82%) and Construction Input Items (11.35%).

III. Rural Consumer Price Index (RCPI)

The **Rural Consumer Price Index** of **December 2021** is decreased by -0.51% over **November 2021** and increased by 11.61% over corresponding month of the last year i.e. **December 2020**.

Increased: Fruits (7.27%), Pulse Masoor (7.17%), Cooking Oil (5.13%), Mustard Oil (5.01%), Vegetable Ghee (4.80%), Gram Whole (4.74%), Pulse Mash (4.08%), Beans (3.72%), Meat (2.20%), Pulse Moong (1.75%), Besan (1.31%), Pulse Gram (1.30%), Wheat (1.10%) and Milk (1.09%).

Decreased: Tomatoes (46.56%), Vegetables (28.66%), Onions (19.01%), Chicken (18.17%), Potatoes (15.75%), Sugar (13.25%), Gur (3.08%) and Eggs (0.81%).

NON-FOOD

Increased: Electricity Charges (14.21%), Washing Soaps, Detergents & Match Box (4.29%), Textiles (4.00%), Hosiery (3.44%), Furniture & Furnishing (3.21%), Woolen Readymade Garments (2.48%), Stationery (2.29%), Cleaning & Laundering (1.93%), Plastic Products (1.60%) and Woolen Cloth (1.52%).

Decreased: Liquefied Hydrocarbons (4.36%) and Motor Fuels (0.67%).

2. YEAR-ON-YEAR: Top few commodities which varied from corresponding month of previous year i.e. **December 2020** are given below:

FOOD

Increased: Mustard Oil (57.78%), Cooking Oil (57%), Vegetable Ghee (55.47%), Pulse Masoor (26.81%), Gram Whole (26.72%), Fruits (25.83%), Meat (19.72%), Wheat Flour (19.29%), Beans (14.44%), Sugar (13.77%), Besan (12.49%), Gur (11.71%) and Milk (10.07%).

Decreased: Tomatoes (30.59%), Onions (29.78%), Pulse Moong (24.53%), Potatoes (22.72%), Condiments & Spices (21.66%), Chicken (13.43%), Eggs (8.03%) and Vegetables (1.15%)

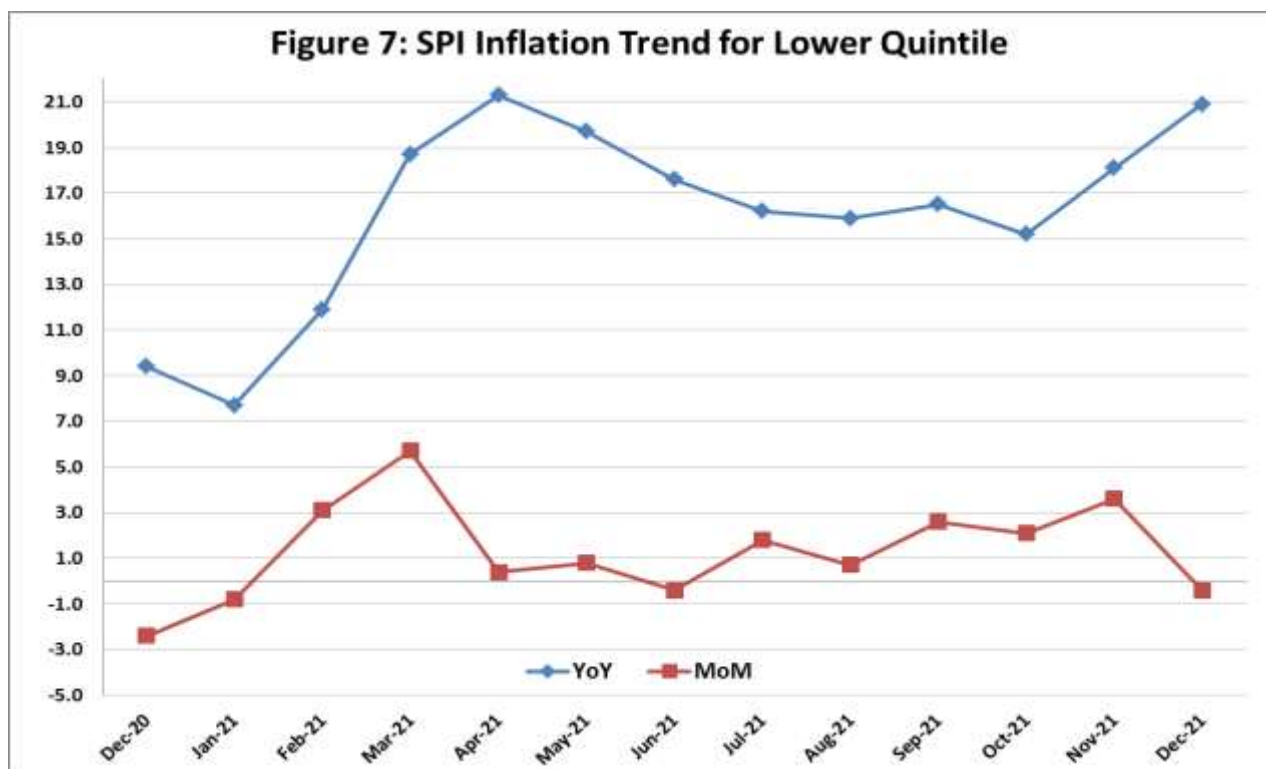

V. Wholesale Price Index

The Wholesale Price Index for December, 2021 decreased by -0.24% over November, 2021. It increased by 26.24% over the corresponding month of the last year i.e. December, 2020. YoY and MoM movements, from December, 2020 to December, 2021 are also graphed below in Figure 8.

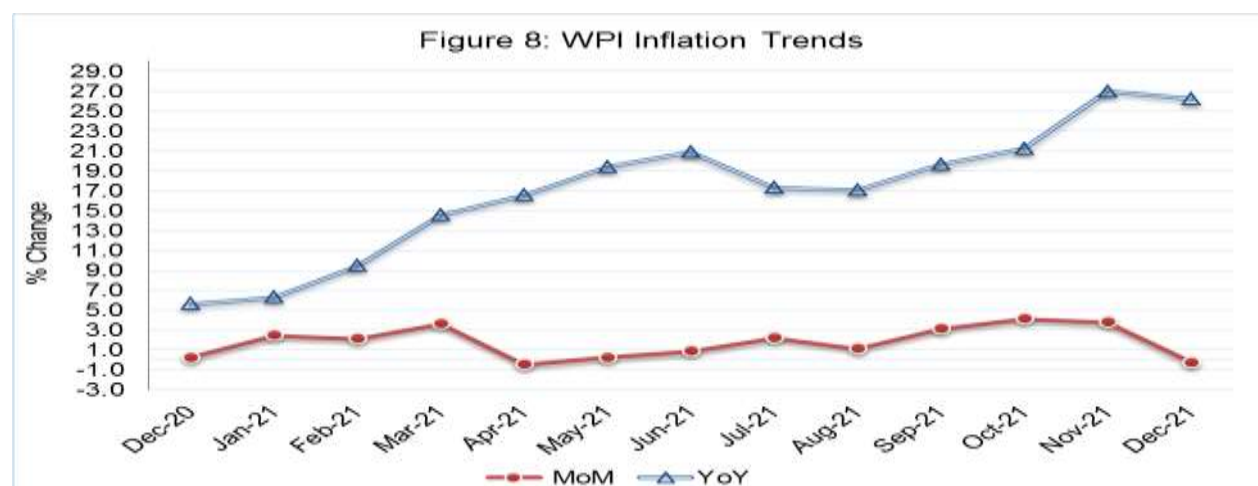
