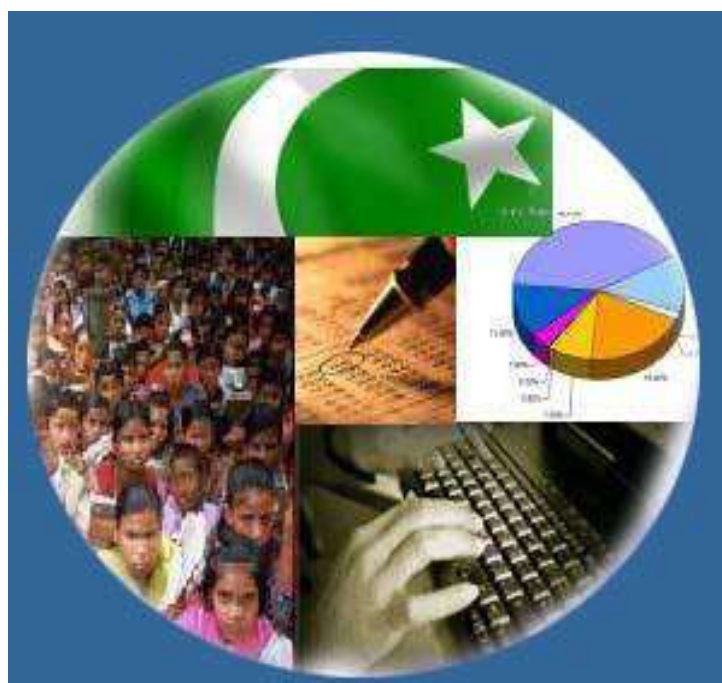

Inflation in Brief

- CPI inflation General**, increased by **8.3%** on year-on-year basis in November 2020 as compared to an increase of 8.9% in the previous month and 12.7% in November 2019. On month-on-month basis, it increased by **0.8%** in November 2020 as compared to an increase of 1.7% in the previous month and an increase of 1.3% in November 2019.
- CPI inflation Urban**, increased by **7.0%** on year-on-year basis in November 2020 as compared to an increase of 7.3% in the previous month and 12.1% in November 2019. On month-on-month basis, it increased by **0.6%** in November 2020 as compared to an increase of 1.3% in the previous month and an increase of 1.0% in November 2019.
- CPI inflation Rural**, increased by **10.5%** on year-on-year basis in November 2020 as compared to an increase of 11.3% in the previous month and 13.6% in November 2019. On month-on-month basis, it increased by **1.1%** in November 2020 as compared to an increase of 2.4% in the previous month and an increase of 1.9% in November 2019.
- SPI inflation** on YoY increased by **9.9%** in November 2020 as compared to an increase of 12.3% a month earlier and an increase of 20.2% in November 2019. On MoM basis, it increased by **1.1%** in November 2020 as compared to an increase of 3.0% a month earlier and an increase of 3.7% in November 2019.
- WPI inflation** on YoY basis increased by **5.0%** in November 2020 as compared to an increase of 5.1% a month earlier and an increase of 11.2% in November 2019. WPI inflation on MoM basis decreased by **0.9%** in November 2020 as compared to an increase of 2.9% a month earlier and a decrease of 0.8% in corresponding month (November 2019) of last year.

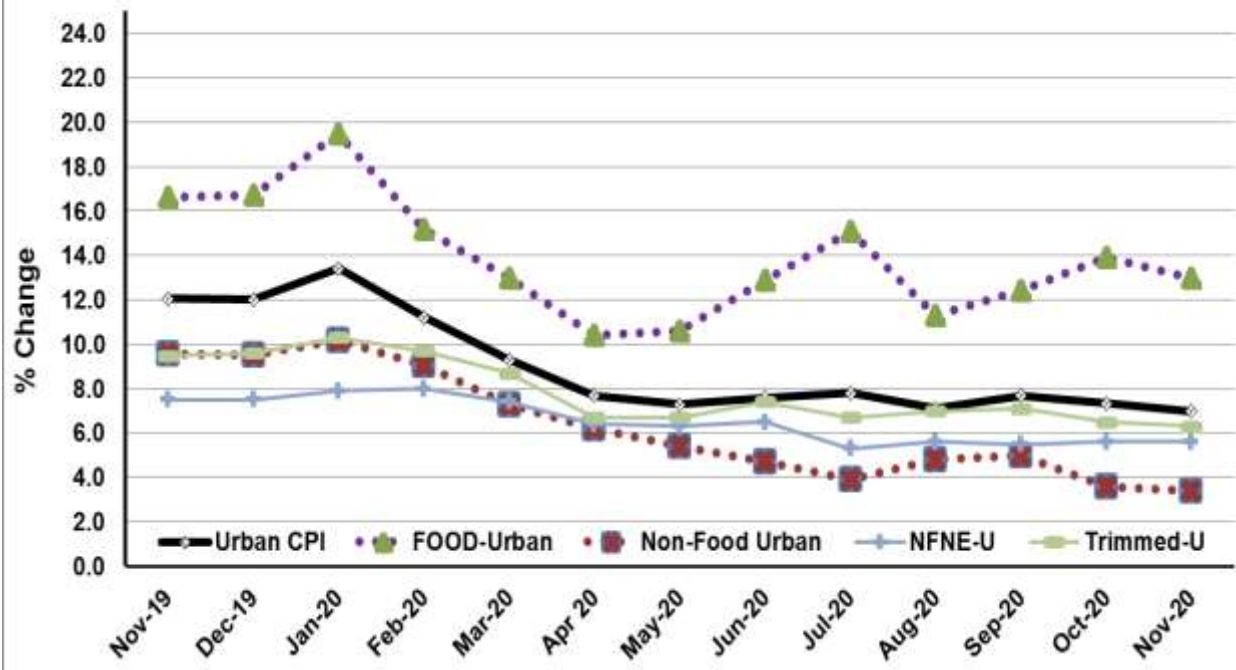


Figure 2: Rural Inflation - YoY, Special Indices

- Figures 1 and 2 show graphically the yearly data of Table 1.a for Urban and Rural CPI while Table 1.1 shows "Period Average" and "YoY" percent changes in indices of three years.

Core inflation (NFNE)

7. Measured by **non-food non-energy Urban CPI** increased by **5.6%** on (YoY) basis in November, 2020 as compared to an increase of 5.6% in the previous month and 7.5% in November, 2019. On (MoM) basis, it increased by **0.3%** in November, 2020 as compared to increase of 0.6% in previous month, and an increase of 0.3% in corresponding month of last year i.e. November, 2019.
8. Measured by **non-food non-energy Rural CPI** increased by **7.4%** on (YoY) basis in November, 2020 as compared to an increase of 7.6% in the previous month and 8.4% in November, 2019. On (MoM) basis, it increased by **0.3%** in November, 2020 as compared to an increase of 0.6% in previous month, and an increase of 0.5% in corresponding month of last year i.e. November, 2019.

Core inflation (Trimmed)

9. Measured by 20% **weighted trimmed mean Urban CPI** increased by **6.3%** on (YoY) basis in November, 2020 as compared to 6.5% in the previous month and by 9.5% in November, 2019. On (MoM) basis, it increased by **0.2%** in November, 2020 as compared to an increase of 0.6% in the previous month and an increase of 0.4% in corresponding month of last year i.e. November, 2019.
10. Measured by 20% **weighted trimmed mean Rural CPI** increased by **9.1%** on (YoY) basis in November, 2020 as compared to 9.5% in the previous month and by 10.7% in November, 2019. On (MoM) basis, it increased by **0.4%** in November, 2020 as compared to an increase of 1.1% in the previous month and an increase of 0.7% in corresponding month of last year i.e. November, 2019.

Figure 1: Urban Inflation - YoY, Special Indices

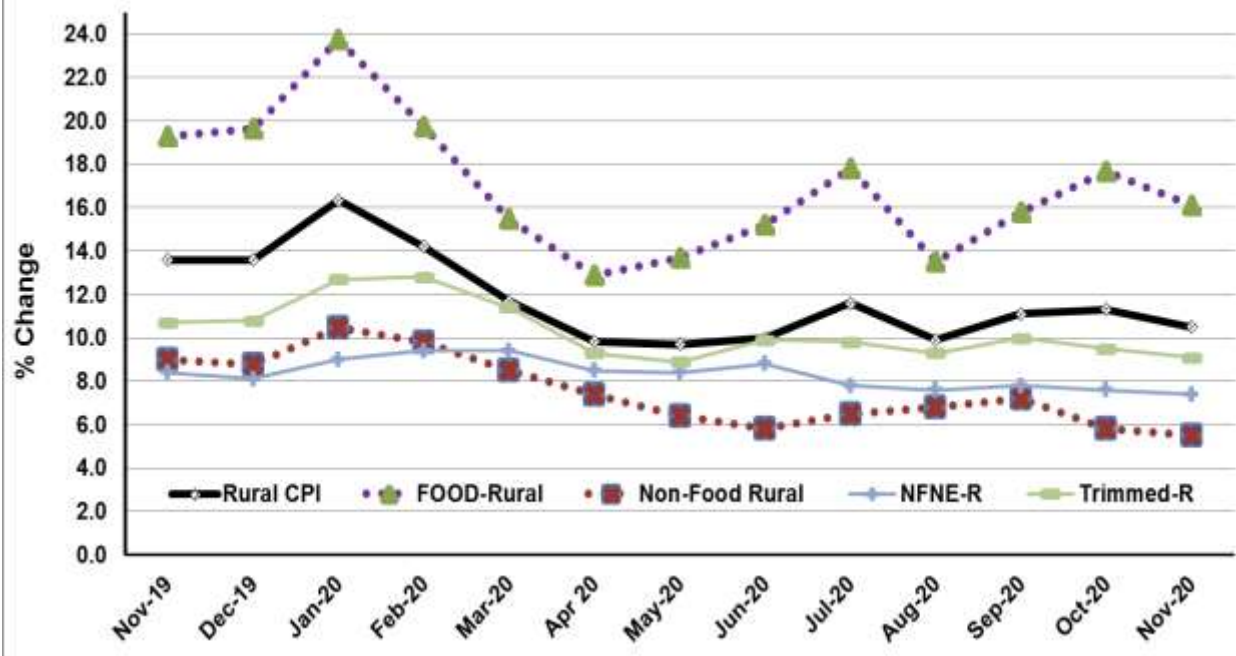


Figure 3: UCPI Inflation MoM, Special Indices

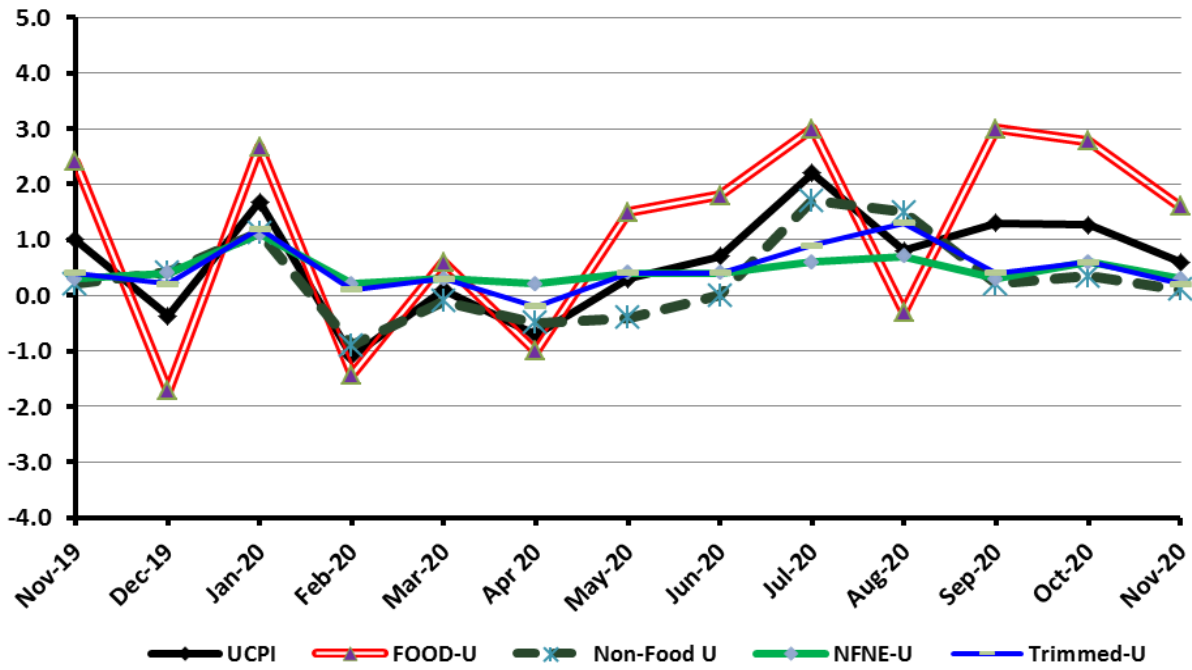


Figure 4: RPI Inflation MoM, Special Indices

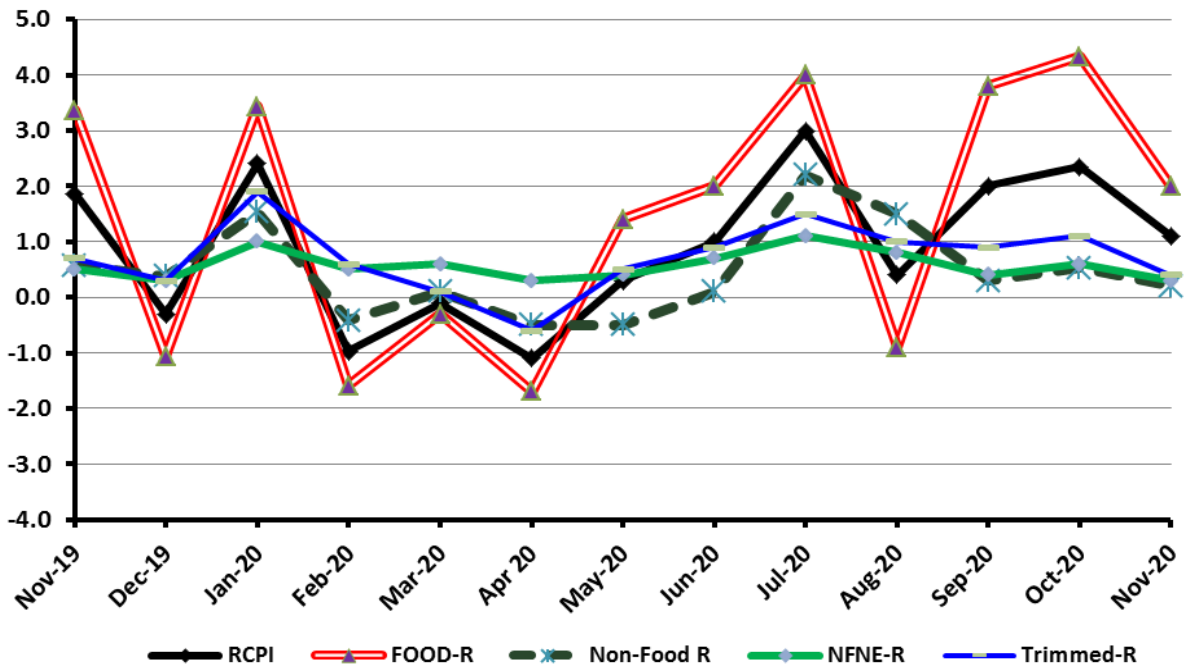


Figure 5: CPI Y.o.Y (National, Urban, Rural)

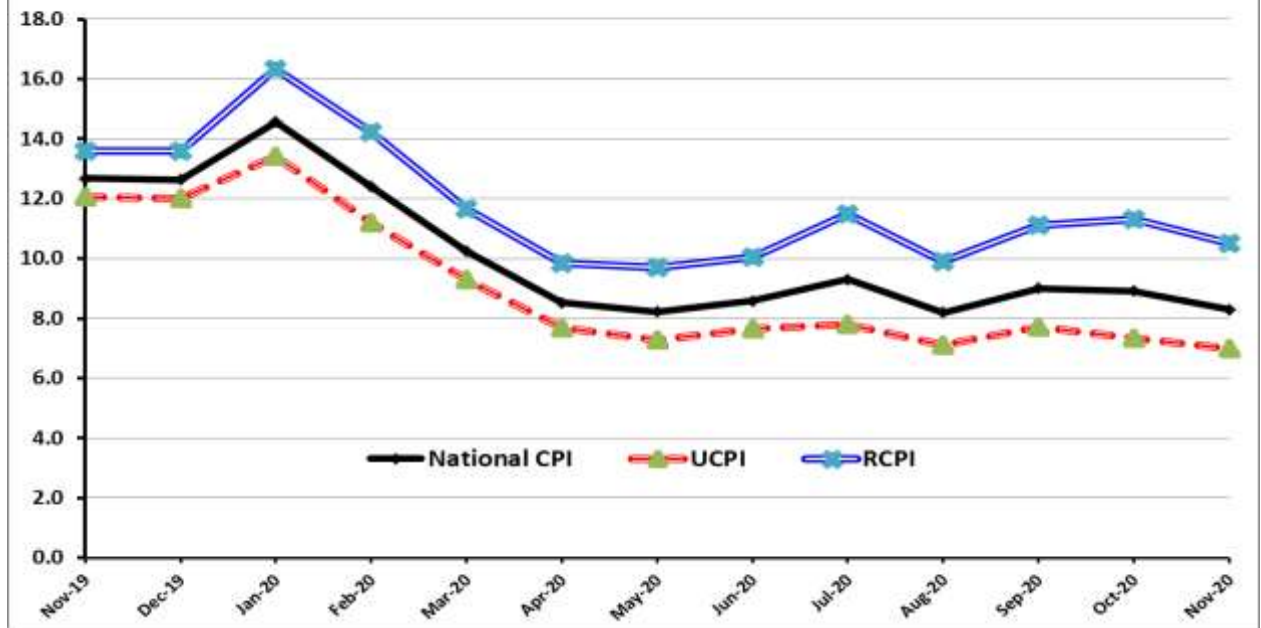
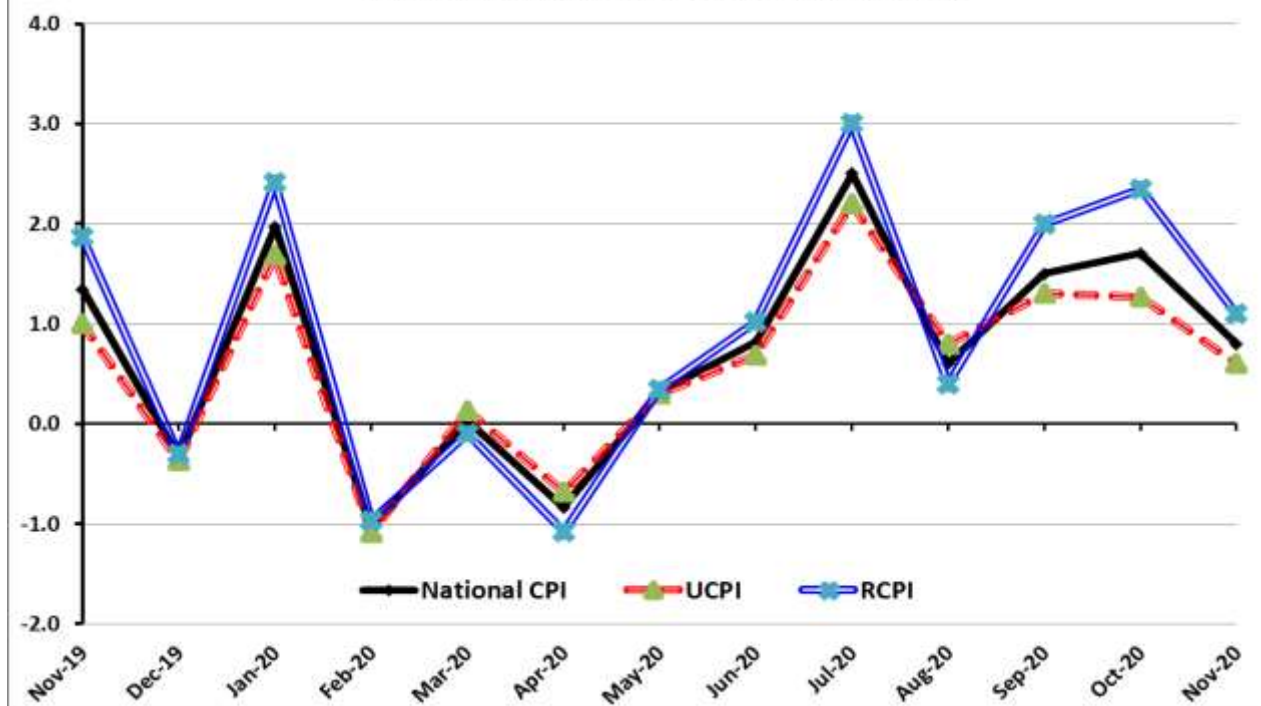


Figure 6: CPI M.o.M (National, Urban, Rural)



I. National Consumer Price Index (N-CPI)

The **National Consumer Price Index** of November 2020 is increased by **0.82%** over October 2020 and increased by **8.35%** over corresponding month of the last year i.e. November 2019.

The **Urban Consumer Price Index** of **November 2020** is increased by **0.64%** over **October 2020** and increased by **6.95%** over corresponding month of the last year i.e. **November 2019**.

1. MONTH-ON-MONTH Top few commodities which varied from previous month are given below: -

FOOD

Increased: Chicken (21.36%), Tomatoes (15.68%), Potatoes (8.79%), Onions(5.81%), vegetables(5.63%), Dry fruits(4.38%), Eggs (2.83%), Butter(2.61%), Condiments and Spices(2.6%) and Fish(1.89%).

Decreased: Wheat flour (4.83%), Wheat (4.1%), Pulse moong (3.54%) and Pulse gram (1.94%).

NON-FOOD

Increased: LPG (10.31%), Readymade garments (8.85%), Cotton cloth (3.75%), Woolen cloth (2.33%), Furniture and furnishing (1.65%) and Marriage Hall Charges (1.14%).

Decrease: Transport services (6.41%), Electricity charges (3.2%) and Motor fuel (1.76%)

2. YEAR-ON-YEAR: Top few commodities which varied from previous year i.e. November, 2019 are given below: -

FOOD

Increased: Potatoes (56.11%), Eggs (48.67%), Chicken (46.82%), Condiments and Spices (37.6%), Wheat (36.6%), Sugar (35.78%), Beans (31.81%), Pulse moong (26.12%), Pulse mash (22.61%), Butter (19.72%), Gur(16.13%), Pulse masoor(15.76%) and Mustard oil(15.12%).

Decreased: Tomatoes (22.58%), Fish (8.34%), Onions (6.6%) and Fruits (3.59%)

NON-FOOD

Increased: Personal Effects (19.46%), Water supply (19.08%), Woolen readymade garments (14.9%), Clinic fee (14.58%), Woolen cloth (12.58%) and Cotton cloth (12.48%).

Decreased: Electricity charges (9.89%), Motor fuel (9.55%) and Liquified Hydrocarbons(2.82%).

III. Rural Consumer Price Index (RCPI)

The **Rural Consumer Price Index** of **November 2020** is increased by **1.09%** over **October 2020** and increased by **10.46%** over corresponding month of the last year i.e. **November 2019**.

1. MONTH-ON-MONTH Top few commodities which varied from previous month are given below: -

FOOD

Increased: Chicken(20.76%), Potatoes(15.8%), Tomatoes(9.29%), Onions(6.56%), Sugar(5.39%), Eggs(5.23%), Condiments and Spices(3.05%) and Butter(1.46%).

Decreased: Gur (5.06%), Besan (2.28%), Pulse Moong (2.26%), Fruits(2.21%), Wheat Flour(1.92%), Pulse Mash(1.82%), Pulse Gram(1.76%), Beans(1.17%) and Fish(1.12%).

NON-FOOD

Increased: Liquified Hydrocarbons(8.74%), Woolen Readymade Garments(3.49%), Clinic Fee(2.35%), Construction Items(1.69%), Woolen Cloth(1.57%) and Textiles(1.00%).

Decreased: Transport Services (3.45%), Electricity Charges (3.2%) and Motor Fuels (2.03%)

YEAR-ON-YEAR: Top few commodities which varied from previous year i.e. November 2019 are given below:-

FOOD

Increased: Potatoes(78.53%), Condiments and Spices(53.75%), Eggs(49.27%), Sugar(42.51%), Chicken(41.01%), Wheat(37.93%), Pulse Masoor(25.75%), Pulse Moong(25.14%), Beans(22.45%), Pulse Mash(21.5%), Wheat Flour(19.59%), Vegetable ghee(17.56%), Bakery items (17.28%), Rice(15.77%) and Cooking oil(15.24%).

Decreased: Tomatoes (23.03%), Onions (8.79%), Fruits (6.03%), Fish(3.66%) and Gram Whole(1.72%)

NON-FOOD

Increased: Personal Effects (22.25%), Hosiry (18.89%), Cleaning and Laundering(17.06%), Clinic Fee(16.88%), Plastic Products(13.68%) and Furniture and Furnishing(12.73%).

Decreased: Motor Fuels (9.92%), Electricity Charges (9.89%) and Liquified Hydrocarbons (3.38%).

IV. Sensitive Price Indicator

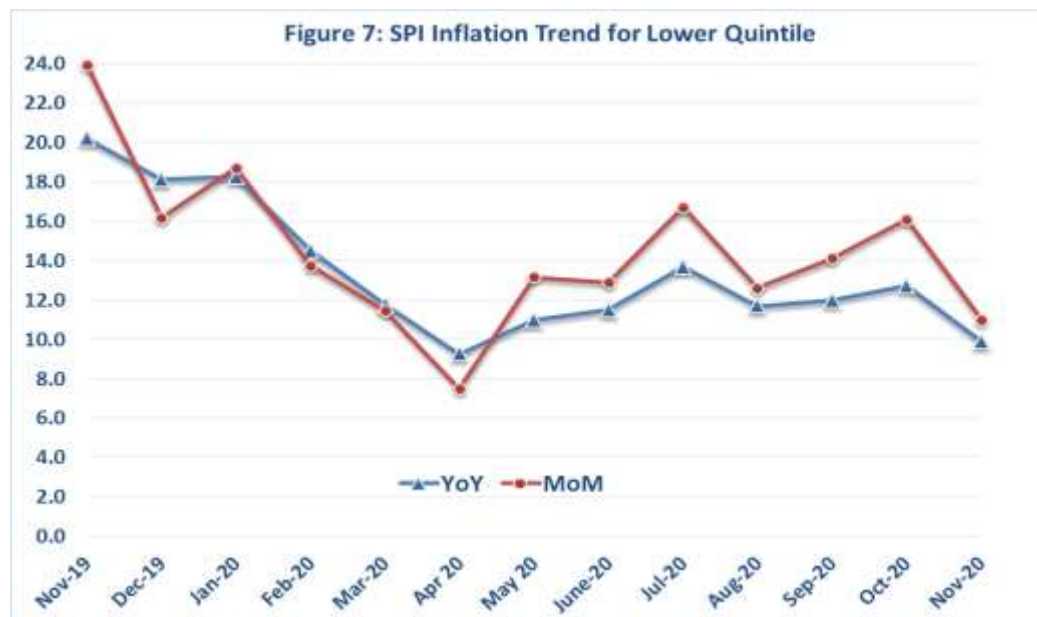
Quintile-wise percentage changes YoY and MoM are given below in Table 4. The series from **November 2019** to **November 2020** is also graphed below in Figure 7.

The Wholesale Price Index for November, 2020 decreased by **0.94%** over October 2020. It increased by **5.00%** over the corresponding month of the last year. YoY and MoM movements, from November, 2019 to November, 2020 are also graphed below in Figure 8.

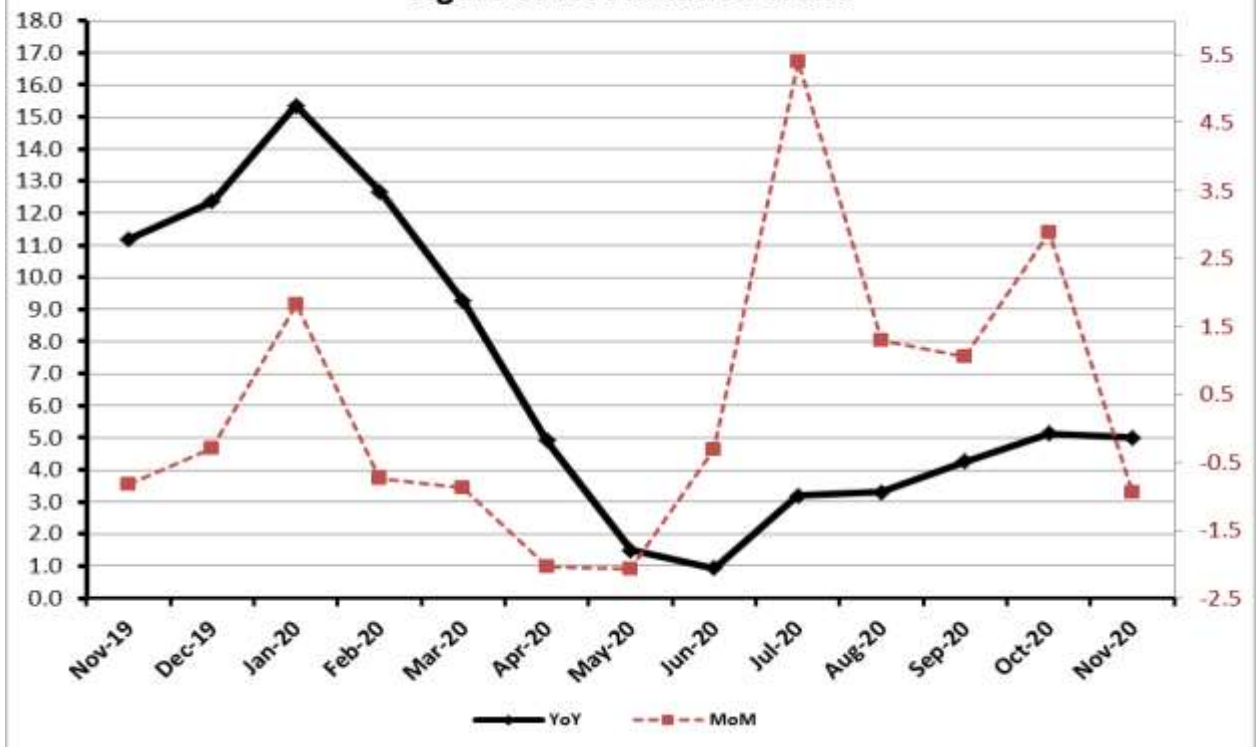
